Cross Reference other sheet in Profile of William Kendrick U, Sr. Also Lois Taylor or possibly Lois McGraw. File letter for present under Profile of Lois Taylor. Ltrs dated 6 FEB 1964, 9 JAN 1964, 14 NOV 1964, 20 NOV 1964 + an earlier one not yet found.

Lois had a heritage linked to the Abel U, Sr / Benjamin U Subdan but may not have been an Upchurch descendant. She is definitely linked to members of the McGRAW family who definitely married into the Abel U, Sr / Benjamin U Subdan.

As of 9 AUG 2002 RPL shows the above mentioned Benjamin U had sons:

- Churchwell U XID-10443 - md 10 MAR 1861
(Lauderdale Co, MS) Elizabeth M. McGraw
XID-26043
- William U XID-10437 md 1864 (MS)
Mary McGraw XID-1835

HOWEVER: Lois Taylor refers to her Great Aunt Mary Elizabeth McGraw and says she md 10 MAR 1861 (Meridian, Lauderdale Co, MS) her "Uncle" [could be her Great Uncle by marriage? - RPL] William Churchwell U - This poses the question are XID-10443 & XID-10437 one & the same and are XID-26043 & XID-1835 one and the same. William UPCHURCH(11)

William UPCHURCH(11) has been a big mystery as he has been very elusive. Until he showed up in 1880 Clarke County, Mississippi, in the household next to his brother, Benjamin Newton UPCHURCH(15), it was not known that he was the son born to Benjamin(7) in the time span of 1830 to 1835. By 1850 William had left his father's household, and was not found again in any Mississippi records until the 1880 census. William UPCHURCH(11) was born about 1830 in Alabama. Around 1864 he married Mary McGRAW, the daughter of Betsie ?. Mary was born about 1835 in Alabama. Mary was probably a sister to Elizabeth M. and Hannah J.

McGRAW who also married brothers of William. William had four known children: John Benjamin UPCHURCH(18); George E. UPCHURCH(19); Richard UPCHURCH(20); and Sonny UPCHURCH(21). Richard UPCHURCH(20) and Sonny UPCHURCH(21) were born in Mississippi about 1875 and 1878, respectively.⁸⁵ Nothing else has been found on either of these children.
