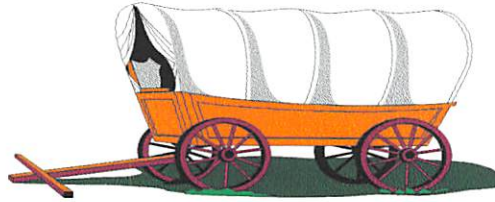

Amidst an oak grove the home of Mr. and Mrs. M.R. Upchurch of Apex Route 1 was the scene of enjoyment as friends and relatives gathered to help celebrate their golden wedding on Tuesday March 8th.

Mr. and Mrs. Upchurch were married in the same community in which they reside having reared six children, the oldest daughter dying in infancy, Cecile, their eldest son was assistant Paymaster of the Navy before his death several years ago. Mrs C.R. Mills resides in Carthage, Rev.H.C. Upchurch in Raleigh; Mrs. H.O. Kelly on Morrisville Route 1; Mrs. R. G. Beckwith Apex Route 3; Mrs. George W. Farrar Apex.

Mr. Upchurch was the second son of the late I.S. and Delia Beavers Upchurch. Mrs. Upchurch being the daughter of the late Jonathan and Jane Welch Bolling of High Point, Mrs. Upchurch came to Chatham county in young woman-hood as private school teacher, before her marriage. 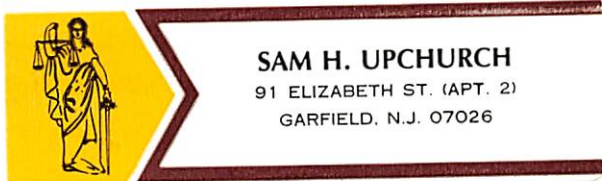

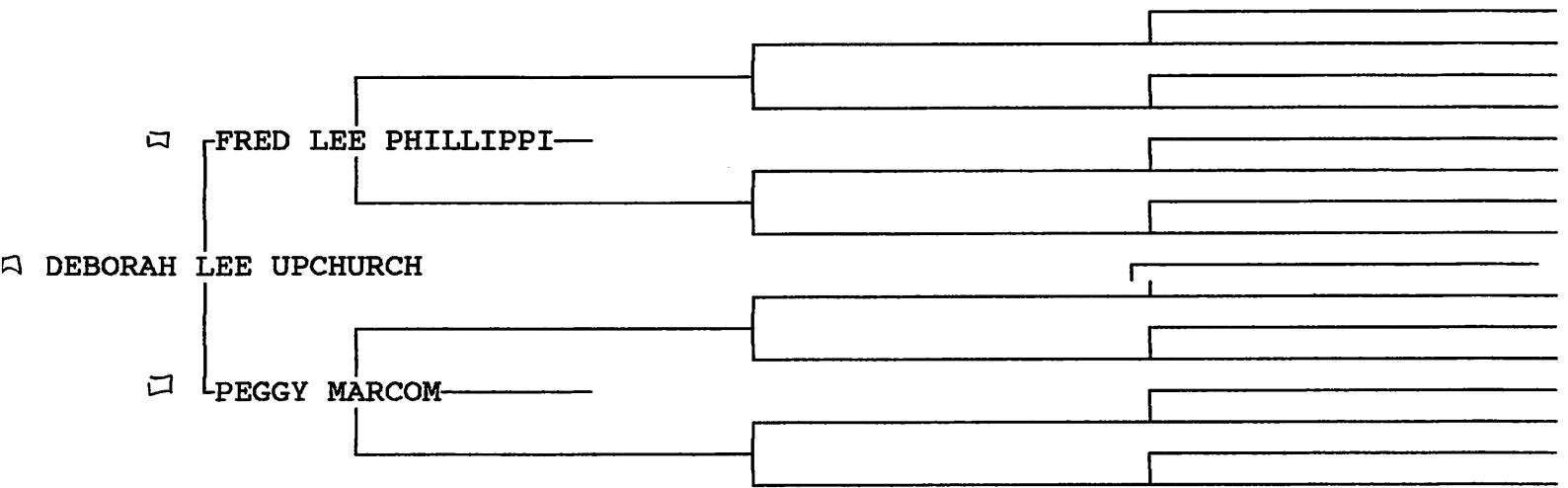

Thank you for your letter of 30 JUN 2003 and for the \$120.00 which we have cashed. Enclosed are sheets on the Upchurch publications showing costs, etc. Let's review where we stand on the \$120.00

the 120.  
You will note from the order form that for the years 1980 - 1999 we bound the 4 issues per each year into a bound volume. Starting in 2000 we have produced only two issues per year of the U.B. Therefore, I elected to bind two years together. So we have the 2000 & 2001 issue (2/yr x 2 = 4 issues) in a single bound document for \$30.<sup>00</sup>. This bound document for 2000 & 2001 was mailed to you on 10 JUL 2003 leaving \$90 out of your 120. We have put you on the list to get a bound document for 2002 & 2003 sometime

this fall for  $\$30.00$  leaving  $\$60.$  out of your  $\$120.$

Next, according to your instructions we allowed  $\$30.00$  to Upchurch leaving  $\$30.00$  out of your  $\$120.$

So you now have a cash balance of  $\$30$  with us. Please let me know if you wish us to send you a check for this amount.

Re Englandia you can see from the form there were 2 issues/year for 4 years or 8 issues altogether. They sell for  $\$5$ /issue or  $\$40$  for the set. A lot of English Upchurch stuff is to be found in the UB issues 1995 & earlier and 2000 and later.

Part of my reason for reducing the number of items produced starting in 2000 was so I could publish an Upchurch Book. As you know there are all sorts of things that get in your way. In 2000 we sold our home, had a new one built and moved. There goes a year down the drain. In 2001 we had a devastating flood ( $\$75,000$  damage) caused by a broken washer hose while we

were out of town. Another year down the drain. Then in 2002 (6 OCT) I fell and broke my leg followed by 4-6 months of recovery. This along with serving a year as church President JUN 02 - JUN 03 took another year down the drain. Still with all of this, like job in the bible, we have maintained a positive attitude - and have kept up with our children & grandchildren (8), with family history and with our farm - even bought two more #13 & #15.

Now - I hope you and I can get back to visiting our Brown & Upchurch books. I'll look forward to hearing one of yours.

In December 200 on a visit to NC we attended church at Inwood Baptist Church and met your brother & his wife - did not get to see your mother - next time!

We are anxious to make another trip back to NC and with luck will do it this fall. I am trying to narrow my Upchurch research so as to concentrate
