Woman nabbed trying to fake prescriptions

Zebulon police arrested a Knightdale woman for trying to swindle painkillers from two doctors and a Zebulon drugstore last week.

The pharmacist at Zebulon Drug Co. called police July 21 to report Julie Upchurch of Terry Lane, Knightdale, for falsifying

information to get a prescription of perkaset, a painkiller police said is classified as a controlled substance.

The pharmacist told police he called Dr. Phillip Burton in Zebulon, the doctor who apparently wrote the prescription, and was told Upchurch used the name

Julie Miller to see the doctor and get the medicine. She reportedly left Burton's office without paying. Police said Upchurch also tried to see Dr. P.K. George of Zebulon by lying about being covered by Medicaid insurance.

When she went to the drugstore to get the prescription filled, the pharmacist said Upchurch gave him the same fake name she had given the doctors, along with the address 2001 Newbolt St., Zebulon. Figuring something wasn't right, the pharmacist called Burton, then the police.

Upchurch, who was at the drugstore when police arrived, admitted to lying. She was arrested and charged with obtaining a controlled substance by fraud.
