Thank you for contacting me. I can actually add a little information about Woodrow Jefferson U. Jr. (14798) (b. 7/20/1934). Currently you show two children (14799 and 14800). There are actually two more. My father, Jeffrey Allan Upchurch (b.12/29/1957) was the oldest, followed by Brian (14799), then Lori Upchurch (b.1/21/196?) and the Michael.

Jeff (my dad) married Pamela Rene Rice (b.5/26/1958 of Garner NC) and has two kids, me (Justin Davis Upchurch b. 12/29/1982 sharing his b-day) and Matthew Edward Upchurch (12/16/1984). I am married to Vanna Kay Roberts (3/29/1984 of Poquoson Va) and have a son Thomas Allan Upchurch (7/9/2012).

Lori is married to Stephen Kearney of Goldsboro and have two Kids, Rachael Delaney and Cade.

Brian is no longer married to Kimberly Beth, but does have two kids, Hayden and Ashley U. with her. His current wife's name is Connie (can't recall last name).

Michael Avery U. is also married, to Carol (can't recall last name).

Woodrow Upchurch Sr (14797) (d. 1971) was married to Agnes Avery (b. 1/30/1913 d.8/1/2005). Both are buried in Buies Creek in a cemetery with a bunch of other Upchurches descending from Jefferson Davis Upchurch (14785).

For Jeff Davis's dad, Benjamin (14648) I have dates of b. 10/29/1830 and d. 4/19/1910 from my grandfather Woodrow Jr (14798). Ben's wife Catherine (14650) was born 8/30/1842. Information is again from Woodrow Jr.

Lastly, in the Vol 20, #1 Jan 1999, of the UB (pdf pg 1665) there is a statement about Woodrow Sr. playing baseball for for the Philadelphia Athletics. To add to this, he played in 1935 and 1936. After the 1936 season he was working at Ft. Bragg doing construction. On the way back from work one night the car carrying him and several other workers flipped, almost killing him. This accident sliced open his left arm, which never really recovered. This is why he only played 2 seasons. He has a Wikipedia page (http://en.wikipedia.org/wiki/Woody_Upchurch), for what that's worth.

My grandfather Woodrow Jr. was married to Eleanor Ruth Tidwell, but they divorced. Jeff, Brian, Lori and Michael are their kids.

Hopefully this adds a little more.

By putting your very helpful information and mine together I have upgraded the Master Outline for the family of your GGF, JWU, Sr. If you will send me your mailing address I will mail you a copy of the Outline and go back an earlier generation which will give you quite a bit of information I have collected over many years. I am hopeful you will have information you can supply me to make more improvements in the outline.

You are of the Jubal U. I/Stephen U Subclan and of the Benjamin U Line in that Subclan. Benjamin was the GF of JWU, Sr. Jubal was the brother of my ancestor Nathan U, I and they were sons of Richard U, II on whom I have produced a video. He is your and my common ancestor. Videos on James U, I and Richard U, I and Michael U, I complete our direct line in America.

Your GF Woody and I were peers at NCSU up to my departure in 1965 but did not get well acquainted at that time. Later we corresponded about family history. In my files there is a 1975 letter he wrote to Belle West and about family history and which she gave to me. I have notes of phone calls from Woody and from Eleanor.

I will be pleased to have some additional incremental inputs on family history from you and I would very much like to know of any special interests you have.
