However, on August 15 my entire medical team decided to cancel the operation and to proceed first with chemotherapy. My first treatment will be August 25, 2016. I will have three treatments on successive Thursdays followed by a week of no treatment. The process will then be repeated as needed. We are pleased with this new plan as I am reasonably well assured of an average of three good days per week for the next several months. This will allow time to put some more of Allied Families into place and to make contingency plans to assure the long-term success of Allied Families Association. There is some chance I may be spared for five years. This will require luck and your prayers.

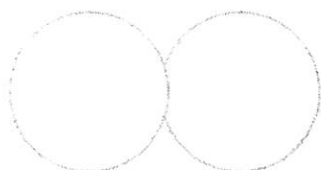

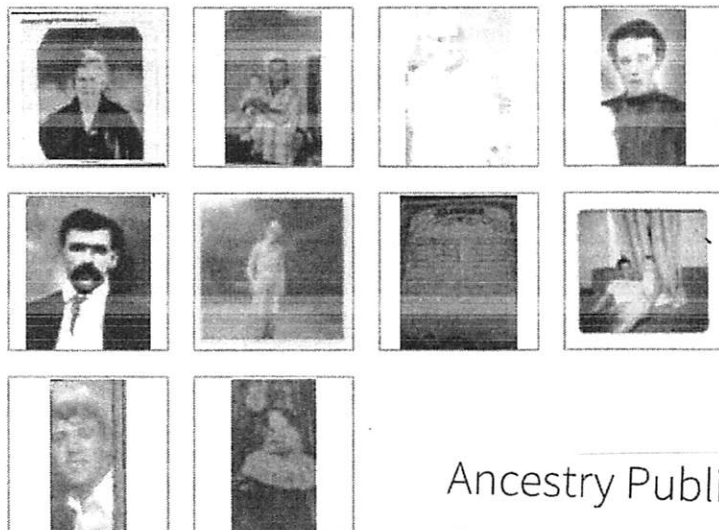

To give you just little more of the story of Upchurches there I will mention that Charles U., a brother of your Abel U., Sr, moved to GA about 1820 first to Putnam County and then on to Henry. His children all came to GA as well but not all at the same time or to the same places. In the same time frame his nephew Claburn U., I ( son of Richard U., III another brother of your Abel) moved to GA and ended up with a large presence in Henry County. When I gave an Upchurch talk in Atlanta in 1989 I made a side trip to Henry County and visited Turner Methodist Church one of several burial sites for upchurches in the County. Over time I have had several interesting contacts with Upchurch descendants in Henry County but they are now stale. If you are so inclined I would welcome help in getting back in touch with some of them if they are still alive or for that matter establishing new contacts. Email contacts are best but the old fashion way works also.

In Gwinnett County you were also close to early GA Upchurches. Brittain U., I, another son of Richard U., III, was there well before the Civil war.

I hope you will go over the Upchurch Bulletin issues and pick out parts to read that are of interest to you and let me know if there a special ways we can interact. I would like to know if you find the issues of the UB easily searchable and to know what you think of the videos.

With the Upchurch Bulletin now on line your should be able to find a lot that I have written about your part of the family and make our interaction more efficient and productive. Let me know if you have any trouble navigating the sites.

Let me give you a couple of pointers. Early in the game I bought into what some early researchers had said about your ancestor Abel U., Sr. They mistakenly concluded that he was a the son of William U., IV who was head of a clan.
