#### Hi Cousin Jack---

It looks like you and Sherwood and I can make a great team and move right along to enroll the Richard U.III family and to build a case showing others how it is to be done. In the past I have accepted donations to further my work on Upchurch issues and on the Upchurch Bulletin and to support the Upchurch Collection at N.C. Sate University. Both are worthy causes and I do hope we can increase the Upchurch Collection Endowment at N.C. State beyond its present value of about \$50,000. However, my passion for now is to develop some momentum for the Allied Families Association. I am waiting to make a big push until we her our tax exempt status from IRS. They have promised me some action next month. In the meantime my CPA is letting me deduct the \$500 contribution I made in December anticipating that our approval will be retroactive to our application date. Still, I would like to assure prospective donors that we are officially tax exempt.

So, I would first invite you to become an individual member of UAFA for 2014 at \$20. We have about 60 members now and I hope for 100 by June 30. Next I would hope you and Nancy and perhaps others would help us get to the \$500 enrollment fee for the Richard U. III Family. 

Hi Jack-

You (and 29 others) have been a strong financial supporter of Allied Families since its 2013 inception. I want to tell you a little of our progress and to appeal to you for a special extra mid-year tax-deductible contribution if you are so inclined.

Tom emphasizes having a Board DropBox where board members have easy access to key documents. I am trying to play a strong role behind the scenes to help insure the long-term success of UAFA. My mind is strong and helpers offset my physical limitations. I may set the record for surviving pancreatic cancer.

As our Association continues to evolve it is anticipated we will offer board members the option of monitoring segments of our operations spending one or two hours per month and reporting to the Executive Committee twice yearly on status. However, we would count on you to keep an eye on what we are doing to document and elevate the records for the Richard Upchurch III family.

Our Allied Families Organization is at a crucial stage in that we are now digitalizing, and placing online, records of our Upchurch Heritage that have been collected since 1950. I am very pleased at the progress being made, but we must keep up the momentum. The goal is to have our on-line platform become a permanent family history presence for others to emulate.

As an aside, I will report that we are moving to hire Sarah Watson, a Wake County NC native, to be our first part-time employee in our Cary Facility. Incidentally, she is a descendant of Kearney Upchurch.

The primary duties of board members are to deal with policy issues. This will be done primarily by conference calls and via email. We have had a couple of conference calls in the last year. Tom is very good at this as he is a key operative in a commercial venture. There are no requirements for meetings in Raleigh. We did have one there and it was nice to provide an opportunity for the board members to get to know each other--maybe another one sometime. Basically, I would say the duties of the board members are very light but we are open to the prospect of individual ones taking on useful activities where they have special interests and where they are so inclined.

Right now we have two very strong committees that help keep things moving along. There are five board members on the executive committee headed by Tom and they are kept in the loop and handle most matters. There is a three member financial committee headed by Deb Heck. Not to be overlooked is the fact that we have a very productive Manager in Jay Buck serving in Chesterfield and a very productive Volunteer Coordinator in Carla Michaels in Cary with other workers in both places and with 50 more volunteers located remotely. Tom emphasizes having a Board DropBox where board members have easy access to key documents. I am trying to play a strong role behind the scenes to help insure the long-term success of UAFA. My mind is strong and helpers offset my physical limitations. I may set the record for surviving pancreatic cancer.

As our Association continues to evolve it is anticipated we will offer board members the option of monitoring segments of our operations spending one or two hours per month and reporting to the Executive Committee twice yearly on status. Additionally, I have started writing to each board member asking if they have some special interest they would like to pursue with the help of me or some other Headquarters member. I offer suggestions but invite ideas to pursue.

I have always resisted allowing financial issues to cloud family history collaboration. Our records are open to members and members alike. We have collaborators who cannot afford the price of membership and I have always welcomed and classed them as corresponding members. On the other hand money has to come from somewhere. I leave it to each individual to contribute based on their ability, their interest, and their conviction about the importance of our work. In my case my wife and I started our poor and along with luck and hard work have been blessed beyond measure. It caused me no pain to establish a \$200,000 endowment for UAFA.

Our Upchurch family helped to build America starting from the earliest days. But the story will not be told unless we do it. If you decide to join our board you will be part of the old guard, along with me, helping to usher in a new cadre of leaders. Your presence will help us provide a stronger focus on the enrolled family of Richard Upchurch, III to which you belong.

You asked about the duration of board appointments. So far we classify our board as the "Founding Board" anticipating that it will help us give shape, form, purpose and procedures for the work of our Association. The board can decide at what point it needs to instigate term limits. In the meantime our Association has made great strides.

I hope these observations will be useful and you will allow your name to be placed in nomination. I am deeply grateful that you take note of my role in many years of effort to lift up our Upchurch heritage. It has been an honor and a joy to gather so much detail which we now hold in trust for the thousands who also helped including your close relatives.

Hi Stalev---

I note that President Tom has welcomed you and two others as added members of our Allied Families Board. I hasten to extend my congratulations as well. The role of our Association is to lift up the heritage of our selected enrolled families which tells the story of America. Our Collection was started on paper in the 1950's. The creation of our Association in 2013 set the stage for digitizing our records and getting them online (a big job) and for perfecting our Platform for managing enrolled families.

Tom has promised to send you more details about UAFA, but I want to emphasize a few key points as follows:

1. We have a great Headquarters Team to execute Board Policies, to test new procedures, and to carry out daily operations. You will enjoy working with Tom as President, Jay as Manager/Webmaster, Carla as the Cary Facility Coordinator and with me as Founder.

2. Our 2018/2019 challenges are to move from creation of Legacy Trees (ancestry trees in <u>Ancestry.com</u> based on information from my Master Outlines) to Living Trees (Copies of Legacy Trees that will be continually updated with new people and information) and to get our

complete 80 file-drawers full of my field notes (Biofile System) scanned and on-line. These are huge but doable tasks. Later we must add information from the Biofiles into appropriate family trees, an extremely huge task, but this will vastly improve the value of the family trees for family and general historical research.

3. We are making great progress in focusing on Enrolled Families and are beginning to assemble Teams of volunteers to perfect and sustain each one--a key to long-term success. We have about 50 volunteers working remotely from home and should have a hundred.

4. Protocols for activities are being developed. This is essential to supplement visions, retain focus and prevent loss of institutional memory as individuals fade. Become informed and help us with this process as you are so inclined.

5. At some point, likely within three years, our Chesterfield operations must be transferred to Cary. Please follow our steps to enhance our Cary capacity as a must do activity.

6. Regarding finances, we have steps and options to accommodate near-term needs and with the help of our members will get the job done. The endowments for each of our Enrolled Families helps get members involved and collectively could, in a few years, reach \$100,000. These are near-term needs on which I have a focus. President Tom has a focus on our longer-term aspirations and financial stability. He hopes to find support to create a million-dollar endowment which will allow our Association to provide a \$50,000 per year salary for a manager to help replace the role I have played.

7. While Board Members are primarily responsible for policy, it is clear that each of us will also have special interests in our program of work. I look forward to staying in touch with you about any special interests you may have and moving to implementation as appropriate.

McAlister Surname DNA Project The Clan McAlister of America (CMA) was <u>founded</u> in 1990 with the mission of <u>searching for</u>, <u>recording</u> and <u>sharing McAlis</u> and genealogy, initially in north America and now all over the world. Family trees are entered into a <u>database</u> that has grown to include more than 100,000 McAlisters and descendants. It is organic more than 329 <u>family lines</u>. We use this to help link families together. For instance, sometimes <u>members</u> are able to give us only the grandfather's name, but that is sometimes enough to link them back to a Scottish immigrant, or to find unknown relations that may nearby. <u>Please share your data</u> with us. Any information you can add will be gratefully appreciated and may help link others. Be su include copies of any newspaper clippings, obituaries, birth announcements, photos and any personal histories that you know.

# **Ancestral Code Numbering System**

To organize our McAlister genealogy, we assign a unique code for each family line. We begin with the oldest known ancestor and use the initials of his given name(s). For example, John McAllister is a "J" line, and William Crawford McAllister is a "WC" li digit number is then added to the letter code to distinguish between the many progenitors with the same initials. So J26 is the 26th t to be submitted to the CMA database with a "J" progenitor. John's firstborn (in the example above) would be designated (J26-1) and child's firstborn would be (J26-1-1), the second born would be (J26-1-2) and so on. The family code is used as the prefix for all des of the line, using an approach we adopted from the "modified register" system used by many genealogists. CMA Database Fact she
