Hi Ed---

I am delighted to have your expression of interest. You and I have a mutual interest so it is a matter of what we can make of it. As we proceed I hopë lady luck will be with us to amplify our inputs of time, money, uncovering of data, analysis of data, sharing with others and bringing others into the fold to share the results and to help pick up one end of the log. I'll now offer a few comments and invite your response.

First, the mysterious aspect. Item 18 in my Biofile for Henderson U. authenticates his birth in Chatham County, N.C. and that his parents were Rufus U and nee Mary Barbee. Now comes my expertise. Prior family historians of the Wake County/ Chatham County, N. C. border have generously shared their knowledge with me and I have added much to this knowledge base. Our first approximation is that there was no Rufus U. and Mary Barbee known to have existed in the area and at the necessary time to have produced Henderson. Having said that we have tried to force fit the authentication into what is known. The closest fit is to assume that the name of the father was not Rufus but rather Ruffin who would have been of the right age and at the right place and who is said to have had 22 children not all of whom have been identified. The Barbee family was numerous in the area and could have supplied the mother. But what we do know of the wives of Ruffin does not reinforce the prospects of a son Henderson unless he was born out of wedlock to Ruffin and Mary, a prospect not to be discounted from what we know of Ruffin otherwise; but please do not take that as a pejorative comment. We are left to keep gathering and evaluating information to bear more on this matter.

Assuming Henderson was born when and where we think there are three Upchurch Clans who were represented in the area to be considered. One was the Moses U. Clan and he was the father of Ruffin. Other sons of Moss could be considered as a prospective father of Henderson but what we know does not make this likely. A second Clan was that of Nathan, U., I my GGGF and a brother of Moses. We could have another look at the sons of Nathan but the prospects are not good. The third Clan is that headed by John U., III. His three sons could have been candidates but none were named Rufus. We have a huge body of facts about these three Clans but as we proceed to enroll them as families under the banner of Allied Families we will be going over the data with a careful eye which could help open up possibilities for a father of Henderson but more likely would rule out some prospects thus narrowing the field. So, you see we have a major challenge to complete the ancestry of Henderson and it would be helpful to know the extent you would like to be an active participant in this sub-project. The solution to the puzzle would be a substantial advance for all descendants of Henderson and a big plus for Upchurch history.

Now let me comment on the 18 generation chart you supplied, for which thanks. If we assume that Henderson is a son of Ruffin, your chart is good from 18 back up to Michael #6 for which some modification is in order. We now more accurately place his birth at 1624 and have a lot of reason to say he was not born at Little Gidding but where we do not know but it was more likely at the village of Brington about five miles away from Little Gidding. These are in a way minor points. You can reliably claim no 5 named Richard to have been the father of Michael but the dates an places are suspect and we must go back to Professor Ransome's data to get more reliable information. Generations 1-4 should be deleted. They come from unwarranted projections by workers in the 1945-1970 era. More detailed work by our consultant Ransome since 1990 reveals that we have no basis whatsoever for assigning the name of the Grandfather of Michael. We (my collaborators and I) have paid Professor Ransome about \$40,000 for his help over the years and have gotten about \$200,000 in services. Our Yeoman Upchurch family in England has been subjected to the most rigorous treatment one could imagine . See reports in the UB and Englandia at <a href="https://www.upchurchstory.com">www.upchurchstory.com</a>.

You and I seem to have assembled records on the descendants of Henderson using our own

methods. I suggest as a sub project that we make it our business over the months ahead to share records hoping to improve information at both ends and then to go on and add to the records. We have powerful tools on the Internet for doing this.

I have already mentioned more work than will get done by just wishing. I suggest we consider how the Allied Families effort can help us. One way would be for us to proceed in the direction of "enrolling " the Henderson U. family much as you see we have done with several families already. Ordinarily we like to start with an ancestor who lived about the time of the Revolution but we can set that aside in the case of Henderson. Our hope would be that w could get other descendants of Henderson to join with us in this effort with time, information and money. If you value this approach it would be help if you could foresee a certain amount of money being brought to bear. That said, I do not presume to speak for your pocket book.

As a tangible step I propose to mail you a copy of my 25-page-28 Item Biofile for Henderson U. Many of the entries represent raw data to be digested and I have done some of this but more is needed. A fresh set of eyes and intellect would be helpful.

I hope we in Allied Families can benefit from your computer expertise and we can address that in due course.

Sorry I am so wordy but your interest led me to probe where it can take us. I'll await you thoughts knowing that you have many other things to claim your time .

4. Did they have just two grandchildren---you and your sister (whose name I do not have)? Any of this you can supply will be appreciated.

I would like to ask your advice on an issue we have for our Allied Families venture. We are using the Weebly process for creating and managing our website <a href="www.alliedfamilies.com">www.alliedfamilies.com</a>. An issue is the adequacy of this platform for our Resource File. We have posted a few items on the file and will post some more just to illustrate the types of things to be included. Weebly indicates that we have unlimited file space That remains to be seen. (Is it really true? Will a high volume of file content slow us down in one way or another?). A big problem seems to be that under the Weebly process we can only search the headings of posted material. RE: An Internet Challenge for Allied Families---

Research to document Upchurch and related families was started in the 1950's by a number of collaborators. This work has progressed in print from books to the Upchurch Bulletin now in its 36th year of publication. Our website <a href="https://www.upchurchstory.com">www.upchurchstory.com</a> established in 2007 continues. An upgraded version was launched in 2013 as <a href="https://www.alliedfamilies.com">www.alliedfamilies.com</a>. All major problems for this improved site have been resolved except one. We now appeal to those knowledgeable about computers and the Internet to advise us.

THE PROBLEM--We anticipate having a very large collection of images and documents (our Resource File). It is our preference to maintain this as one ever expanding search-able file which members of the public can view and download without charge. They would gain access by visiting our website and requesting a password which would be furnished upon the visitor revealing their name and email address.

#### ROADBLOCKS TO SOLVING THE PROBLEM

No. 1. The Weebly protocol for our website professes to make unlimited space for us (I somehow question that it will be adequate). Definable Weebly limitations are:

a. Their search function is weak providing for finding words only in "Headers" and not in the body of posted documents.

b. They do not facilitate us placing on our website a search empowered linkage to a Resource File we might chose to place in the Cloud (such as Amazon S3) or elsewhere..

No. 2. If we place our Resource File in the Cloud (as for example on Amazon S3) we are left with two challenges as follows:

a. Will we be required to have all of our information posted in a single file to provide for search-ability and if so how do we conveniently add data to the file?

b. What methodology would allow a massive file owned in the Cloud by Allied Families to be searched by us and our guests?

No. 3. We assume Roadblocks No. 1 and 2 are routinely solved by large organizations who can spend large sums of money to accomplish the kind of data management we visualize. We are a low budget 501 (c) 3 organization and need a cheap template already existing or some other workable alternative.

THE SOLUTION---The way we handle Family Trees on our website illustrates what we need for our Resource File. I have some info on the ancestry area for Henderson Upchurch but no hard evidence such as birth/marriage/death certificates. I know from family lore written down some time age. Thanks for the update. I also apologize for lateness of reply (again). I have had several unforseen travels and just got back yesterday.

I will be very busy seems for some time to come. My interest is still there and I have returned my membership for 2015 via USPS.

The Acrobat solution will probably work for storing the data. I'm less certain about being able to search and browse it as we might like without some additional software either off the shelf (costs) or special development (really costs and not really feasible I believe). I'm not at all familiar with Weebly but expect that, although the storage is not "unlimited" it is probably quite large relative to what we may need. However I would check their price for various sizes of gigabytes (and terabytes perhaps). I don't have a good handle on what the ultimate size could be but if it grows beyond their capability I suppose the database could be migrated to another solution. As you know the cost is the issue. I have not been involved in building cloud based solutions before. As I mentioned I'm goig to be involved in such as project but the work including development of software is being done by a commercial developer and will cost \$10 million or so I expect before its all said and done.

Acrobat seems a reasonable way to get started give the costs.

I haven't had time to write up Henderson Upchurch info yet but will do so and send. An interesting family comment from my dad's notes is that Henderson Upchurch was the son of Ruffin (Rufus) and Barbie. The note I have is Henderson's mother died when he was 14 yrs old and he didn't get along with his stepfather so he ran away from home.Leter appearing in Texas fought in Texas revolution, was in Battle of San Jacinto with Sam Houston, later a Texas ranger (I have copy of his pay for some of that time), fought with the rangers in the Vasquez campaign in 1842, fought in the Mexican American War settled in what is now Leadner, Texas married Mary Peyton died in 1892 and buried near Leander, TX - I have location of the grave but haven't had time to find it yet. He and two sone Greeleaf and John. Greenfeaf is my great grandfather.

My grandfather, Thomas Henderson Upchurch married Zelah Alice Sharp. They had three sons: Thomas henderson Upchurch Junior (never married); William (Bill) Nelson and Robert Joseph (my father). William Nelson married Nellie Engbloom and had two sone - William nelson Junior and Bobby) and one daughter \_ Renee. Robert Joseph married Ella Belle Hatherly (my mother) and had one son Me. I don't have any brothers or sisters. I know where everyone is buried except for finding Henderson and Mary's grave in Leander. I am told there is a small fenced area not kept up. Birth, marriage & death certificates will of course tell the tale.
