Eddie Ray Upchurch, 88, died Thursday, Feb. 7, 2013. Upchurch was born Sept. 21, 1924 in Appling County to the late John Richard Upchurch and the late Wilma Morris Upchurch. 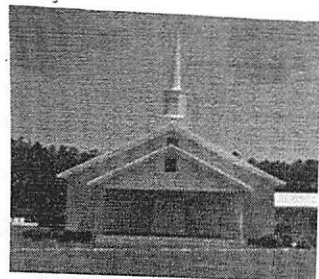

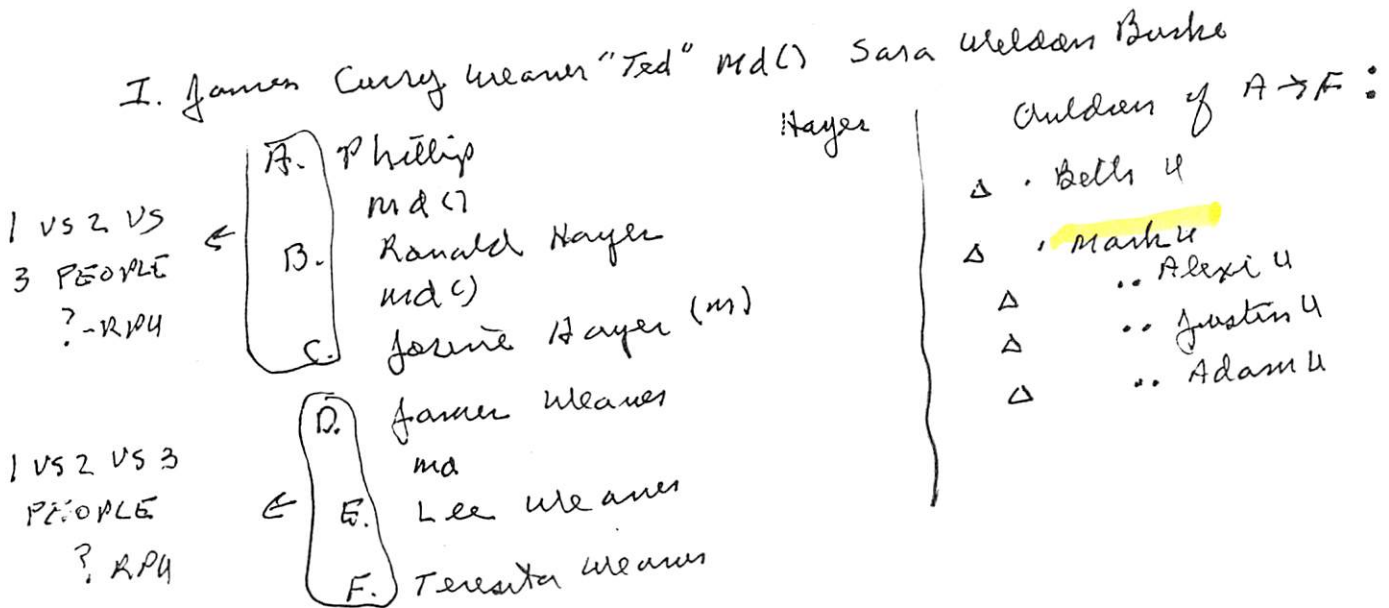

Mr. Nixon, 85, died at Presbyterian Hospital, Tuesday, November 04, 2003.

Funeral service for Mr. Nixon will be held at 11:00 AM today, November 6, at Holy Trinity Greek Orthodox Cathedral with Father Basil Kissal and Father Tommy Vlahos Officiating. Interment will follow in Evergreen Cemetery. Pallbearers for the service will be Jimmy Poulos, Pete and John Polites, George Nikopoulos, George Copsis, Jimmy Stasios, Spiro Nixon and John Kleto.

Xenophon was born in Viniani of Evrytania in 1918. Upon graduation from high school in Karpenisi in 1935, he came to the United States, to Frederick, Maryland where his father operated a restaurant. From 1942 to 1943, Mr. Nixon attended George Washington University in Washington, D.C. At the end of 1943 he was drafted into the U.S. Army, where he served for 30 months in the Medical Corps in the European Theater of Operation. He was wounded at St. Lo, France and was awarded the Purple Heart Medal.

After World War II, Mr. Nixon was honorably discharged from the army and came to Charlotte, NC where he became a restaurateur. He opened and operated, along with his brothers, Steve and Gus, the Presto Grill for Twelve Years. In 1959 the three Nixon Brothers built the famous Nixon Brothers Steak House and Supper Club which they operated until 1975.

In 1950, Mr. Nixon was elected as a member of the Charlotte's Parish Board of Trustees and served as its Secretary for many years. In 1970 and 1971 Mr. Nixon served as President of the community. Since 1962, he has served as a member of the parish's bimonthly publication, The Voice of the Community. He was also the archivist and historian for the community. He has been a member of the Holy Trinity Cathedral Foundation and was elected as its Chairman in 1980 and 1981. Because of his devotion and service to his church and community, in March of 1993 the Ecumenical Patriarchate bestowed on him the medal of St. Andrew the Apostle as Archon of the Patriarchate of Constantinople. Mr. Nixon became a member of the Evrytanian Association of America 'Velouchi' in 1946 and has been elected to its Board of Trustees numerous times and has served as Secretary from 1955 to 1959. He has also been editor of the Velouchi publication. He was elected and served as President of the association from 1983 to 1985. Mr. Nixon was instrumental in the establishment of the Evrytanian Foundation in 1983 and ever since has served as its secretary.

Mr. Nixon married Anna Koutroulis of Wilmington, N.C. in 1950. They raised four children together before her death in 1988.

Mr. Nixon is survived by his daughter Marika Kekas and her husband Nick of Spartanburg, S.C.; sons, Theofanis Nixon and his wife Bonnie of Charlotte, and Nick Nixon and his wife Frankie of Atlanta, GA; daughter, Virginia Williams and husband Alan of Charlotte; grandsons, Evan and Alex Nixon and Mark Upchurch.

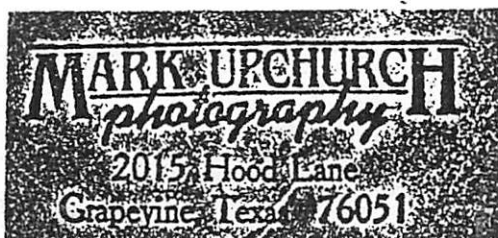

Men Charged In Slaying Of Woman In Duke Park

A woman was found beaten to death about 12:30 a.m. Tuesday in Duke Park, and two men have been charged with murdering her.

The body of the woman, Cynthia J. Easterling, was found behind a picnic shelter in the park by a public safety officer on patrol. She was partly undressed, and police said she may have been sexually assaulted.

One of the men charged with killing her, Thomas Carter of 2132 Bedford St., Apt. 8, was found sleeping in the shelter when the body was found, a detective said. Carter was being held without bond in the Durham County Jail. He is to appear in court today.

On Tuesday night, detectives arrested a second man after an informant told police they might find some of Mrs. Easterling's belongings in the man's car.

The second suspect, Mark Allen Upchurch of 3913 Glenn Road, was charged with murder early Wednesday and was also jailed without bond.

The officer on patrol, Sgt. D.E. Laeng first spotted a shoe and a pocketbook in the parking lot of the park, which is off Roxboro Road near Interstate 85. Then Laeng found the body.

Detective A.E. Harris Jr. said Ms. Easterling was killed by blows to the head with a wooden chair leg.

Police said Ms. Easterling had lived at 1023 Moreland Ave., but they were unsure if that was her most recent address.

Harris said Ms. Easterling had apparently met with Upchurch and Carter earlier Monday, but Harris was unsure if they knew each other previously.

Man Charged In Killing Implicated PSO In Theft

One of two men charged with murder in the death of a 35-year-old Durham woman was the key witness in the trial of a Durham policeman acquitted last April of charges that he helped fake a gas station robbery.

Mark Upchurch, 20, of 3913 Glenn Road was the second to be charged with murder in the death of Cynthia Jacarol Easterling, whose body was found Tuesday in Duke Park.

Upchurch was given a suspended prison sentence after he pleaded guilty in April to charges that he embezzled \$390 from Hales I-85 Amoco station by faking a robbery.

After his arrest for the robbery, Upchurch implicated Durham Public Safety Officer Stephen M. Chorman and told police that Chorman suggested the fake robbery and planned to take half the money.

Police said Ms. Easterling was beaten to death apparently with a wooden chair leg. A public safety sergeant patrolling Duke Park found her body behind a shelter after noticing a shoe and pocketbook lying nearby.

The policeman found Thomas Carter, 23, of 2133 Bedford St., Apt. 8, sleeping under the park shelter. He was the first to be charged in connection with Ms. Easterling's death.

Upchurch was arrested Tuesday night after an informant suggested that police search his car.

Both men made appearances in Durham County District Court on Wednesday.

William Sheffield was appointed to represent Carter, and Richard Rigsbee was appointed to represent Upchurch.

Rigsbee, however, informed the court that Ms. Easterling had been his client and lawyer Arthur Vann was appointed instead.

Upchurch and Carter are being held at the Durham County Jail with no bond allowed.

A woman told the *Durham Morning Herald* that Ms. Easterling did not live at the address given for her by police. That address appeared in Wednesday's *Morning Herald*. Police had several addresses for Ms. Easterling and were trying to determine the correct one.

Witness Fingers Officer In Faked Holdup

A shattered glass window and a service station attendant's nervousness led Durham public safety officers to suspect that an Aug. 18 robbery was faked.

And after asking the attendant for the truth, they were told a fellow officer had planned the bogus holdup, according to testimony in Durham County Superior Court Monday.

The testimony came in the opening day of the trial of Stephen M. Chorman, a Durham public safety officer who has pleaded not guilty to being an accessory before the fact to embezzlement.

The first witness, Mark Upchurch, 19, of 3913 Glenn Road, said he executed the faked robbery on Chorman's instructions.

A few hours earlier, Upchurch said, Danny Hales, the owner of Hale's I-85 Amoco station, had asked for his resignation because of an affair Upchurch was having with the owner's wife.

Then Chorman, a frequent visitor to the gas station, came by and suggested a method of revenge, Upchurch said.

"He said, 'If I were you, to get back at Danny, I would rob the place,'" Upchurch quoted Chorman as saying.

Chorman had suggested such a plan on other occasions, Upchurch said. While he had not reacted before, Upchurch said, on that day "I told him I agreed with him."

Upchurch said Chorman gave him specific instructions on what to do:

He was to wait until 3:30 a.m. when Chorman would be the only officer in the area. Then, Upchurch was to knock supplies off a shelf, break a glass window and hide the money in a bush beside the station.

Chorman told him to describe the robbers as two black men, one tall and one short, driving a green Plymouth with a license plate that began with the letters "TDK," Upchurch said.

Upchurch said he gave Chorman a knife he owned on the assumption that he should not be armed. Chorman was to leave the knife by a fire hydrant on Avondale Drive, the attendant said.

"I quoted something to him like 'I owe you \$100 for helping me, don't I?'" Upchurch said he told Chorman. "He

said, 'No, we'll halve it.'"

The scheme fell apart, according to Upchurch's account, after it was put into action an hour ahead of schedule.

At 2:30 a.m., he knocked supplies off the shelf, put \$300 in a bag and buried the money beside a bush, Upchurch said. Then he called the police station and waited for Chorman to arrive, he said.

The first officer to arrive, however, was A.R. Parker, who had just left a doughnut shop on Roxboro Road.

Parker listened to Upchurch's story, then drove off in search of a green Plymouth with two black men inside, Upchurch said.

At that point, Upchurch said, he realized he had forgotten to break the station window, which he did before Parker returned.

Parker testified that he didn't notice whether or not the window was broken when he first arrived, but asked Upchurch about it when he returned.

The gas station attendant told him the robbers had kicked it out during the robbery, Parker said.

Parker said Upchurch acted nervous

and wouldn't look at him, behavior that made Parker suspicious.

He mentioned his suspicions to Lt. Eddie Sarvis, who agreed that something didn't add up, Parker said. Sarvis also had talked with Upchurch at the station and had been told a robber used his hand to break the window, Parker said.

When the officers confronted Upchurch, Parker said, he admitted having faked the robbery, but refused to give them more information until after he had spoken with Hales.

As Upchurch was being taken to the magistrate's office, Parker said, he made the comment, "I didn't do this by myself."

When asked who had helped him, Parker said, Upchurch replied, "Steve Chorman."

Upchurch testified he saw Chorman at the service station before he was taken away. The attendant said he mouthed the words, "What do I do now?"

Chorman's response, he said, was to turn his back.

Testimony in the trial will continue today.

Officer Denies He Played Role In Fake Gas Station Robbery

A Durham public safety officer admitted discussing faked robberies, but denied Tuesday that he helped stage one on Aug. 18 for his own profit.

In the second day of his trial in Durham County Superior Court, Stephen M. Chorman disputed testimony by other officers that he had confessed to proposing the faked robbery.

Chorman said he was shocked when he heard a police broadcast about a robbery at Hale's I-85 Amoco service station, where he and an attendant had talked earlier about faked robberies.

Chorman is on trial for being an accessory to embezzlement by Mark Upchurch, the service station attendant.

Although he was "98 percent sure" the robbery was staged, Chorman said, he did stop one man in the vicinity for questioning.

Later, when he was certain the robbery was faked, Chorman said, he panicked and went back for a knife that he earlier had taken from the attendant and left beside a fire hydrant. Chorman

said he had taken the knife to prevent the attendant from cutting himself.

He said he tossed the knife out of his patrol car because he was scared and wanted to rid himself of any connection with the attendant, whom he described as a "habitual liar."

Earlier Tuesday, Chorman's commanding officer and a detective testified that Chorman had confessed that he recommended the staged robbery to Upchurch.

"He admitted suggesting the robbery and giving him (Upchurch) details that would make it look real," said Lt. Eddie Sarvis, Chorman's watch commander on Aug. 18.

In a subsequent interview, however, Chorman denied that he took part in the scheme, Sarvis said. Asked why he had not come forward with his suspicions about the robbery being faked, Chorman said he was scared, Sarvis said.

Chorman, who joined the force on Sept. 10, 1979, had been suspended once before for speeding to a funeral procession at 80 mph, Sarvis said.

Detective David Rigsbee testified that Chorman had admitted pursuing a car

matching the description given by Upchurch even though the officer said he was fairly certain the robbery was a sham.

Asked if he had thrown Upchurch's knife away to cover up his own role in the crime, Chorman said yes, Rigsbee said.

Chorman's testimony cast his role in a different light.

He said he visited the service station often to promote good community relations. On more than one occasion, he said, he had told Upchurch that the station's location made it a prime target for robberies.

During one conversation, Chorman said, he told Upchurch how easily someone could drive a car up to the pump and steal gas. To illustrate his point, he said, he described a mythical green car and three letters of a license plate.

It was the same description broadcast over police radios the night Upchurch reported a robbery, Chorman said.

On an Aug. 18, Chorman said, Upchurch said he was resigning his job at the station and wanted to "get back" at the owner, Danny Hales.

They talked about faking robberies, Chorman said, adding that he mentioned "It's done all the time."

"I meant it as a release valve for him to let off some steam so he wouldn't do it," Chorman said.

Then, Upchurch said, "Hey, I'll give you \$100," Chorman related. He added that the attendant drew a knife from his hip pocket and said he would cut himself and his shirt to make the robbery look more realistic.

"I told Mark he had better not do that," Chorman said. "I took the knife away from him to keep him from being cut."

When he heard the report of the robbery at the gas station later, Chorman said, he was stunned because the description of the car was identical to the one he and Upchurch had previously discussed.

"At the moment, it seemed liked *deja vu*," Chorman said.

Officer Acquitted In Fake Robbery

Stephen M. Chorman, the Durham Public Safety officer charged with helping fake a gas station robbery, was acquitted Thursday in Durham County Superior Court.

A jury of six men and six women returned to the courtroom with a not guilty verdict less than an hour after deliberations began.

Several of Chorman's fellow public safety officers, some of whom had testified on his behalf, leaped to their feet, clapped and shouted when the verdict was announced, an outburst that drew the ire of Judge E. Maurice Braswell.

"To see police officers in uniform to carry on as you just did on that front row, I am utterly amazed," Braswell admonished. "One would think you had never been in court before."

Chorman left the courtroom with his wife, who was in tears. He was mobbed by the other officers when he went out the door.

The public safety officer had been charged with being an accessory to a fake holdup at Hales I-85 Amoco station on Avondale Drive. Mark Upchurch, a station attendant, testified that he carried out the scheme on instructions from Chorman, who was to receive half of the embezzled money.

Chorman, calling Upchurch a habitual liar, admitted having talked with the gas station attendant about a fake robbery but denied that he had told Upchurch to do it.

Upchurch, who has entered a plea of guilty to embezzlement, will appear in court on Monday. In exchange for his testimony against Chorman, the district attorney's office has agreed to make no recommendation on his sentence.

Chorman's future as a public safety officer was not immediately clear. He reportedly was suspended pending the outcome of the trial.

Public Safety Director Talmadge H. Lassiter said that no decision has been reached yet on whether Chorman will be reinstated and receive back pay.

"We'll have to look at this real closely," Lassiter said. "A criminal case doesn't necessarily bind us to any specific action."

Chorman's lawyers, Robert W. Myrick and Jerry Clayton, said they, too, were unable to determine what Chorman's job status will be. Those concerns, however, were secondary to relief at having won the case, they said.

On Aug. 18, Upchurch reported a robbery at Hales I-85 Amoco, but when police officers became suspicious, he broke down and admitted that he had staged the robbery himself.

He also told investigators that he had an accomplice, Chorman, one of the officers who responded to the robbery call.

Upchurch said the station's owner, Danny Hales, had demanded his resignation that day because of an affair Upchurch was having with Hales' wife. On a visit to the station, Upchurch said, Chorman suggested the fake robbery as a method of revenge against Hales.

Chorman admitted having talked with Hales about robberies and the way they are committed, but he said Upchurch was the one who broached the subject of a fake robbery at Hales' station.

Chorman said he had taken a knife away from Upchurch to prevent the attendant from cutting himself, as he had threatened to do to make the robbery look realistic.

Having thought that Upchurch would never go through with the scheme, Chorman said, he was stunned to hear a police report of the station being robbed.

Ellie Upchurch lived with my grandfather, Lex Upchurch to help take care of my father, Larry and his two sisters, Agnes and Marjorie after the death of their mother Elsie. Ellie gave the family Bible belonging to John Upchurch to my aunt Agnes. She kept it until her death and shortly after the funeral Marjorie ended up with it. I wish I had photo copied it or written down the information, but I did not see it until she was leaving with it. Unfortunately it will most likely end up in the trash if it hasn't already.

Ellie was Cherokee, but I am unsure if she was full-blooded. She knew a lot of native american medicine and tried to pass it on, but the racism was prevalent at the time and no one in the family seemed to be interested in claiming their heritage.

I have heard that John Upchurch had illegitimate children, but I was unsure of how many or who they were. My dad remembers Cora and Vallie very well. They would often come to visit. Mark and Benton also came to live with them to help raise the kids and provide financial support. Mark amassed a large sum of money from some businesses he owned in Louisiana and brought the cash back to TN. He provided the majority of financial support and parental guidance for all 3 kids until his death.

Mark Wesley UPCHURCH(499)

Mark Wesley UPCHURCH(499) was born 1 September 1851⁴¹⁸ in Alabama, died 21 November 1901, and was buried at Bradley, Oktibbeha County, Mississippi. He was a farmer and Lutheran minister. One of his 1899 sermons has survived, entitled "Make this valley full of ditches." The four page handwritten sermon⁴²¹ included eight lines of poetry that Mark Wesley probably wrote himself. Mark Wesley was married three times in Oktibbeha County. On 28 January 1870 he married his first wife, Betsy "Bettie" Ann LANGFORD⁴²², who was born 12 October 1855 and died 1876-1879, the daughter of John LANGFORD and Lucinda ? . Mark Wesley and Betsy had three children. On 23 December 1879 he married his second wife, Martha A. McKAY⁴²³, who was born about 1847 and died 1880-1886. No children have been found for this marriage. On 30 October 1886 he married Joseph Martha Edmonia HUGHES⁴²⁴, the daughter of Joseph HUGHES and Martha ELLISON, who was born 22 June 1862 in Sturgis, died 20 March 1911, and was⁴²⁵ buried at Bradley. Mark Wesley and his third wife had seven children.

Mark Wesley UPCHURCH(499) had ten known children: William Harrison UPCHURCH(509); Lucinda UPCHURCH(510); Delanie UPCHURCH(511); Bertie Elvira UPCHURCH(512); Frederick Sylvester UPCHURCH(513); Ellen Airmonta UPCHURCH(514); Wesley Ira UPCHURCH(515); Renna Lee UPCHURCH(516); Rosalee Mae UPCHURCH(517); and Troy Calvin UPCHURCH(518).⁴²⁶ Lucinda UPCHURCH(510) was born 26 December 1873 in Sturgis and died 28 June 1916. She married an ADAMS and had three children: Elnora ADAMS who married Elwood ANDERSON; Elvira ADAMS; and Henry ADAMS. Delanie UPCHURCH(511) was born 4 August 1876 in Sturgis and died 7 July 1913.⁴²⁷ On 31 December 1896 she married J.Q. WELLS in Oktibbeha County.⁴²⁸ They had three children: Willie Lou WELLS; Polly Bell WELLS; and Bessie WELLS.⁴²⁹ Frederick Sylvester UPCHURCH(513) was born 17 April 1890 in Sturgis, died 5 March 1924, and was buried at Inverness.⁴³⁰ He was remembered as being sort of an oddball and a drifter with a really bad temper. He would live with his parents until he

got mad about something and then he would move on for a little while.⁴³¹ Rosalee Mae UPCHURCH(517) was born 17 August 1898 in Sturgis, died 12 February 1901, and was buried at Pleasant Hill Methodist Cemetery in Winston County.⁴³² Troy "Roy" Calvin UPCHURCH(518) was born 27 March 1900 in Sturgis, died 1 March 1910⁴³³ of an unknown three week illness, and was buried on 2 March at the Craig Cemetery in Oktibbeha County.⁴³⁴

Two troubles had come upon Israel at this time. The kings of Israel gadah and Edom were gone forth to battle against the king of Moab. Strife is an evil between nations or individuals; it takes years for a nation to recover from the devastating effects of war. Terrible is the destruction of life and property which war causes. To the horrors and perils of war in this case was added a fresh difficulty. Their armies passing through the desert had no water to drink. It was no wonder then that with the soldiers weak and languishing from thirst, with no water either for them or for their horses and cattle, they began to despair and regard defeat as certain. But the Prophet Elisha was sent for, as we have seen and on being consulted by the kings of Israel and gadah he said; "Make this valley full of ditches. For thus saith the Lord ye shall not see wind neither shall ye see rain; yet that valley shall be filled with water that ye may drink. And this is but a light thing in the sight of the Lord; he will deliver the Moabites into your hand." We have here God's power and love manifested in its fullness.

God's promises are all fulfilled when we obey his commands. We should be willing to do whatever he has commanded us to do. A strange command make this valley full of ditches. It was a strange command that ditches should be dug in a desert place. But so it is also in the spiritual kingdom. God often chooses the most unlikely persons for the operations of his grace. Is it not a fact that in thinking of the spread of the gospel and in engaging in christian work we are too much guided by human calculations? We judge too much by outward appearance. We forget that God's ways are not as our ways, nor his thoughts as our thoughts. Is God's arm shortened that it cannot save. It is time for us as christian churches and as christian people to work wherever God gives us the opportunity even though it should be in the most unlikely and unpromising sphere. God calls us wherever we are to dig up the wells in the valley. One other thought this strange command of God suggests. God wants us to be fellow-workers with him. We find human agency as a rule accompanying divine grace. Christ's own command is clear. "Go ye therefore and teach all nations - and lo I am with you alway." How do we stand in regard to the

Is there any command that we are deliberately and constantly disobeying, it ought to be the daily prayer of every Christian, 'Make me to go in the path of thy commandments; for therein do I delight'. The way of salvation is clear; believe on the Lord Jesus Christ and thou shalt be saved. Is it not better for us as these soldiers did to take God's plan to believe that whatever he commands is for our good to accept his loving offers of salvation purchased for us by the precious blood of his beloved Son, and to yield ourselves to him as willing servants doing the will of God from all hearts -

You may never see the streams of blessings flow, but at any rate you will have dug the channels for them. Such labor is not in vain in the Lord.

Miscellaneous Holmes County UPCHURCH's

Holmes County, Mississippi presented a big mystery in the UPCHURCH history. Two of the children of Moses UPCHURCH(498) went to Holmes County to marry, Walter Lane UPCHURCH(506) and Peter J. UPCHURCH(505). William Harrison UPCHURCH(509), son of Mark Wesley UPCHURCH(499) and nephew to the above men, also married here. However, there are additional UPCHURCH members in Holmes County that have not been tied in with any of the other UPCHURCH lines. Family history has it that Moses UPCHURCH(498) had one or two additional daughters that are not accounted for in this history. Perhaps part of all of these Holmes County lines are some of his descendants.

On 24 January 1894 Mrs. L or T.M. UPCHURCH married W.S. MADISON. The bride was eighteen and the groom twenty-one.⁶⁸⁷ On 3 January 1895 Maude UPCHURCH married Henry ALSTON.⁶⁸⁸ Nothing more is known about these girls. Due to the age of the first bride, the Mrs. could be in error. The two brides could be UPCHURCH sisters, sisters who had previously married UPCHURCH men, or totally unrelated.

In 1900 Holmes County, two widowed sisters lived in the same household, Eveline LUCUS and Fannie UPCHURCH. Eveline was born in June 1854 and Fannie in February 1872. Fannie had three children by her UPCHURCH husband: Mable UPCHURCH(964) born in October 1892; Fannie UPCHURCH(965) born in January 1895; and Jimmie UPCHURCH(966) born in June 1896.⁶⁸⁹ Fannie UPCHURCH(965) married Lee BURGE on 27 June 1913 in the same county.⁶⁹⁰ The father of these UPCHURCH children has not been found.
