Five of the children are still living, with four of

△+△+△+△+△ them, Prebble, Mary, Ona and Anna, living in Erick. Hollis lives in the Dallas/Ft. Worth area. They had one daughter who died in infancy.

They first settled on a farm where the Erick F.F.A. farm is located. They later moved to the Hibbard Community and then settled permanently in the Dabney Community.

A short time later four brothers of William Holland:

△+△+△+△ Jess, Tom, John and Booker also moved their families to Western Oklahoma from East Texas.

The families worked pulling cotton and they traded some of their homemade syrup for groceries to help them make their way in their new home.
