I think the addition of one laptop or desk top would be helpful right away. Sarah's laptop isn't the best. We couldn't get her Vista OS to connect to Ancestry, even though it was able to connect to the wireless system. She worked on the desk top, which is generally fine, unless someone else needs it for a particular reason.

I think Woody, Mike and I are in agreement at this point that Sarah is super personable and excited to be a part of the group, but that it will take time to assess if she has skills that may be of value in a more managerial position. Ideally, someone who is an early retiree, late 50s or so, who has time, experience, and a knack for genealogy would be ideal. Sarah has not worked with Ancestry before, so I'm not only needing to train her on how to use Ancestry, but also how to apply that knowledge to your Master Outlines. It's a lot to take in for a novice. We are making progress, but slowly.

Jay, it would be helpful to have some biofiles to access so that I can also let Sarah try her hand at transcription. That seems to be a good gateway to learning the "Allied System" with the added advantage of Sarah being a very good typist.

#### Hi Carla---

It appears we are ready to take another step with Sarah Watson and I want to get your reaction to a plan. She and Monk visited for two hours on the 23rd and he gave me a favorable report. The plan has two parts.

For Part I Sarah would work as a Volunteer attending the Thursday afternoon sessions and working with you on populating the Richard Upchurch, III Legacy Tree. We are working to get 1-3 computers for the Cary Facility and she could take one of these home and continue to work as a Volunteer on the Legacy tree. There are other things she could do as a Volunteer on her Line. For example, Jay and I could work with her on annotating the Kearney Upchurch cemetery to be put on our website. Thus Sarah would gradually become knowledgeable about our system so as in Par II to be able to explain it to others

For Part II she would work 4 hours/week (for now) at \$10/hour. As a prime activity I propose that Sarah preside over a second work session for the Cary Facility--possibly on a Saturday. This would be billed as an Open House event and we would recruit people to come and participate. One activity might be to get copies of photos that people would be willing to share. As another avenue I would explore whether WCGS might be willing to cosponsor with our Association a Special Interest Group (SIG) to do research on Wake County local and family history. This could take place in the second work session. Perhaps others could provide backup for Sarah in the second work session. Kim Wrenn would be an option for some days as would Monk.

Later on we could explore the prospect that Sarah could take on some duties we now perform in Chesterfield.

After I hear from you I will have a chat with Sarah about a way forward. Thoughts from Woody and Mike will be welcome also.

Today I contacted Sarah Watson to review progress she is making on her participation in our family history collaboration. We had a very productive phone conversation. While she needs more time to become acclimated, our original game plan continues to look feasible. Basically this involves her working on several aspects of her Richard Upchurch, III Family as a volunteer and, at some point, becoming additionally a part-time paid worker for Allied Families.

We are grateful to you for helping Sarah get oriented and will appreciate your suggestions on steps to be taken. Her present work on the Richard Upchurch, III RPU Legacy Tree is a good step. Now with access to one of the Cary loaner computers this can proceed more rapidly. Working on a Biofile is another good step. She had studied the heritage chart on the Cary Office wall and could use a little more help in negotiating this. It would also be helpful if she understands more fully how this chart leads to enrolled families, videos, and Biofiles on our websites. At some point, I would like to work with Sarah on annotating the Kearney Upchurch Cemetery and capturing photos for the 1840's Kearney Upchurch home.

We need not wait until Sarah is fully acclimated to begin to chart tasks for her to perform as a paid worker. Sarah is already on board with the idea of her helping with a second work-session for the Cary Facility. It seems that a Saturday afternoon slot would work well. I hope this can be initiated prior to July 1. Work to be done could be open ended, but I suggest having Sarah up to speed on capturing photos could be included as a project. Jay and I will work on a protocol for this.

In order to increase the productivity of a Saturday work session, I propose that we work to provide some back-up for Sarah. Monk Perry has agreed to help some, his health permitting. Kim Wrenn has agreed to attend some sessions and otherwise to be available to consult by phone. I am wondering if one or more of our Thursday volunteers might be willing to lend some support to our Saturday venture, especially in the beginning.

As Sarah continues to fit into our Cary operations, I visualize this as opening the door to more functions being transferred from Chesterfield to Cary in the next three years. We need to continue to engage Judy Rysdon and Nancy Saul in our discussions and can now add Sarah to the mix. In the meantime, I am pleased to learn the Terri Burns and Jay Buck are collaborating on a Facebook venture.

Tom and I have been working on a Critical Functions document relating to what needs to be done in the next three years. The momentum now building for our Cary operation should increasingly provide us options on just who might fill specific roles as more functions are put in place in Cary.

Carla, you have the best group of our Cary operation, so your help in evaluating options going forward will be most welcome.

Still anticipating a trip to Cary when it can be scheduled later this year. Sending all best wishes,

Just a note to let you know how things are going in Cary! Our volunteers continue to come on Thursday, or if they can't, they work from home, ensuring steady progress. I had started an email earlier in the week to you, and discovered it in my drafts file. It's been a little hectic with my step mother's situation recently.

I spoke at the American Legion Memorial Day Service this past Monday, representing our DAR chapter. I think that's the last big thing on my list (until the next thing comes up)! Anyway, Sarah is willing to continue learning how to work on a Master Outline. I'm working my way through Richard III 9th generation/Claburn Sub-clan and beyond right now.

My Dropbox has the Britton sub-clan in it and it's not too big. If that one isn't taken, that might be a good one to give her, so she can see it completed without taking too long, even though she isn't adept yet at Ancestry.

I spent yesterday at the office with Sarah, working on the Master Outline assigned to me. I had her observe me doing the inputs for awhile to refresh her memory of the process, talking her through it and answering questions and then had her take over to do them herself while I was observing. She does seem to have a long way to go before she is comfortable with working on it by herself. Her lack of research experience keeps her from intuitively knowing which generation she is working on, and without monitoring, I think she might make input errors. I'm hoping that will clear up with practice and over time. In the meantime, a short Master Outline, as suggested above will be helpful so that she can see progress.

I also recommend sending some shorter, less complicated biofiles for her to continue with. I do not recommend having her work on Master Outlines at home right now, but she is eager to contribute, so working on biofiles outside of the office would be a solution. I was engaged in conversation with someone else as Sarah was leaving and only later realized that she ended up taking Sion to work on this week. Its complexity is a drawback for her. I will have her trade it for a shorter one next week when we are all back in the office.

I also wrote Brenda Sue Upchurch Pickett and await her reply.
