Catherine Hawkins widow of the aforesaid deceased now living and I do hereby acknowledge and release all my part of the aforesaid estate my the land containing about two hundred acres lying and being in the County of Greenville State of South Carolina on the water of Reedy River adjoining land of Park Hawkins Mrs Uppard and others near the Pisgah Mountains & and it is expressly understood that the said John Upchurch do by these presents and it is his intent and meaning of this instrument of writings to convey to said Lewis Bridger all the interest I have in the before mentioned estate to which I am in any way entitled to by the last will of the said Eaton Hawkins or fully as if that conveyance were more fully and clearly expressed ~~these~~ together with
