Further to yours of the 18th. I have now had a chance to visit my Valley office and have reviewed my files on your close relatives which are especially good because of inputs from your first cousin Eleanor, may she rest in peace. In reviewing the files I was reminded of the great sacrifice your family made and of your great personal loss when your father gave his life for our Country on D day in France. I hope present day generations appreciate and honor Lieutenant Howard Unchurch, Sr and his kind to whom we are indebted for so much. Here is a brief excerpt that Eleanor wrote to me on March 10, 1982 about your father: "He was an architect, was hansom, was a musician and played the piano beautifully--was a graduate of Auburn University where he performed with the "Auburn Knights"".

I also have the feeling that Eleanor did not finish her work which is generally the case with family historians. Further, their records often get put aside and eventually are lost. With the creation of Unchurch And Allied Families Association we have a Headquarters location where we can entertain the acceptance of compiled records. Perhaps it is too late to even learn what happened to her records but if there is a possibility of learning of the existence of her collection I would welcome opportunity of exploring the possibility of them being acquired by UAFA.

My Master Outline, kept manually, for the Burton Unchurch Line in the Abel U.,Sr/Bartley U Subclan, to which you belong, is in good shape. If you are interested and will provide a mailing address I will be happy to mail you a section of the compendium so you can see some details and learn how my records are kept. Later we could do more if you are interested.

You will note from my website that I have produced videos on several of the children of Richard U., II 1725-1798, your and my common ancestor. He established the Upchurch enclave on the border of Wake and Franklin Counties in North Carolina about 1765. Each of the children of Richard U.,II headed one of the 22 Unchurch Clans. You descend from his son Abel U., Sr ans I descend from another son Nathan U.,I. I have produced a video on Nathan and plan to produce one on Abel. There is a lot more to learn about Abel U.,Sr who left N.C. about 1820. It is my hopes that among the families we "enroll" in the plan of work for UAFA will be the Abel U. Sr., Family. This would allow the story of this family to be online at one spot sort of like a book.

I realize that individuals have different levels of interest in their heritage. I will be interested to learn of your particular interests and to work with you collaboratively in keeping with your level of interest. As you can no doubt tell my bite by the family history bug was severe.
