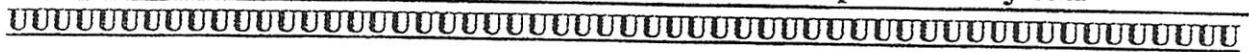

In response to your email of 18 AUG 2014 I decided to improve my records on your GF Thomas Boyley U. I thought this a good intermediate place to start. over time we can move to earlier or later generations but I gather your preference is to move to the children of Thomas Boyley U which I will be glad to do. In each case I find it necessary to "clean up" the records and to add to them as I did for the record on your GF enclosed as follows:

Biopile for TBU - 4 Pags - 9 Items + Sub-Items

From these records you will be able to figure out where your GF was at various times and see when his children appeared

I note that your father David signed on the 1940 Census as an 8-year old.

I have a thought as where the Bogley in Thomas Bogley U came from but I will have to do a little more research on my idea.

I am encouraged that you will send in financial support to help us along with the enrollment of the Nathan U, I family to which you and I belong. See enclosed sheet.

We have a draft of a narrative for the Nathan U, I Family. One son his brother Moses U was sent to 33 of his descendants on August 19. The drafts are in rough form and will appear more polished & easier to use once we get our records included for Allied Families operational. we are now working on the upgrade.

It is to bad you will not make it to NC this year. No plan for 2015. I can arrange for Billy Upchurch who lives in western Wake Co., NC to give you a tour. He has always lived in the area. He is a first cousin of your GF Tom Bogley U and would have know all of Tom's children.

Billy has a been interested in his Lynch's heritage. He has already donated to support the enrollment of the Nattrans U., I Family.

If you are ever going to visit the Lynch's end one in Western Wake where your ancestors lived it would be better to do it sooner than later as time will take away some of our sources.

Could you tell me a little about yourself - your interests, - your work life, where you grew up? As for me my oral history is posted on the Internet via the Lynch's Collection at N. C. State University.

Enclosed herewith is a copy of my master Outline for the Buster U family through the 9th generation (Michael U, I am Generation No 1). This is data for the Nathan U, I / Buster U Subclan. After you have processed this I can send similar packets for the other children of Nathan U, I each of whom head a Subclan.

So this packet covers the children, grand children and great grandchildren of Buster U. The descendants (if any / if known) of the great grandchildren are covered in continuation section "15" as shown on the left hand side of the page. Just when we will

handle these digitally is an open question

You will note that the format of these records is designed to capture full names (full maiden name of females) dates of birth, marriage, death and place of birth, marriage, death and burial. For place I like to include town / county / state and the name of the cemetery. You will be the first to see how much of this can be placed on one of our Alford Families Family Tree on Ancestry.com. Do let me know questions.

Your ancestor Bartus U produced an important slice of Guilford history. He had nine sons - no daughters. The youngest died in the Civil War July 11, 1863. One of his descendants George U was a classmate of mine at N.C. State University.

Two of the same W. C. U., I & Alfred U were pioneers in the city of Raleigh and we would prefer to bury their contributions at light. Other sons stayed in Wenden Wake and made great contributions there.
