Thank you for your email about the passing of Alan. I send my heartfelt condolences for the loss of your father. I know you will miss him greatly as will I. He was a dear friend. A copy of his extensive obituary in the Raleigh newspaper was sent to me by a friend and I have preserved it in his Biofile.

Just in the last day or so I have posted a letter of condolences to you mother in which I recapped the friendship that Alan and I had and the number of times that we interacted including visits to the McGee household in Advance.

I am please to know that you are preserving the family history records that Alan accumulated. He has shared some major portions of this with me and details have been incorporated into our Allied Families archives. Notable were two albums of photos and clippings of his extended family. I imagine you have the originals. We are developing our Allied Families Cary Facility to accommodate such collections where circumstances are appropriate.

Often in a family there is no one who is prepared to carry on the interests of the family historian in the family. I am glad to learn that you continue the interests that Alan had. You, in a sense, assume to mantle of representing what we can call the Raeford branch of the Upchurch family. The record of this Group is a rich and storied one.
