(10) Notes of call to RPH from Barbara 4 AUG 2007

Barbara has checked on the murder of my classmate Bill Cochran in Pittsboro in the 1950's. He was courting a young lady who earlier had an older suitor - George Smith. He placed dynamite in Bill's car & killed him. George was not arrested after the incident but the girl was alert re her car and informed authorities when she found it with an explosive device in it. This led to SBI/FBI getting on the trail of George. As the authorities got closer he committed suicide. Barbara is open to a visit from me

We met in the home of Barbara Martin (Andrews) James (DIV - one child) b. 1933. Her sister Eleanor Jane (Andrews) (Hewitt) Melinaat around shortly & we had a 2 1/2 hour chat. There brother George did not come as Barbara had hoped.

Then father George Henry Andrews, Sr. ran a store in Chatham Co, NC as did his father. He was selected by the voters to run for Chatham Co, NC Sheriff & was elected 4 terms. When Ben Scott became Governor he took an appointive office. He had diabetes which the family hid from the electorate. He was outgoing and loved people & his job. He & Beatrice lived most of their lives

in the home where I visited Beatrice year ago (Upon departure we spelled the house - still intact) They had a cousin Andrews relative who was a hermit. At the end stayed in the Post House for a short while.

They felt Aunt Ellie (then GM) was poorly served in having to live first with one child & then another in his lengthy widowhood. They were shocked when a postcard arrived from her with writing on front & back giving family secrets - such as James got drunk again last night as usual. Aunt Ellie had a teaching certificate.

Jane said Dan's MIL lived with Dan & Suzanne. Jane confirms that Suzanne had been married before she met Dan. At that time having no children Jane said Suzanne was nearing the end of her childbearing years when she married and they also probably decided not to have children because of their close kinship.

The Martin children probably got a break on education costs in college as they went to Baptist institutions.

Dan apparently had several reactions to drugs & was institutionalized twice following such reactions. He was handsome but a hard taskmaster. He was in the Philippines during the war. Jane wanted to marry him. Aunt Ethel opposed Jane of wanting to be his heir.

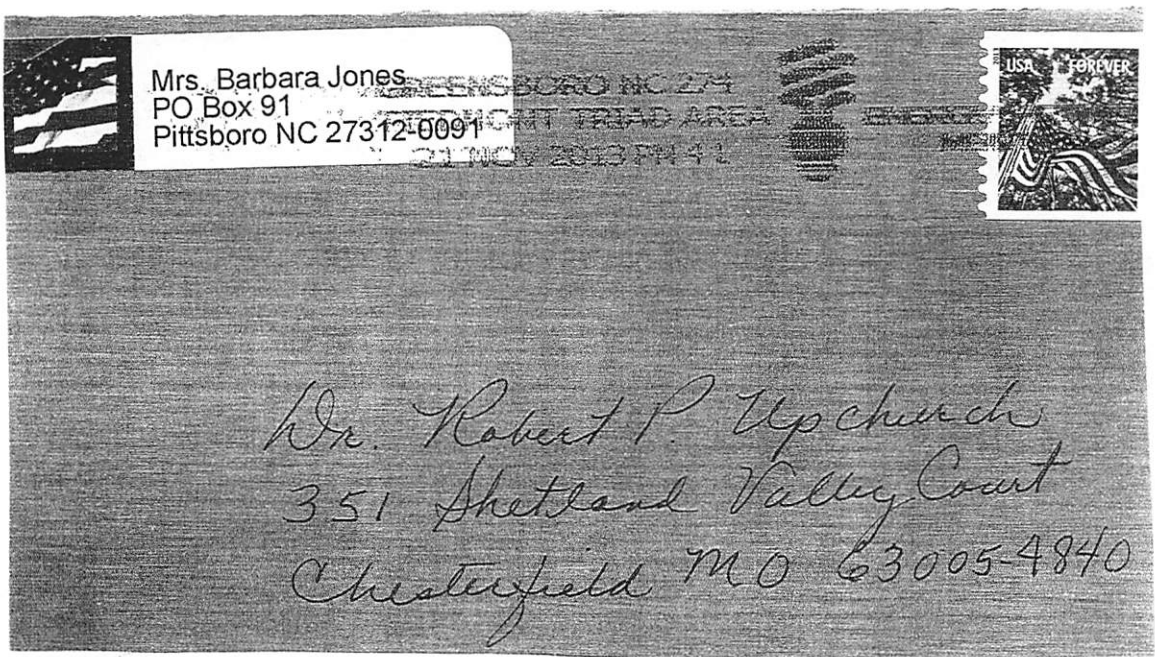

THE SOURCE OF GIVEN NAMES IN UPCHURCH CLAN NO. 3  
HEADED BY REVOLUTIONAARY WAR SOLDIER NATHAN UPCHURCH, I  
1759-1835 WITH EMPHASIS ON THE FAMILIES OF HIS SON  
GILBERT UPCHURCH 1792-1845 AND HIS GRANDSON  
BARTLEY JEFFERSON UPCHURCH 1841-1929

I. Nathan Upchurch, I 1759-1835 – Source unknown – maybe a Bible name? His children were named Burtis, Gilbert, Hubbard, Acril, Nathan II, Tabitha, Mackey, and Aquilla. So far sources are unknown, except for the fact that Nathan U., II was obviously named for his father. The name Nathan continued as II had III and III had Nathan U., IV. None of the children of Nathan U, I had two given names.

B. Gilbert Upchurch 1792-1845. He md 1<sup>st</sup> Elizabeth Upchurch and 2<sup>nd</sup> Lucretia Mills.

1. Mariah Elizabeth U. 1820-1900. She was a child of Gilbert's first wife and named Elizabeth after her mother. She was blind and lived in the home of BJU and was lovingly called "Aunt Mariah".

2. Nathaniel Smith U. 1823-1913. Patriarch of the Florida Upchurches. There was a Smith family in western Wake Co., NC where he was born, leading one to believe that the Smith family and our Upchurches were somehow connected. (For more see Uncle Lass No. 4 below). Uncle Nat had 10 children born in FL, all with two given names. So far we do not trace any of the 22 names back to Gilbert U. and Nathan U., I, although the names George and Elizabeth used could have come from siblings of Nathaniel. One could argue that Nathaniel could have been a play on the name of his GF Nathan U., I.

3. Nathan U. 1827-1855 +/- was blind – obviously named for his GF Nathan U. I.

4. Lamberth Lassiter U 1830-1905. He was partly blind and lived in the home of BJU and was livingly called "Uncle Lass". His unusual names immediately lead one to speculate that they came from family connections. On July 25, 2009 an email from Cousin William Alan Mills allowed a reasonable theory to be developed. Lucretia Mills, the wife of Gilbert U., was the daughter of Naaman Mills who married Penelope Lassiter. Thus, we can surmise that Lucretia named Uncle Lass after her mother, nee: Penelope Lassiter. Further there is some evidence that the mother of Naaman Mills was nee Smith which could be the source of the name of Nathaniel Smith U. being the GM of Lucretia. So, the descendants of BJU also have a Lassiter heritage. There were Lamberth family members in western Wake and that need to be investigated.

5. Marie U. – No information.



6. William George U. 1837-1895. "Uncle William" AKA "Bill" married Eleanor Marks U., I 1844-1927. Their 7 children were: Minnie Florine, Harvey Clinton, Delmer Demond, Belle Williamson, William Garland, Eula Gartrell and Sadie Rowena. Sources need to be established. Williamson came from Uncle William's business partner B. P. Williamson.
7. Haseltine U. 1839-1862. - No information.
8. Unnamed daughter - No information.
9. Unnamed daughter - No information.
10. Bartley Jefferson U. 1841-1929 "Jeff" md Aurora O. Ray 1849-1869 "Roe".
  - a. Ellena Judson U. 1870-1947 "Aunt Lena" - need sources.
  - b. Bessie Estille U 1872-1962 - need sources md Miley Perry 1876-1929.
    - i. Mancy Clyde Perry "Clyde" - She was named for her grandmother, Mancy Denton.
    - ii. Alton Owen Perry, Sr. 1904-1982 md (2<sup>nd</sup>) Anne Elizabeth Bryan 1914-2004. Alton named a son Jr. and named Monk - Miley after his GF Miley Perry and Albert after his GF Albert Bryan. Alton named his son Anthony Bryan Perry, Sr. using the mother's maiden name.
    - iii. Percy Barrett Perry "Percy" 1906-1991.
      - (I) Percy Buffalo Perry "P. B." - The Buffaloe from his mother's maiden name.
      - (II) William Dean Perry - The Dean from his mother's maiden name.
      - (III) Bessie Bonita Perry - The Bessie from her GM.
    - iv. Lena Upchurch Perry "Sister" 1907-1998. Lena from her Aunt Ellena. She md Edwin Holt Tilley.
      - (I) Frances Holt Tilley - named after her Aunt Frances and her father.
    - v. Frances Lane Perry 1909-1997 - The Lane from her Aunt Patricia Aline U. who was also called Patty Lane U. md Harold Desmond Wilson, Sr. They named a daughter Evelyn Clyde Wilson after her sister Clyde and a son Jr. "Harold Je." Who named a son III "Desi".
  - c. George Malcom U 2879-1938 "Uncle Mac". The George after his Uncle William George U. The Malcolm ?
  - d. Eleanor Marks U., II 1875-1967 named after Eleanor Marks U., I "Aunt Mox" the wife of William George U., E., her uncle. She md James Lee Martin, Sr. They named a son Jr., and another William Andrew Martin and a third Walter Daniel Martin -Sources?. Daughter Beatrice Roe Martin got "Roe" from Aurora. Eleanor Upchurch Martin got her mother's name. Mary Garnette Martin - ?

- e. Patricia Aline U., II 1878-1935 "Aunt Pat". Aunt Mox had a sister Pattie Aline U., I (of whom we plan to publish a photo). She was prominent in Raleigh circles and it is quite likely Aunt Pat was named for her, although the Aline in Aunt Pat's name could be spelled somewhat different.
  - f. Robert Jefferson U. "Little Jeff". "Jeff" 1880-1948. I, Robert Phillip U., was named Robert after my father and Phillip after a character in a book my mother was reading. My sister Patty Lane U. was named after Aunt Pat. My sister, Ernestine Ray U. was named to honor our Ray heritage.
  - g. Gettis Henderson U "Uncle Gettis" 1882-1957. Gettis - ? We have some hints for Henderson which need study.
  - h. Wisconsin Lamar U. "Uncle Wis" 1884-1959. Wisconsin comes from a Dr. Wisconsin Royster in Raleigh who delivered babies. The ladies thought so much of the Dr. that they named their children after him. Lamar - ??.
  - i. Martha Ray U. Aunt Maude" 1886-1975. Martha ?? Ray was her mother's maiden name.
  - j. Frank Jones U "Uncle Frank" 1888-1968, md Edna Dell Woodcock. Frank - ?? but the Pattie Aline U. I mentioned above had a husband Franklin O'Kelly Moring, Sr. who was a business partner of Uncle William. Maybe the Frank name came from Mr. Moring. Jones came from a Minister at Inwood. Uncle Frank and Aunt Edna used their names for their children and reached back to Bartley to pick up Frank Jefferson U., Sr. Monk reports that Aunt Edna had a brother Bennie Woodcock hence Bennie Jones U. for "Bitsy". Lois said she would have used Bartley for one of her children but as pronounced she thought it spelled "BOTLEY" which she did not favor. In this family much confusion has arisen because Uncle Frank's son Frank Jefferson Upchurch was called "Frank Jr" whereas he was not a "Jr". Then Frank Jefferson named a son "Jr" thus himself becoming "Sr" still always being affectionately known as "Frank Jr." in the family.

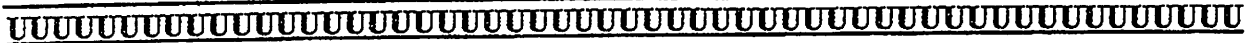

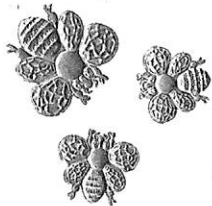

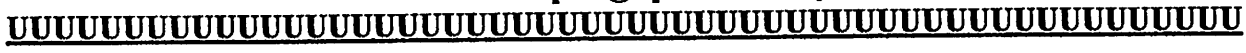
