△ FOOTE, JAMES HENRY

Resided in Wake County as a professor at Wake Forest College when he was appointed Captain, at age 33, to rank from May 16, 1861. Submitted his resignation December 19, 1862, stating that "he had vacated his seat as professor with the proviso that he return within a year and that now after 19 months he is being urged to return." Resignation accepted on January 6, 1863, and he was appointed Assistant Adjutant General, State of North Carolina, with the rank of Major and assigned to the Roll of Honor.

△ FOWLER, HARDIMAN D.

Resided in Wake County and appointed 2nd Lieutenant at age 28 to rank from May 16, 1861. Promoted to 1st Lieutenant to rank from September 20, 1862, and to Captain to rank from January 6, 1863. Present or accounted for until captured at Spotsylvania Court House, Virginia, May 10-12, 1864. Confined at Fort Delaware, Delaware, until transferred to Hilton Head, South Carolina, August 20, 1864. Transferred to Fort Pulaski, Georgia, October 20, 1864, and returned to Hilton Head on November 19, 1864. Sent to Fort Delaware, Delaware, on March 12, 1865, where he was released after taking the Oath of Allegiance on June 16, 1865.

△ CARVER, ELIAS A., 2nd Lieutenant

Resided in Wake County where he enlisted at age 17, July 16, 1861, for the war. Mustered in as Private and appointed Sergeant, November-December, 1862. Elected 2nd Lieutenant on February 20, 1863, and appointed to rank from date of election. Present or accounted for until captured at Spotsylvania Court House, Virginia, May 10, 1864. Confined at Fort Delaware, Delaware, until transferred to Hilton Head, South Carolina, on August 20, 1864. Transferred to Fort Pulaski, Georgia, October 20, 1864, and then back to Hilton Head on January 1, 1865. Transferred on March 12, 1865, to Fort Delaware, where he was released after taking the Oath of Allegiance on June 16, 1865.

△ HEARTSFIELD, JACOB A., 1st Lieutenant

Resided in Wake County where he enlisted at age 22, July 16, 1861, for the war. Mustered in as Private and appointed Sergeant June 26, 1862. Promoted to 2nd Lieutenant to rank from October 25, 1862, and to 1st Lieutenant to rank from January 6, 1863. Present or accounted for until captured at Spotsylvania Court House, Virginia, May 12, 1864. Confined at Old Capitol Prison, Washington, D.C., until transferred to Fort Delaware, Delaware, June 17, 1864. Transferred from Fort Delaware to Hilton Head, South Carolina on August 20, 1864, and from there to Fort Pulaski, Georgia, October, 1864. Returned to Fort Delaware by way of Hilton Head on March 12, 1865. Released after taking the Oath of Allegiance at Fort Delaware on June 16, 1865.

△ PATTERSON, HENRY HOUSTON, 2nd Lieutenant

Resided in Wake County where he enlisted at age 17, August 8, 1861, for the war. Mustered in as Sergeant and appointed 1st Sergeant November-December, 1862. Elected 2nd Lieutenant January 9, 1863, and appointed to rank from date of election. Wounded in action at Spotsylvania Court House, Virginia, May 10, 1864, and reported as absent-wounded until returned to duty on December 29, 1864. Furloughed on January 4, 1865. Paroled at Appomattox Court House, Virginia, April 9, 1865.

△ SCARBOROUGH, WILLIAM D., 1st Lieutenant

Resided in Wake County and appointed 1st Lieutenant at age 28 to rank from May 16, 1861. Wounded and captured at Sharpsburg, Maryland, September 17, 1862. Died of wounds in hospital at Frederick, Maryland, on September 20, 1862.

△ TERRELL, JAMES J., 3rd Lieutenant

Resided in Wake County and appointed 3rd Lieutenant, at age 26, to rank from May 16, 1861. Wounded in action at Malvern Hill, Virginia, July 1, 1862, and leg amputated. Resigned January 31, 1863.

18. James David BLACK1 was born on 14 Dec 1855 in MS.. He died 17 Or 19 May 1926 ? in Hinds Co., MS.. He was buried in Lula Baptist Church Cemetery, Madison Co. Mississippi. He was Methodist. Possibly buried off Highway 22 between Flora and Brownsville in Madison Co.
- James David black had a half brother named John Posey and a sister named Nannie. John Posey has two sons Emmett and Prentiss and 1 daughter - Willie Mae. He was married to Elizabeth Rebecca CARVER in 1879 in Madison Co. Mississippi or Hinds Co. Mississippi.
19. Elizabeth Rebecca CARVER1 was born on 12 Aug 1860 in MS. She died 21 Oct 1931 or 1932 ? in Monroe, La or Madison Co. Ms ?. She was buried in Lula Baptist Church Cemetery, Madison Co. Mississippi. She was Baptist. James David BLACK and Elizabeth Rebecca CARVER had the following children:
- i. Percy Lee BLACK1 was born on 23 Apr 1886 in Madison Co. Mississippi. He may have moved to Texas. A Internet friend (Maurrine Mattson) said to us. That her cousin John Francis Smith, once told her that Percy Lee Black was the black sheep of the family and they didn't talk about him . They never mentioned him. He did have a daughter named Myrtle and possibly a son. He died in 1962.
 - ii. John Franklin BLACK1 was born on 23 Sep 1879 in Madison Co., Mississippi. He died on 9 Mar 1959 in Hollendale, Mississippi. He was buried on 10 Mar 1959 in Flora Cemetary, Madison Co., Mississippi. John Franklin Black is The great grandfather to our friend (Maurine Mattson) She said she thinks her great grandfather was living with her Aunt in Hollendale, Mississippi, when he died. He was buried in Flora Cemetary in madison co., Mississippi.
 - 9 iii. Susie Sarah Arcola (Ollie) BLACK.
 - iv. Mary E. BLACK1 died on 19 Sep 1922. mary had 12 children
She was born 2 Feb 1883 or 19 Jan 1922 ? in Madison Co. Mississippi. Was told that she had 12 children.
 - v. Jessie M. BLACK1 was born on 31 Oct 1884 in Madison Co. Mississippi. She died after 1900. Sources say that Aunt Edna and and james P. black's widow was talking about her in the late 1950's early 1960's.
 - vi. James Pliny BLACK1 died on 11 Aug 1959. He was born 21 Sep 1889 or 1896 ? in Madison Co. Mississippi. He was the Justice court Judge in Hinds County, Either in the 40's or 50's. (Maurine's grandfather owned petrified Forrest out from Flora, in the late 40's he had roads and picnic tables out there. He had no children at least known of living in the 1950's.
 - vii. Connie H. BLACK1 was born on 9 May 1891 in Madison Co. Mississippi. She died aft 1900 or 1910 ? in Monroe, La.
 - viii. Susie Ann or Susie R. BLACK1 was born on 29 Sep 1895 in Madison Co. Mississippi. She was buried after 1910 in Boltou Cemetary.

DURHAM - Mr. Irvin Lewis Carver, 78, resident of 337 Tarleton East, died Monday Morning in Hillhaven Convalescent Center following an extended illness. He had been a life-long resident of Durham. He was a retired employee of 30 years as a horticulturalist at N.C. State University in Raleigh. He was a member of Mount Bethel United Methodist Church.

He was a member of the American Horticulture Society, N.C. Association of Nurserymen and the N.C. Farm Bureau. He was educated in the Durham and Orange County Schools. He received his degree in horticulture from N.C. State University. He was a veteran of the U.S. Army having served during World War II.

Surviving are seven sisters, Mrs. Louise C. Hall, Mrs. Gladys C. Lovitt and Mrs. Catherine C. Jeffries, all of Durham, Mrs. Carrie C. Maddry of Swansboro, Mrs. Ruth C. 'Just Blind, Dumb Luck'

James Carver says he doesn't know how he survived Wednesday's bombing of the Murrah Building. The Federal Highway Administration employee stumbled, half stunned, down the stairs from his fourth floor office with only cuts and bruises. He grabbed this folder of family photos from his desk as he fled. "We've got three kids and six grandchildren," he said as he slowly walked north from the building more than an hour after the blast.

Carver said he had worked in the building since it was opened in 1977. As many as 10 of Carver's were missing and presumed dead. (Metro Downtowner Photo by Claude E. Long)

What really happened was that I was blown against the back wall of my office along with all kinds of debris. After sitting there stunned a while, I climbed over to the blown out window. About an hour later, I climbed down a ladder from the fourth floor. After Jeanene got me home, Michael was all ready there from Dewey and he sewed up the cuts on my hand.

"The floor" consisted of a ledge about 2' W
X 4' or 5' long! (3)

DEAR JENNIFER,

THIS NEWSPAPER GOT THE PHOTOGRAPH AND THE NAME RIGHT. WHAT REALLY HAPPENED TO ME WAS THAT I GOT BLOWN AGAINST THE BACK WALL OF MY OFFICE AND I SAT THERE ON THE FLOOR STUNNED A WHILE. AFTER THAT I GOT THE PIECES OF DESK, WALL, PIPE, STUDS, CONCRETE, AND OTHER DEBRIS OFF OF ME. I FOUND YOUR PICTURES LAYING BESIDE ME ON THE FLOOR. AFTER CALLING TO SEE IF ANYONE ELSE WAS THERE, I CLIMBED OVER JUNK AND GOT TO THE WINDOW. FIREMEN GOT A LONG LADDER UP TO THE WINDOW WHICH WAS, OF COURSE, BLOWN OUT. THEY HELPED ME THROUGH THE WINDOW AND DOWN THE LADDER. MY OFFICE WAS ON THE FOURTH FLOOR AND I WAS A LITTLE SHAKEY. AFTER I GOT DOWN, A RED CROSS WORKER BANDAGED MY HANDS FOR ME BECAUSE THEY HAD SOME CUTS AND WERE BLEEDING. LATER AFTER NENE GOT ME HOME, YOUR DAD WAS ALL READY AT OUR HOUSE AND HE SEWED MY HAND UP WHERE THE WORST CUT WAS. MY HANDS ARE HEALING UP VERY WELL AND I AM OK. I DID TELL THE REPORTER THAT IT WAS "JUST BLIND DUMB LUCK" THAT I ESCAPED. SO MANY OTHERS DIDN'T. LOTS OF PEOPLE FROM ALL OVER THE UNITED STATES CAME TO HELP CLEAN UP AND THINGS ARE GOING TO BE OK.
