Hi Daniel----

Our phone chat yesterday was very exciting for me. You have a grasp of the vision we have for Allied Familie and I am grateful you are willing to be patient as the specifics unfold. I truly believe it is a new kind of venture that has great potential and especially where families enrolled trace back to the same area. The concept of "enrolling " families is a key element of the program but this is tied to other aspects such as enrolling family histo books, enrolling cemeteries, etc.. Also, it is critical to make use of the resources on the Internet such as Find A Grave, Fold 3, etc. It will be a happy day when we have illustrations of all of this actually underway.

On the money side it appears we will need to actually spend the first \$500 collected to enroll a family for ongoing expenses. Beyond \$500 it is my thought that all contributions would be put in a permanent support fund for the enrolled family and that when this fund reaches \$10,000 it would be a full fledged endowment to perpetually support the enrolled family.

Keep in mind that we hope for a UAFA repository/museum in Wake County, N. C. There I hope to place my family history records where they will be preserved and guarded but made readily accessible to the public. Long term you might want to consider this as an option for your collected materials.

Thanks for sharing your Family Tree with me. I have now created a folder to preserve such trees and another one came in last night. I will create a couple of trees as soon as my SIL Bob Heck comes over and use these to see how to create descendant charts. Your suggestion that you require "editor" status toe able to do this sounds right to me.

I'll attach a sketch of how contribution levels might be linked to UAFA inputs but bear in mind this is just a thin piece at this point and needs improvement and approval of the UAFA Board. I need to add enrolled cemeteries to the list of resources.

This is an exciting time for me and I hope 2014 will show great progress for UAFA. Thanks for your understanding and support.

This is to report to you that I have now fully processed the information on your grandfather and his descendants provided with your email of September 8, 2014, for which thanks again. All the details are fully locked into my system using the manual techniques I adopted many years ago. My march to the digital worlds continues but much continues as manual.

I would like to get more such printouts from you but first I would like to ask if there is a procedure for me to create outputs such as you sent on my own. I have often tried to do this upon reaching Public Trees online and even when I have a specific invite have not been able to do so. This is frustrating as I can often get the information by printing our the Public Tree page which features and individual showing their parents and spouses and children. Then by clicking on one of the children or one of the parents I get another page and so on. Even this is not quite a complete as the format you sent. So, do you know if there is a process for creating the format you sent and can you teach it to me? This is a frustration I have had for several years. If this is not feasible /possible, I will get back to you with a request for another segment of you family records. I note many Phillips workers on line but have accepted your versions as my safe haven as you are clearly a serious Phillips researcher.

While I suggest no action I wish to note that The Phillips, Pearce, Upchurch, and a couple of dozen other families all trace their heritage back to Dunn Township in Franklin County, N.C. Collectively we have uncovered or generated summaries that go far to tell the story of the area and its people for the 1750-1900 era. I have made dozens of trips to the area and have dug deeply as have you and others. The fruits of my labors are now in the Allied Families Research Center in Chesterfield ,MO. I know you and other researchers must have created similar treasure troves. A question now is how can we collectively do something so that all of our hard work is not lost to future generations For me a part of the answer lies in the program of work unfolding for our new organization UAFA of which you are a member.
