I have confirmed that she and her three siblings (XID-59140-59143) are incorrectly linked to XID-33487 rather than 33489. The error occurs in the printed version and in the on-line version on our website. Our webmaster, Jay Buck, and I conferred about this and he will make the corrections on the website. I have made the changes in my file copy of the printed edition.

It is highly important that our records be authentic. When we progress to our Ancestry.com Active Tree for the Harmon Upchurch Family we will have special focus on accuracy.
