Background: The above information was provided by Dr. House, in two letters, to me, dated 5 September 2000 and 24 October 2000.

Objective: Locate the will and estate papers for Rubert Vance McGee and other general information about him and his relatives.

Authorization: 6 hours for this segment of research, analysis and report writing.

Repository: North Carolina State Archives

Summary of Research:

Dr. House provided the information that Rubert McGee died in Fayetteville in 1942 during World War II. I first searched the NC State death certificate indexes for the years 1940-1947 and the will and estate records in Wake and Cumberland Counties but did not find any death records for Rubert. After further investigation I discovered that Rubert was honorably discharged from the Army on 17 September 1945 and died in a car accident in Chatham County, North Carolina on 22 July 1951. I also found the marriage records for Rubert V. McGee and Ernestine Upchurch in Wake County.

Research Results:

1. I searched the North Carolina Death Certificate Index 1940-1943¹ and 1944-1947² for Rubert, Robert and Vance McGee/McGhee under the soundex codes of M200 and M220. I did not find anyone indexed under those names for this time period.
2. I searched the Wake County Wills³ (original) through 1966 and did not find a will for Rubert, Robert or Vance McGee/McGhee.
3. I searched the Wake County Loose Estate Records⁴ through 1952 but did not find a file for Rubert, Robert or Vance McGee/McGhee.
4. I searched the Wake County devisor⁵ and devisee⁶ indexes for McGee and various spellings of the name. I found no entries for Rubert, Janet, Aurara or Ernestine McGee. *Comment: Devisor is the individual who is writing the will: the testator. Devisee is the heir.*

5. I searched the Wake County Index to Dowers 1804-1946⁷ but there was no entry for Aurara or Ernestine McGee. *Comment: Dower is the part of the husband's estate that the widow receives for her support.*
6. I searched the Wake County Grantor⁸ and Grantee⁹ Index to determine if Rubert bought or sold land or if his land was divided at his death. There were no entries for him in either index for the years 1932-1958, indicating he did not purchase or sell land in Wake County.
7. I searched the Wake County Marriage Register¹⁰ and found a marriage entry for Rubert McGee and Ernestine Upchurch on 26 Nov 1938. They were married in Raleigh by Forrest C. Feezor, a Baptist minister. The witnesses were Patty L. Upchurch, Mrs. E. H. Tilley and P.B. Perry. The bride and groom were both residents of Raleigh. The groom was 21 years old indicating he was born about 1917/1918 and the bride was 18 years old indicating she was born about 1919/1920. (Document #1)
8. After I found the marriage register entry I was able to find a copy of Rubert and Ernestine's marriage license¹¹. It looks as though the name giver for Rubert's father is A. McGee, (I believe the first initial is crossed out.) and he was living. Rubert's mother's name appears to be Mommie or Monnie McGee but it is unclear; she was also living. Ernestine's parents were R.J. and Bettie Upchurch and they were also still living. (Document #2)
9. I searched the Cumberland County Wills¹² (original) for McGee; there were none.
10. I also searched the Cumberland County Index to Wills 1796-1962¹³, devisor and devisee but there were no entries for McGee.
11. The Cumberland County Loose Estate Records¹⁴ available at the archives only went as far as 1930.
12. I searched the Cumberland County Index to Estates not exceeding \$300, 1930-1956¹⁵. There were no McGees in the index.
13. I also looked at the Cumberland County Accounts and Inventories of Estates 1945-1954¹⁶ and the Final Estate Accounts 1937-1955¹⁷ but these volumes were not indexed and would have taken a very long time to search so I did not search them.
14. I searched the Cumberland County Index to Deaths 1913-1947¹⁸ but did not find an entry for Rubert, Robert or Vance McGee.

15. I also searched the Raleigh, NC birth index¹⁹ for the years 1916-1917. I did not find an entry for Rubert McGee.
16. I then searched the General Index to Military Discharges²⁰ in Wake County and found an entry for Rubert V. McGee. His record²¹ (Document #3) indicates he was discharged 17 September 1945. I only had access to the discharge paper on microfilm. It was very faint and it is difficult to read the small print. Rubert's service record is available but because of federal privacy laws, I cannot access the file. Janet, however, can request a copy of the file and receive it at no charge. She needs to contact the Veteran's Service Office at 252-355-9052 and tell them she is Rubert's daughter, that Rubert was discharged from Wake County and that she would like a copy of her father's service record. (not the discharge papers which I am including here) The Veteran's office will contact the NC State Archives and they will send Janet a copy of the service record. I cannot tell you what will be in the service record because I don't know, but it may be very interesting for her to read. Rubert was a Sergeant and received several medals and awards.
17. I checked the NC Death Certificate Index for 1948-1951²² and found the entry for Rubert. Rubert's death certificate²³ (document #4) indicates he died 22 July 1951 in a car accident near Moncure, NC in Chatham County. The informant for the information on his death certificate was US Army Official Records from Ft. Bragg, NC. His death certificate does not indicate whether he was married, his usual residence was in Raleigh and an autopsy was performed.
18. I also checked the Chatham County Index to Devisors and Devisees 1916-1965²⁴ and the Chatham County Loose Estate Records²⁵ for Rubert, Ernestine, Aurora or Janet but there were no entries.
19. I did try to find Rubert and his family on the 1920 census index (soundex). The soundex is organized by similar sounding last names and then alphabetical by first name. I could not make out the first initial of his father's name on his marriage certificate but I searched under D, B,²⁶ F.²⁷ I did not find him and now I believe the initial may be an A. This will take further research.

It does not appear that Rubert left a will or loose estate record in Wake, Cumberland or Chatham Counties and he did not own land in Wake or Cumberland, unless he received it as a gift and it was not recorded in the deed books.

I did not have time left to do any further research but if you would like to continue I would recommend the following.

1. Search the Wake County Bound Estate Records for Rubert.
2. Search for an obituary and newspaper article about Rubert's car accident. The names of his parents and siblings may be given.
3. Obtain a copy of Rubert's birth certificate for the names of his parents.
4. Find his family on the 1920 census to determine the names of his siblings.
