Dear Mr. Upchurch:

I have your letter of September 6, 1968 concerning the family history.

I have glanced through some of my records, but can find no John Winton Upchurch in High Falls, North Carolina, however, I found a John Winston Upchurch in Wake County, North Carolina who was a grandson of Nathan Upchurch, who in turn was a brother of Moses Upchurch. I don't know whether this will help you or not.

Mr. Roy White of Houston, Texas spent an entire day in my office the early part of the year and it took him approximately fifteen hours to photostat the information I have on hand, which covers some several inches of files. You can understand from this that it would be somewhat expensive to have all of this copied, whereas it might be of no use whatever to you. In time to time, as the opportunity affords, I will search my records to see if I can find anything in connection with your grandfather or his parents.

In connection with C. E. Upchurch, I knew a Dr. C. E. Upchurch of Union City, Tennessee and had a letter from him two or three years ago. He was one of some five or six brothers, all of whom originated in Greene or Pickens County, Alabama. I knew him quite well. I have looked through the telephone directory of Atlanta and can find no C. E. Upchurch, although there are some twenty to twenty-five Upchurch's listed. Our people came to Alabama in about 1815 or 1816 from Wake County, North Carolina. At the present time I lack only one name in being able to tie our family into the North Carolina and Virginia line. For your information, the Virginia line originated at Jamestown, Virginia in 1642 and so far as we know, the first Upchurch was a Michael Upchurch who imigrated from England to America and apparently married the daughter of the Lt. Governor of the Virginia Company, whose name was Farrar. I have his line down to approximately the year 1785 or 1790, but as mentioned above, lack one name at about that time.

If there is anything further I can do to help you, please let me know.

Your letter arrived Monday and I am estatic over your speculation of my family line. I have spent the past two days searching through all my notes, etc. and could not find any new information that I haven't already sent you.

My oldest sister, who is 62 years of age, still maintains that my Great Grand Father was Kelly Upchurch but as I said before, she can not document it. Also as I reread the letters I received from Annie Upchurch back in the 1960's, the places she mentioned in which my ancestors lived, very much corresponds to the places you have mentioned in your letter of this week. I am enclosing one of her letters.

The "F Upchurch" on the death certificate still remains a mystery to me but perhaps you were right when you suggested that it could have very well been "F. Kelly Upchurch".

You wrote in your letter I received this week that Ruffin Upchurch's first wife was Elizabeth Kelley. However, on page 33 of Belle Lewter West's Upchurch Family, Ruffin's first wife is Williams and his second wife was Pasty Goodwin. This confuses me.

I do have a paper that Mrs. West sent me stating that Kelly Upchurch and Sara Jane Eason were married in Chatham County, N.C. on 19 Sep 1837 and William Goodwin was Bondsman at this marriage. I think I sent you a copy of this paper some time ago.

Do you have the names of the children, other than Caroline, from the Cumberland Co. N.C. Census in 1850 of Kelly Upchurch? Was John Winton, William Henry, George or Annie listed? There may have been others in this family but these are the only names I have so far.

I just feel that we are so close in putting the pieces together with your new speculation that I am just over-whelmed. I can never thank you enough for all your efforts and interest you have shown in my family line. I will contimue to keep searching and will send you any information that I may obtain.

Dear Phil,

Good news! Good news! I am really excited! Last night I spent down at the Merman Branch Genealogical Library here in Las Vegas searching the 1860 North Carolina Census Microfilm of Harnett County and I found my KELLY UPCHURCH!! I am enclosing the information that I copied from the microfilm for your files. I do believe that the John as shown on this microfilm is my Grandfather. All the names check out except the Julia, and I think that I can explain her name later on in this letter.

I kept studying the Upchurch Bulletin Missing Link No. 8 - Kelly Upchurch, Volume 3, Number 2, dated April 1982. It suddenly occurred to me that many of the names that appeared on the 1840 Cumberland County, NC census that you listed match the names that I found on the 1860 Harnett County Census that I saw last night, but the problem was in the spelling of the names. If you will take a look at this Missing Link of the Upchurch Bulletin now, I will explain:

Julia A. U - This is probably Julia Ann and they called her "Annie".

Julia appeared on the 1860 Census of Harnett County.

Geb. A. - This was a mis-reading. It should have been Geo. (for George) A. (He left N.C. with my Grandfather John for Georgia.)

Caroline U. - This is correct.

Aizabah & Isabella - The only names I cannot explain.

William Upchurch and John Upchurch did not appear on the list as they had not been born.

Earlier during the summer, I had searched the 1860 Census for Pitt County, N.C. There were no Upchurches listed at all.

I am enclosing notes that I took from your correspondence to me in regards to Kelly Upchurch and Ruffin Upchurch. I'm sure that you have all this information, but I tried to summarize the main points.

I am also enclosing a sheet of information that I found on Ben Upchurch as I searched the 1860 N.C. Census for Garnett County. This may help someone else who is searching like me.

Now my big question.... where do I go from here? I have been floating on Cloud 9 and had difficulty in even sleeping last night as a result of my find. I really do not know what my next step should be. Please advise me.

Thank you for all the help you have given me. I look forward to hearing from you again soon.

### RUFFIN UPCHURCH:

From the Ruffin Upchurch 1812 War Papers (submitted by the wife Martha Upchurch in her bid for a pension) we learn that Martha Goodwin (sometimes called Patsey) was his wife for 40 years beginning about 1825 and that she was his last wife until his death in 1866. We also learn that before Ruffin's marriage to Martha Goodwin, he was married to Elizabeth Kelley and that Elizabeth died young after she and Ruffin had several children. (Possibly Kelly Upchurch was one of these children.)

Whether Ruffin married before he married Elizabeth Kelley needs more documentation. The current evidence that his first wife was \_\_\_\_\_\_\_ Williams comes from an affadavit of Ora Upchurch (Mother of Belle West) in about 1950 and who was old and may have been relying on memory from word of mouth passed down over many decades.

- Your letter of 30 September is before me. It is always enjoyable to - hear from an Upchurch, even though we are a large and prolific family, - and that means that our relationships are far removed.

- I haven't proven the parentage of our first ancestor to come to America. There is quite a background of information from a few counties in England.

I am equipped to furnish a photostat of a letter written by our first ancestor to come to Virginia, back to his father in England, which merely salutes his father, "Loveing and Kinde Father my duty with my wifes humbly I senhed to you and to my Mother and alsoe our love to my Sister," Nowhere in the letter our outside is there any indication of his father's name. Also I have copies of my interpretation of his Old English type of writing. These two items I am furnishing for \$4.

It is possible that you may be able to read Old English and would have fun doing so. In that case you would not want my interpretation. The photostat had to be made from one which was shipped to me from the West Coast and back to her by registered mail. Price of photostat \$2.50.

A+AThe name CALVIN rang a bell. One Calvin was married on Sept. 21, 1865, in Henry County, Ga. to Mary Daniel. Backtracking some one Calvin showed in the census of Franklin Co., N. C. for 1840 with eight in his family. It has been said that several nephews with with Charles Upchurch, Prevolutionary man, to Henry County, Ga. when Charles was granted land in henry Co. for his service in the Revolution.

Dacktracking again I have just found Calvin Upchurch in Index of Deeds - of Franklin County, N. C. as early as 1829. He was active buying and - selling.

Some years ago my husband and I were travelling in Tenn. and were led A to get in touch with a Dentist, Dr. Calvin Edgar Upchurch of Union City. A Ho said his father was Calvin b 1828, I failed to get the place of A his father's birth. His Mother was Sarah Jane Childress, born 1838. A The dentist has a daughter Lula Janette Upchurch who married T. T. King A and this daughter has a son Thomas Calvin Upchurch.

The dentist is likely deceased before now, but probably you could find from some source in Union City, Tenn. something about this family of Valvin Edgar Upchurch. He thought his grandfather was Bartlett Upchurch but knew nothing more about him. Bartlett Upchurches are prevalent in North Carolina records.

There is so much information on Upchurches in North Carolina I have been forced to narrow my searching to my own immediate line. In doing this I have not pursued the dozens of lines into vraious other counties. The above  $\frac{Calvins}{Calvins}$  seem to be the extent of information I have on this name.

Dear Phil,

It has been a long time since I have corresponded with you. Much has happened since then... beginning with my retirement in September 1990. I decided that after thirty-five years of teaching, it was time to call it "quits"! However, I still do some occasional substitute teaching today.

For years, I have been meaning to put my family line, beginning with Kelly Upchurch (XID 22540) in some sort of order. Being that I have more time on my hands now, I began to make out the attached outline. I used The Register of American Ancestors, UB, Vol 10, Number 2, as the basis for my outline. However, I added a lot of names, in my immediate family line, that were not in the family register, thus they do not have XID numbers.

As you can readily see, of the seven children of Sara Jane Eason and Kelly Upchurch, detailed information is given on four (Julia Ann, George A., William Henry, and John Winton). There is only a listing of names for the remaining three children (Isabella, Elizabeth, Caroline). I do not know if you have received any additional information on these last three.

In rereading several of your past letters, you mentioned that you did not have any direct on-going contact with members of this particular family line. Although you did say that as far as you knew in 1987, Annie Ruth (KID 22667) → Upchurch in Highfalls, N.C. was still living. At one time, she was most helpful and interested in our family line. However, she did not respond to a letter I had written her a year or so ago. I have no idea as to why she didn't.

> It was from Vickie Marie Barefoot that we received documents giving us conclusive proof that Kelly Upchurch was a son of Ruffin Upchurch. I wonder if she would have additional information on Kelly's three children on which we have only very limited information?

I will keep working on this end to make this family line as complete as possible. In the meantime, you are free to use any of the information in this outline as you would like.

It is WONDERFUL to be able to connect all of my lines, now, back to Moses (Ruffin U., Kelly U., John Winton U. Sr., John Winton U. Jr.) Without your help, I could have never done it. Thank you, again.

Dear Phil.

I am long overdue in thanking you for the telephone call last month telling me of the wonderful research Mrs. Scott Warren Gersh has been doing and of her breakthrough in finding positive evidence that Kelly Upchurch is definitely a son of Ruffin Upchurch. I was absolutely thrilled as was every member of my family! That was the one missing link to my line of heritage.

Thank you also for the wonderful Upchurch Bulletin of April 1989 (Volume 10, Number 2). I know that I have read and reread it at least a dozen times. I took the information you had recorded for the Moses/Ruffin Clan and Subclan in the Register of American Ancestors and plotted out family trees. It was done with much excitement.

In October and November of 1968 I was corresponding with a Miss Annie Ruth Upchurch, Box 62, Highfalls, N.C. 27259. Her grandfather was William Henry Upchurch. In her letter, she referred to Roland H. Upchurch of Highfalls, N.C. and Frank H. Upchurch of Robbins, N.C. as our uncles. At the time, she seemed quite interested in tracing our particular line, but somehow or other we stopped corresponding. tried to ressume correspondence ten years or so later, but there was no reply. I have no idea which one of William Henry Upchurch's seven sons would be her father. She did not say. My question to you is: Have you had any correspondence from any of the descendants from this particular family line?

Dear Phil,

Your letter was waiting for me upon our arrival home from our summer vacation in the Pacific Northwest. Thank you for all the time you spent in putting all the pieces of information together for me. I feel so helpless when I cannot offer you more bits and pieces to go on. However, I have done some work this summer which I will give in detail later on in this letter, but first to answer the questions in your letter and respond to your speculations.

- 1. I was elated when I read the material on Ruffin Upchurch which appeared in UB, Vol 5, No. 2. You did a beautiful job of putting all the information together that related to Ruffin. I am so glad that you included your speculations along with the facts.
- 2. In reference to the Charles Kelly Upchurch Jr. in Greensboro, N.C... There may be a connection between his family and mine. My father had a brother named James Franklin Upchurch, who had a son named Charles Jack Upchurch
- 3. About the name Winton... I had never heard that name before other than my Grandfather, John Winton U., who named my father, John Winton Jr. However my Dad changed his named (unofficially) at about the age of 12 to Julian Winton. He changed his name (according to my mother) because there was another man in town at that time with the name of John who had a notorious reputation throughout the area and my Dad did not like having the same name as this unsavory character.
- 4. I read through all the material that Byington sent you and did not see anything new on my family line. I was so in hopes that she would be able to make the connection of Kelly to Ruffin. I still feel that we will find it in time. Positive thinking!

During the summer, the attempts I made to connect Kelly Upchurch to Ruffin Upchurch are as follows:

- 1. I wrote the Clerk of Superior Court of Cumberland County Courthouse in Fayetteville, N.C. asking for them to check their indexes and send me a listing of any will or deed for the Upchurch surname for the period 1830-1870. Their reply was, "No record of wills."
- 2. I also wrote the Clerk of Superior Court, Harnett County, Lillington, N.C. for the same information. They wrote that they did not have any names for that period of time due to the courthouse burning in 1892 the last time.
- 3. I ordered a film from the Geneological Library here on Probate Records Administrator's Records 1857-1868, Cumberland County, N.C. The film has not come in yet. I just called the library and they are trying to find out what happened to the order.

I have ordered from National Archives and Records Services the entire Pension Records file on Ruffin Upchurch from the War 1812 requested by Martha Goodwin, his second wife. I know that you already have this information but I thought maybe I would detect something extra when looking through the entire file. I should have this information within the week as they have already notified me they have located the file and for me to send the search fee, which I did.

Thank you again for all the help that you have given me over the years. Any further suggestions for searching my line, which you may have, would be appreciated.
