

ACRIL L. UPCHURCH XID-84

Commentary: Acril L. Upchurch was born 1805 in Green Level, Wake County, NC and died 1860 in Tipton County, Tennessee. He was the son of Nathan Upchurch I, head of Upchurch Clan #3. Acril married Mary Olive in Wake County in 1833 thus linking the Upchurches to the prominent Olive Family of Western Wake County. Using his inheritance following the death of his father in 1835, he migrated to Tipton County, TN where he resided a family. We are yet to learn the circumstances that led to his move – a topic for research.

Margaret Loyce (McFarland) Alket was a descendant of Acril Upchurch who gained DAR membership based on her relationship to Acril. We have a few snippets of her research and more can be uncovered. As of the 1970s, she had become unresponsive to family inquiries.

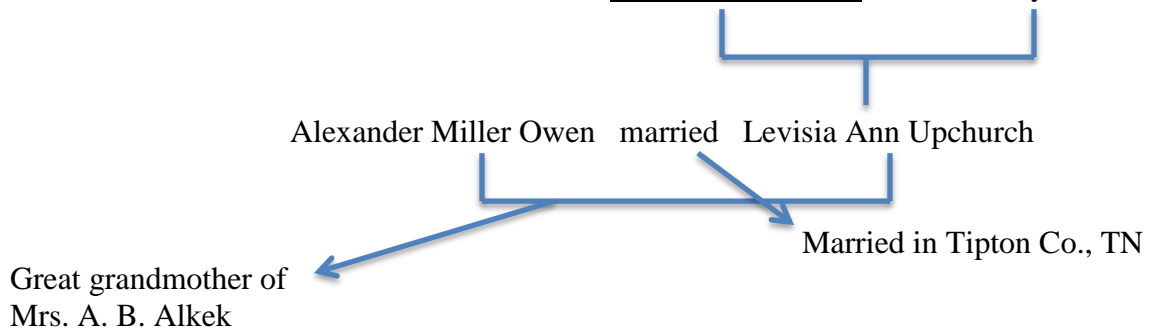
The circumstances of the marriage and movement of Acril to TN provide numerous insights into the record of the Nathan Upchurch I family and more research on Acril should be rewarding.

ACRIL UPCHURCH FAMILY

Among the sons of Richard Upchurch was Nathan Upchurch→[Nathan Upchurch, I]. His service in the Revolution was confirmed and a pension granted. Nathan made his will dated 2-26-1835 naming his four sons: Burtis, Gilbert, Acril and Hubbard. One son, Nathan, had preceded him in death. Acril L. Upchurch, son of Nathan, was born 1805 in Wake Co. NC and died Feb. 1860 in Tipton Co. TN. He was married 3-30-1833 to Mary Olive born 1813 NC daughter of Howell and Sally (Barker) Olive. Mary died in Fayette Co. TN before 1850. Their children:

This indenture made the fourteenth day of January 1842 between William Ward Agent for Acril Upchurch and Mary his wife of first part and Green Beckwith of the second part, all of the county of Wake and State of North Carolina. Witnesseth that the said William Ward for and in consideration of the sum of fifty-five dollars has bargained by these presents doth grant, bargain, sell and deliver said Green Beckwith his heirs and assigns forever a certain tract of land lying and being in the county and state aforesaid:

Beginning at pine—Green Beckwith's line post one hundred seventy one-half poles to a stake then South one hundred ninety-four one-half poles to a pine, then East one hundred seventeen one-half poles to a pine in the line of ??? Utley ??? thence North one hundred ninety-four one-half poles to the beginning continuing one hundred forty-two acres.....same more or up.....with all the apparentness therewith belonging.....in any will apparenting and do hereby and covenant to and with the said Green Beckwith his heirs and assigns.....before the execution of this land full rightand.....to sell said land and premises and agree hereby the warrant and forever defend the right and title of the same to him the said Green Beckwith his heirs and assigns forever. A witness whereof I have.....set my hand and seal this day and year above written.
