
Kisar Alford

Abstracts of Vital Records from Raleigh, NC Newspapers for 1841

In Franklin Co, NC on the 7th inst [7 Jan 1841] Mr <u>**K Alford**</u> married Miss Martha Upchurch. [From Raleigh Register Semi-weekly Newspaper]
