I have looked in my list of UPCHURCHes and do not see any of these names mentioned. I will, of course, send her to you so that she can send you her information and you two can compare notes.

You are correct in saying that William Franklin is UNCLE to Joseph Martin, sorry for the error. As for Mary Jane being the same person as Mary Jane (WOODS/YORK), the 1900 Census says that Ruben and Mary Jane had been married for 21 years — which would be correct, as their 22 anniversary was later that same year — November, to be precise. So, I think that this also proves that we are talking about 1 Mary Jane and not 2. Because of the knee-thingy, I haven't pursued the U.B. being placed at any of the local libraries. I promise to get on this just as soon as I am physically able.:)

Thank you for the John ROGERS genealogy pages. I am wondering if this Aaron ROGERS mentioned on the last page, might not be my Aaron. I am sending to NC for copies of a will that mention an Aaron. However, the parental name is Thomas, not Joseph. I got this information from the LDS, so it may not be correct. I will have to get the copy and read it and hope that it mentions a wife to Aaron. I might see about getting a copy of the will of Joseph ROGERS and see if anything matches...you never know, do you? Coincidentally, these ROGERS moved to GA with the son named Drury so they may be kin to Kathy Cobb...perhaps? Nothing is ever certain until we have proof, is it? <G>

Yes, the given names of Ruben's parents do appear to be wrong. This is probably an honest mistake of the family enumerator. I have been told by others, that information given on a death certificate is often suspect, as the people are in a harried state and do not always get the names correct. Because of the information found in the census, I believe Ruben's parents to be named Aaron and Nancy Ann...that is, until I find information to the contrary! <G>

Well, I can't contribute much more to this conversation, so I shall close now and go and take a pain pill. The knee is beginning to swell up along the bottom edge and it's very painful to stand on. I shall, of course, forward the Michael Enterprises address to Ray and Kathy Cobb in GA. Let me know if she writes to you. Dear Cousin Phil:

Hello there! Yes, I had a wonderful time and truly enjoyed our chat while you were here in our fair city! It is, indeed, always good to meet the face at the other side of the name.

I have taken steps to become a certified genealogist - I mailed a request to BYU checking into their genealogy program...figured I might as well go to the source to get where I want to go! I have never really considered myself to be a detail oriented person, but I am finding that I rather enjoy ferreting out the little details that make a name on paper into a living, breathing, human being.

With regard to the UPCHURCH family bulletins, I will check into Sutro Library and see what they have for the family. I recall seeing a few - very few - UPCHURCH items. With regards to your "stipulations" about cataloguing them, etc., I know that they will do precisely this and enjoy receiving them, as well. Sutro is a Sutro is a state run facility, and as you may know, the state is rapidly going broke, so any gifts would definitely be appreciated. binding them, I have seen where they have taken older issues of other research materials and either put them together in loose-leaf notebooks, or into safe portfolios. This is how I located some of my BAILEY information. The ITAWAMBA SETTLER magazines had been put into a case and were remarkably well cared for. I am donating all of my Arizona Genealogy newsletters to Sutro - after I read them, and if there is nothing in them that is pertinent to me. I plan on doing the same thing with my ITAWAMBA SETTLER's. But, let me talk with Mr. Glover and see what his opinion on this might be. Glover is the chief, or co-chief, librarian at Sutro. There is another rather nice library within a library. The Santa Clara County library system has a lovely facility on Homestead in Santa Clara that happens to have a separate room devoted to genealogy. I have been there a few times, and plan on going back again soon. While I am there, I will talk with the librarians and also check to see what they have regarding UPCHURCHs.

Regarding Great-Grandma ROGERS... I am beginning to suspect that Mary Jane YORK and Mary Jane ROGERS are actually the same person. I am have been talking with Lois York Hamilton and Wally Garchow, both are YORK researchers. Lois used to write a YORK newsletter from Idaho...Anyway in the 1860 Census, Pleasant Andrew YORK and his wife are enumerated in different, but near, households. Included in Pleasant's direct household are Martha (18), Infant (6/12 and unnamed) and 2 other children. Lois espoused the theory

COPIED FOR LIBRANT FILE that Infant 6/12 is actually the child of Martha, because unlike the other children, she is not enumerated in order of age, but directly under Martha's name - lending itself to the thought that she was, perhaps, illegitimate. In the 1870 Polk County Census, Benton Township, dated June, 1870...we have John T. WOODS, (28), Martha C. (28), Mary J. (10) and Dartha (sic) (03). Moving forward to the 1880 Census, we move to Washington Township, Boone County, dated 11 June 1880.. We have John WOODS (39), Martha (39), Dolla (sic) (12), Nancy (9), Priscilla (7), Easter T. (05), Rosa E. (03) and lastly, Joseph B. (11/12). We also have in Sulphur Springs Township, Boone County, we have Ruben C. (25), Mary J. (19) and Fanney (8/12) with Mary Barbara YORK enumerated, incorrectly, with the COOPER family. Sooooooo, I think all of this leads me to believe that Mary Jane YORK and Mary Jane WOODS are one and the same person. Now proving this will be much more difficult, and I hope not impossible!

I am going to put the Safford information on a separate sheet so that you my refer to it more easily.

Thank you for your help in this search.

FANNIE LUEUM ROGERS & WILLIAM BOOKER BAILEY

BAILEY/ROGERS SHORT HISTORY

D→A The William Booker BAILEY and Ruben Capers ROGERS families arrived—in Safford, Graham County, AZ around the turn of the century. Both—families had been in Sweetwater, Nolan County, TX prior to their—arrival in Arizona.

 $\triangle + \triangle$ Fannie Luella ROGERS met and married William Booker BAILEY in Sweetwater, Nolan County, in 1896. On 03 Jan 1897, Mary Leona $\triangle + \triangle$ ROGERS was born to Mary Jane and Ruben ROGERS. The first child of $\triangle + \triangle$ Fannie and William was born on 05 Dec 1998 and he was given the mame of William Lafayette BAILEY.

It is believed, by birth dates, that these two families then moved to the Safford/Solomon(ville)/San Jose area of Graham County. The △ + △ last child of Mary Jane and Ruben ROGERS was born on 29 Jul 1900 and was given the name of Franklin William ROGERS. Meantime, □ Frank's (as I believe he was later called) first cousin, Martin △ + △ Joseph BAILEY had been born to Fannie and William the month before — on 23 Jun 1900.

— The 1900 Census shows that the BAILEY's and the ROGERS' lived next — door to one another. The ROGERS' were in household 245 and the BAILEY's 246.

☐ It is known that William Booker BAILEY died in 1907. I do not have — a precise date of death, nor do I have a location of the burial. ☐ In the 1910 Census, Fannie Luella ROGERS BAILEY is shown as the — Head of Household and as a washerwoman. It is also known that ☐ + ☐ William Booker's brother, Samuel H. BAILEY was married to Fannie's ☐ sister, Florence Virginia ROGERS. Where this marriage took place, — or was dissolved is unknown. It was dissolved because after the ☐ the ☐ death of William, Fannie married Samuel (certificate of marriage is ☐ in my possession, and at the Graham County Court House). Sam and ☐ the ☐ Fannie had a daughter, Alice Leora, born on 7 Sep 1908. Sadly, Sam ☐ flew the coup leaving Fannie to rear her children alone -- or with ☐ the support of her parents. In any case, Fannie was left to fend — for herself and her children by the death of one husband, and the — desertion of another.

□ +△ According to my Aunt Cora (BAILEY), Great-Grandma Fannie took in a — couple of Spanish/Mexican children named Bustamentos (spelling is — not correct). The family was fluent in Spanish. Also, according +△ to Aunt Cora, my Grandmother, Rena Luella BAILEY, was given to — running off and staying lost for a spell, without telling anyone △+△ where she went or whom she was with. Apparently during one of △+△ these escapades, she met my Grandfather, James NAVARRETTE and they — married. Where they married, is a mystery, and one I would like to uncover. Where they divorced is another mystery, but I suspect △ that they may have -- or Grandpa may have -- divorced in Tucson. +△ My step-Grandmother, Luisa Valdez NAVARRETTE, says that James and △+△+ △ Rena were never married. However, James and Rena had four children □+□+□together: Cora June, George James, Benjamin Martin and Rose Mary.

A The last, Rose Mary, died 9 days after her birth and is buried in Bowie, Arizona at the Desert Rest Cemetery. I do not know what the legal aspect of common law marriages was in Arizona in the 1920's, $\triangle + \triangle$ but I suspect that they were truly married. Grandpa was a Catholic, △ Grandma was not, so maybe they were married by a JP somewhere. Í □ know that my father, George James, was born in Dos Cavasas (spelling is approximate). Perhaps they were married down there, \neg or in one of the other nearby small mining towns. Then again, \neg perhaps they were married by a circuit court judge and the record $\triangle+\Box$ of that could be anywhere! Grandpa NAVARRETTE married Luisa Valdez in the Catholic Church after the desertion by Rena of the family. △ This is a long and involved story, but apparently Grandma was able \square to find love a second time, because she married a Julio MONTANO in Albuquerque and had 4 more children (3 boys and a girl). Julio looks remarkably Interestingly enough, D Grandfather!

 \Box $+\triangle$ So, there you have it. I believe that Aunt Cora said that William \triangle Booker died in San Jose, so he may be buried there - somewhere. \triangle $+\triangle+\triangle$ Fannie Luella ROGERS BAILEY, Mary Jane YORK ROGERS and Ruben Capers — ROGERS are all buried in Phoenix, Arizona. In summary, here are — the items for which I am looking:

- △ 1. Death certificate or obituary of William Booker BAILEY
- $\triangle + \triangle$ 2. Marriage certificate of Rena Luella BAILEY and James NAVARRETTE
 - Not too much, but more than I can locate on my own.

I love the way they change the names and spellings! Anyway, are you able to shed any light what's so ever on my UPCHURCH? If you wish, I could send you a copy of Ruben's death certificate. Also, he died in Phoenix and is buried at Forest Lawn.

Oddly enough, the 1880 Census for Searcy County, Arkansas, says that he, his mother and his father were all born in NC. He had moved to Arkansas by late 1878/79 (maybe much earlier, I haven't been able to locate him/them yet) and married Mary Jane YORK and had a daughter, Fannie Luella ROGERS.

In a book called: Rutherford County North Carolina - Wills Abstracts 1779-1910 there is mentioned an Elias UPCHURCH, 22 July 1844, Summer 1844. Wife Ann, All my Children, minors. EXEC. wife, John Tomerlaen. Wit. J.M. Webb, Moses Logan. E-133... Sarah could have been one of the minor children...

So, as you can see, I am rather bereft of evidence that Allen ROGERS and Sarah UPCHURCH are actually Ruben Capers ROGERS' parents!

Anything you might be able to do to clear this up, would be most welcome! Thank you for your time and efforts. And, in case you are wondering, I found your name and address through GEnie and their "U" category. Once again, thank you!

Dear Cousin Phil:

Hi there!! How are you these days? I'll wager that you thought I had forgotten all about you, didn't you? Actually, I have been lazy and simply not gotten around to having the wills photocopied. My daughter was working downtown, so she did all of my banking and mailed all of my letters! Now that she isn't currently working downtown, I have to do all of this for myself! Sheesh..:)

Anyway, here are the two wills that I promised you: Thomas ROGERS, date 1856 and Howell UPCHURCH, dated 1846. Howell mentions Nancy Ann by name within the will, then in a codicil, dated 24 February 1844, he renames her but calls her Nancy ROGERS. So, this means that Nancy and Aaron married sometime between 23 Nov 1843 (date of original will) and 24 February 1844. Howell also mentions a number of his other children in the will.

Thomas ROGERS' will mentions a son named Aaron, but I do not know if this is "our" Aaron ROGERS or another one. His siblings are also listed within the will, but I don't recognize any of their names - as Aaron did not (apparently) name any of his children for his siblings or parents. I find that Thomas ROGERS' will is very difficult to read. It must have been the last will that the scribe wrote that day and he was very tired, or his ink was of a very poor quality. In any case, if you can manage to "translate" these wills into modern day language, I would be forever grateful. Howell's is none to easy to read either. The ROGERS children had some pretty interesting names: Richard, Rushing, Russel, Shepperd. Aaron, Calvin, James M., Jason, Comedove (is what it "looks" like), Thomas P.

I wonder who Robinson ROGERS was, and what did he do to deserve only \$1 as a bequest? The will states that Thomas had paid a number of debts on previous occasions.. ummmm...

Also, the daughters are named as whom the married! This is helpful, too bad he didn't do the same for his sons! Anyway, Roda married an Arthur SIKES, and Winny married Isaac ELIOTT.


Now, onto the UPCHURCH will -- I do see where one might think that he had named a daughter Lariah, but I think



the L is actually an S. If you look to the bottom of the first page, he does not mention a Lariah..but does mention: Cely, Nancy, Martha, Sarah and my son, Wm. Riley - no Lariah... So, I am of the opinion that there was no Lariah, just a Sarah who got special mention and a separate bequest - the same as is true for Nancy after her marriage to Aaron ROGERS.






