**(2)** Note: RPU research in Aug 2011 reveals that Mrs. S. L. McElroy, the informant, is the sister of the deceased, nee Sarah Elizabeth Upchurch, wife of George F. McElroy. The “L” in SEU [Mrs. S. L. McElroy] probably comes from her nickname “Lizzie.” – 20 Aug 2011
