Coach Brogden dies at 90

He was known by the simple nickname "Coach."

Leon Brogden Sr., one of Wilmington's best-known and best-loved sports figures, died at age 90 on Sunday after an extended illness.

Mr. Brogden coached at New Hanover High School from 1946 to 1967. He led 55 championship teams in football, basketball and baseball during his career.

In 1988, Mr. Brogden was picked by North Carolina high school administrators, athletic directors and coaches as the man who had contributed the most to high school athletics in the state. That same year, he was elected to the North Carolina Sports Hall of Fame.

"I think so many times we talk about how this guy was great and that guy was great. Coach Brogden was the true measure of greatness," said Joe Miller, New Hanover County athletics director. "We'll never find another guy like him."

Mr. Brogden hired Mr. Miller as a coach 27 years ago.

"It's a sad day. I'm really happy that he's not suffering anymore, but it's just that he will be sorely missed. You don't replace people like that," Mr. Miller said Sunday. "There will be a void there."

Mr. Brogden coached two of the most famous football players to come from Wilmington, Sonny Jurgensen and Roman Gabriel.

Mr. Jurgensen, a former New Hanover great and NFL Hall of Fame quarterback, said of Mr. Brogden in late 1999, "The best thing we had going was the coaches we got. (Leon Brogden) was a great coach. He left nothing to chance."

"Coach Brogden was the best coach I ever played for," said Mr. Gabriel, also a New Hanover standout and former NFL quarterback.

Bill Brooks, the longtime University of North Carolina at Wilmington athletics director and baseball coach, played and worked for Mr. Brogden.

"He was almost like a second daddy to me," said Mr. Brooks in a 1999 interview. "He made it possible for me to come here. He is a great man."

Mr. Brogden's name is well known even to those who aren't familiar with the coach himself. Brogden Hall, the basketball arena at New Hanover High School, is named for him, as is the annual holiday high school basketball tournament played at UNC-Wilmington.

Born Aug. 26, 1910 in Wake County, Mr. Brogden began his coaching career at Edenton in 1936. He accepted a coaching job at Wilson before taking over at New Hanover.

His basketball record at New Hanover was 325-80.

Funeral services will be held at 11 a.m. Tuesday at First Baptist Church.

LEON L. BROGDEN SR.

Leon L. Brogden Sr. of Wilmington, NC died Sunday, October 1, 2000 at the Lower Cape Fear Hospice Care Center.

He was born August 26, 1910 in Wake County, NC, the son of the late Ennis Webb Brogden and Minnie Ray Brogden.

Coach Brogden attended Wake Forest College and graduated with a Bachelor of Science in Medicine in 1932. He began his coaching career in 1935 in Edenton. One year later he took over the coaching duties in Wilson. After a successful nine year stint in Wilson, Coach Brogden moved to New Hanover High School in Wilmington. Through his forty years of coaching, Coach Brogden was associated with more than fifty-five championships.

Due to the recognition these successes generated, Brogden was the first high school coach to be selected to the North Carolina Sports Hall of Fame. Additionally, he was selected to the Wake Forest Sports Hall of Fame and the North Carolina High School Athletic Association Hall of Fame. He retired as Athletic Director of the New Hanover County School System in 1976. In 1988, Brogden was picked by North Carolina high school administrators, athletic directors, and coaches, as the man who has contributed the most to high school athletics in the state.

"It's a sad day. I'm really happy that he's not suffering anymore, but it's just that he will be sorely missed. You don't replace people like that," Mr. Miller said Sunday. "There will be a void there."

Mr. Brogden coached two of the most famous football players to come from Wilmington, Sonny Jurgensen and Roman Gabriel.

Mr. Jurgensen, a former New Hanover great and NFL Hall of Fame quarterback, said of Mr. Brogden in late 1999, "The best thing we had going was the coaches we got. (Leon Brogden) was a great coach. He left nothing to chance."

"Coach Brogden was the best coach I ever played for," said Mr. Gabriel, also a New Hanover standout and former NFL quarterback.

Bill Brooks, the longtime University of North Carolina at Wilmington athletics director and baseball coach, played and worked for Mr. Brogden.

"He was almost like a second daddy to me," said Mr. Brooks in a 1999 interview. "He made it possible for me to come here. He is a great man."
