

The note below deals with the John Bunn Section of Vol 1. A careful look at the 75 pages of this section reveals only two Upchurch notations. One on Page 2 where Williford Upchurch (son of Janes Upchurch, VII and grandson of Richard Upchurch, III) fathers a child by Gilly Bunn, granddaughter of John Bunn and on Page 60 where the will of Jesse Bunn, son of John Bunn in 1816 shows Abel Upchurch, Sr owes the late Jesse \$50.

More study is likely to reveal more Upchurch connections for the John Bunn Family – probably from descendants of female Upchurches – RPU 12 Mar 2010. [Note: names included William Bunn, James Bunn, Jacob Bunn, Owen Bunn, David Bunn, John Bunn, Isaac Vick, Odam Bunn – CJM 15 Nov 2020]

A Note to Readers

The father of John Bunn is unknown. There is documentation available in courthouse records in the counties of Northampton and Wake, North Carolina that tend to indicate that John's father might have been William Burn/Bunn who resided in Northampton County. William had six sons and one daughter. The names of his sons were William, James, Jacob, Owen, David, and John. The name of his daughter is unknown. She married Isaac Vick.

Land records in Northampton County pertaining to William's son, John, ended abruptly in 1778. That was the same year that the John Bunn, residing in Wake County, entered a land grant for three hundred acres of land in that county. Apparently John did not receive that grant for documentation showing that the grant had been issued could not be found in the North Carolina Archives in Raleigh. However, John initiated another request for a grant that was entered on May 27, 1779. He received that grant on September 30, 1785. Could it be that the John residing in Wake County was the same as the one residing in Northampton County? The land received by John in the grant is located in southeastern Wake County, on the eastern side of SR 2308 between the community of Hopkins and Moccasin Creek.



Land records in Northampton County for another of William's son, David, ceased shortly after that of his brother John. David sold two hundred acres of land in Northampton County in 1781. That same year the name David Bunn appears on the Tax List for Wake County with acreage tax shown to be two hundred acres. Could this be the David from Northampton County and the brother of John Bunn. Odam Bunn, son of the Northampton County David Bunn, also left that county around 1790, and his name appears on the Wake County Tax List for the year 1792. Did Odam follow his father to Wake County?

Although documentation to prove that John and David living in Wake were the same as the John and David residing in Northampton has not been found, one could very well come to that conclusion after carefully reviewing all of the information available in those counties. If it can be proven that John Bunn residing in Wake County was the son of William in Northampton County, then John would be a direct descendant of the Owen Bunn/Burn/Burne mentioned in the Introduction who resided in Isle of Wight County, Virginia.

In the March 1779 Minutes, Wake County Court of Pleas and Quarters, John Burn/Burn covey land to his son Desse Burn/Burn. Land records pertaining to that transaction could not be found. However, at the division of Jesse's land at his death, some of the land shown on the division map, when plotted onto a topographical map, overlays the two hundred and seventy acrea land grant that John received. So, it appears that the land received by John in the grant was that mentioned in the minutes that was conveyed to Jesse.

A Note to Readers

David Bunn was a very popular name in North Carolina during latter part of the eighteenth century and the early part of the nineteenth century. Those researching that particular name must be extremely careful to insure that documentation gathered and compiled pertaining to that name is assigned to the proper individual.

This section pertains to the David Bunn who resided in Franklin County. David was a farmer and owned over six hundred acres of land in that county. The names of his wife or his parents are unknown. A marriage bond was issued to a David Bunn and Polly May on December 31, 1829 in Franklin County. Documentation to prove that Polly was the wife of the David about whom this section is written, has not yet been discovered.

It is felt that the above mentioned David was somehow related to David Bunn and his wife, Lucy Bunn, who lived in Northampton County, North Carolina between 1750 and 1781. David sold two hundred acres of land in that county to his nephew, Henry Bunn in 1781. Shortly thereafter, records in that county pertaining to that particular David ceased. In 1787, his son, Odam Bunn, sold one hundred acres of land in Northampton County. Records in that county pertaining to Odam also ceased shortly thereafter.

The 1781 Tax List for Wake County, North Carolina indicates that an individual named David Bunn owned two hundred acres of land in that county. Odam Bunn's name also appears a few years later on the tax list for that county. Although unproven, those two individuals appear to be the same ones who were residing in Northampton County earlier.

The 1850 census for the Dunn District of Franklin County lists David and members of his family. His wife's name does not appear on the list. Please note that his daughter's name was Lucy. Was she named after her mother? Also, David had a brother named John. David named one of his sons John. Was that son named after his brother?

David, of Franklin County, died prior to November of 1858. A Court of Equity notice in the November 6, 1858 issue of the *American Eagle* newspaper, Louisburg, Franklin County, North Carolina, mentions the sale of land belonging to heirs of David Bunn, deceased.

On 25 Dec 2014 Danny responded:

Reference the various spellings of Odum's name, I am pretty sure that all that you have mentioned pertains to the same individual. In addition, his name appears as Woodam Ben in the 1820 census for Rowan County, NC. Attached is some information pertaining to Odum.

The Mary that was living with Elias Bunn was Mary "Polly" Wrenn. She was mentioned in the will of her mother, Elizabeth Wrenn. Her Franklin County will was dated 18 May 1837. A brother named Elias was also mentioned in the will. A Marriage Bonds in Franklin County, dated 7 Jul 1813, indicates that Mary was the wife of Green Walker Bunn, the person for whom the town of Bunn was named. Mary and Green had a son named Elias (probably after her brother). That is who she was living with at the time of the 1880 census. Green Walker Bunn died In October of 1851.

It appears that Odum was married 5 times. In addition to Mary, her was married to Lucy Bell (19 Feb 1816), Wake Co., NC; and Elizabeth "Ezbell Myers (14 Mar 1822), Rowan Co., NC. Attached is some information pertaining to Odum. That beginning at paragraph 7 was taken from his 1812 pension file.

Notes

Deed Book 5, page 296 of Northampton Co., NC, reads "William Bur-Burn, 200 acres after his fathers decease... plantation whereon my soil

Burn, 200 acres after his fathers decease.. plantation whereon my son David Burn now lives.. said land on both sides of Murfree Road in Co. of Northampton, 3 Dec 1773. Jun. Ct. 1774." It appears that Odum received that land for on 3 Dec 1787, he conveyed 100 acres to William Allen (Deed Book 8, page 223), and on 7 Jan 1790 he conveyed another 100 acres to Joel Pope (Deed Book 8, page 206). It also appears that Odum left Northampton Co. at about that time and moved to Wake Co., NC.

Information on page ___, Franklin County, NC, Inventories, 1789-1800, indicates that Odom was present at an estate sale of Jame Pince on 24 Mar 1794. Further, he is listed in the Tax List for that county in the years 1792, 1793, 1794, 1802, 1805, and 1809. He is also shown in the 1800 census for that county with three male under the age of 10 and one male between 10 and 16.

On March 20, 1814, Odom Bunn was enlisted as a Private in the 10th Infantry of U. S. Army at White Plains, Wake Co., NC by Lieut. Fox. for a period of 5 years. Enlistment papers reads as follows:

"Height: 5' 8"; Eyes: Grey; Hair: Dark; Complection dark; Age: 50; Occupation: Ship Joiner; Where Born: Northampton, NC. Remarks: R. R. Wilkesborough, April 30, 1814 D. R. Capt. Geo. Strother's Co. Feby 16, 1815, Present - J. R. & M. R. Capt H. H. Villard's Det. Fort Washington, July 31, 1815. Discharged at Fort Washington May 25, 1815 for inability Mo. Ret of Capt Jas Reeds Co. U. S. Arty Ft. Washington, May 30, 1815. Also reports him discharged May 25, 1815 for disability - See Pension Cases."

On 18 Feb 1818, he received 160 acres of land in the state of Illinois Public Domain Land Tract Sale for his military service. It is unknown as to whether he ever lived there. This land was later conveyed to William Harrison of Franklin Co., NC, for it is mentioned in William Harrison's will dated 9 Oct 1826 (Will Book I-J, page 42, Franklin Co., NC).

Page 286 of The Index to War of 1812, Pension File, Vol. I, at the North Carolina Genealogy Library, Raleigh, NC, reads, "Bunn, Odum, Elizabeth A. (Mise) 5th wife, WC-34983, m. 1822, Davidson Cty, NC, sd in 1840, wd 5th Jun 1881, Sullivan Cty, TN, srv. George Strother's and H. H. Villard's Co's 10th US Inf., lived Sullivan Cty TN, sol. had 5 wives, 4th wife Lucy (Bell), 1st 3 wives not named on card."



Shortly after the his death, Odum's wife, Elizabeth file an application for a widow's pension based upon his service during the War of 1812. She made a statement therein that he was born near Raleigh, NC, presumeably in Wake County. She may have been wrong, for Odum lived in Northampton Co., NC prior to moving to Wake County. In other pension information provided therein, she states that Odum ran away from home at age 17 when his father was drafted into the Revolutionary War service. He joined his father, and fought for the war's duration in the regular army, witnessing the surrender of Cornwallis and stacking of weapons at Yorktown, Virginia. He said he fought in the battle of Horse Shoe Bend in central Alabama during the War of 1812. That battle involved fighting the Creek Indians in what is now Tallapoosa County. He had a crippled hand and told people he had been wounded in the battle, but the pension office said that his discharge was for rheumatism and the hospital suggested his hand disability was related to the disease. Odum was a carpenter when married to Elizabeth, and his 1815 discharge lists his occupation as a carpenter. Odum died between 1840 and is buried next to his wife Lucy Bell in a private graveyard about 2 miles from Clemmonsville, NC. Odum's son, Absalom, stated in a letter that he saw them buried there, and then visited the site years later, and that the first wife of Odum is also buried there. There were no tombstones. Absalom stated that Odum had seven children by an early wife. Elizabeth stated there were four other wives. In a letter from Elizabeth to the Department of Interior Pension shows Odom middle initial to be "R." She stated that Odam's name sometimes appeared as Redmund in North Carolina Records. Elizabeth never received the pension. However, her son, Absalom, did receive compensation after her death, at the rate of \$8 per month commencing in March of 1878, and ending in June 1881.

Elizabeth lived for a short time in Surry Co., NC; then in Carroll Co., VA for a few years; then Washington Co., VA; then Sullivan Co., TN.

An affidavit by Elizabeth Wilson of Carroll County witnessed by T. F. Bunn [Thomas Franklin] and H. F. Deed Book 5, page 296 of Northampton Co., NC, reads "William Burn of Northampton Co., NC, to grandson Odam Burn, 200 acres after his fathers decease . . plantation whereon my son David Burn now lives . . said land on both sides of Murfree Road in Co. of Northampton, 3 Dec 1773. Jun. Ct. 1774." It appears that Odum received that land for on 3 Dec 1787, he conveyed 100 acres to William Allen (Deed Book 8, page 223), and on 7 Jan 1790 he conveyed another 100 acres to Joel Pope (Deed Book 8, page 206). It also appears that Odum left Northampton Co. at about that time and moved to Wake Co., NC.

Information on page ___, Franklin County, NC, Inventories, 1789-1800, indicates that Odom was present at an estate sale of Jame Pince on 24 Mar 1794. Further, he is listed in the Tax List for that county in the years 1792, 1793, 1794, 1802, 1805, and 1809. He is also shown in the 1800 census for that county with three male under the age of 10 and one male between 10 and 16.

On March 20, 1814, Odom Bunn was enlisted as a Private in the 10th Infantry of U. S. Army at White Plains, Wake Co., NC by Lieut. Fox. for a period of 5 years. Enlistment papers reads as follows:

"Height: 5' 8"; Eyes: Grey; Hair: Dark; Complection dark; Age: 50; Occupation: Ship Joiner; Where Born: Northampton, NC. Remarks: R. R. Wilkesborough, April 30, 1814 D. R. Capt. Geo. Strother's Co. Feby 16, 1815, Present - J. R. & M. R. Capt H. H. Villard's Det. Fort Washington, July 31, 1815. Discharged at Fort Washington May 25, 1815 for inability Mo. Ret of Capt Jas Reeds Co. U. S. Arty Ft. Washington, May 30, 1815. Also reports him discharged May 25, 1815 for disability - See Pension Cases."

On 18 Feb 1818, he received 160 acres of land (Township 2, South Range 6, West, 4th Pincipal Meridan) in the state of Illinois Public Domain Land Tract Sale for his military service. It is unknown as to whether he ever lived there. This land was later conveyed to William Harrison of Franklin Co., NC, for it is mentioned in William Harrison's will dated 9 Oct 1826 (Will Book I-J, page 42, Franklin Co., NC).

Page 286 of The Index to War of 1812, Pension File, Vol. 1, at the North Carolina Genealogy Library, Raleigh, NC, reads, "Bunn, Odum, Elizabeth A. (Mise) 5th wife, WC-34983, m. 1822, Davidson Cty, NC, sd in 1840, wd 5th Jun 1881, Sullivan Cty, TN, srv. George Strother's and H. H. Villard's Co's 10th US Inf., lived Sullivan Cty TN, sol. had 5 wives, 4th wife Lucy (Bell), 1st 3 wives not named on card."

Shortly after the his death, Odum's wife, Elizabeth file an application for a widow's pension based upon his service during the War of 1812. She made a statement therein that he was born near Raleigh, NC, presumeably in Wake County. She may have been wrong, for Odum lived in Northampton Co., NC prior to moving to Wake County. In other pension information provided therein, she states that Odum ran away from home at age 17 when his father was drafted into the Revolutionary War service. He joined his father, and fought for the war's duration in the regular army, witnessing the surrender of Cornwallis and stacking of weapons at Yorktown, Virginia. He said he fought in the battle of Horse Shoe Bend in central Alabama during the War of 1812. That battle involved fighting the Creek Indians in what is now Tallapoosa County. He had a crippled hand and told people he had been wounded in the battle. In correspondence dated April 19, 1815, a surgeon from the Fourth Military District, Fort Washington, stated tha Odom was incapable of performing his duties and it appeaared that he had rheumatism, and was a fit subject for discharge.

Odum was a carpenter when married to Elizabeth, and his 1815 discharge lists his occupation as a carpenter. Odum died between 1840 and is buried next to his wife Lucy Bell in a private graveyard about 2 miles from Clemmonsville, NC. Odum's son, Absalom, stated in a letter that he saw them buried there, and then visited the site years later, and that the first wife of Odum is also buried there. There were no tombstones. Absalom stated that Odum had seven children by an early wife. Elizabeth stated there were four other wives. In a letter from Elizabeth to the Department of Interior Pension shows Odom middle initial to be "R." She stated that Odam's name sometimes appeared as Redmund in North Carolina Records. Elizabeth never received the pension. However, her son, Absalom, did receive compensation after her death, at the rate of \$8 per month commencing in March of 1878, and ending in June 1881.
