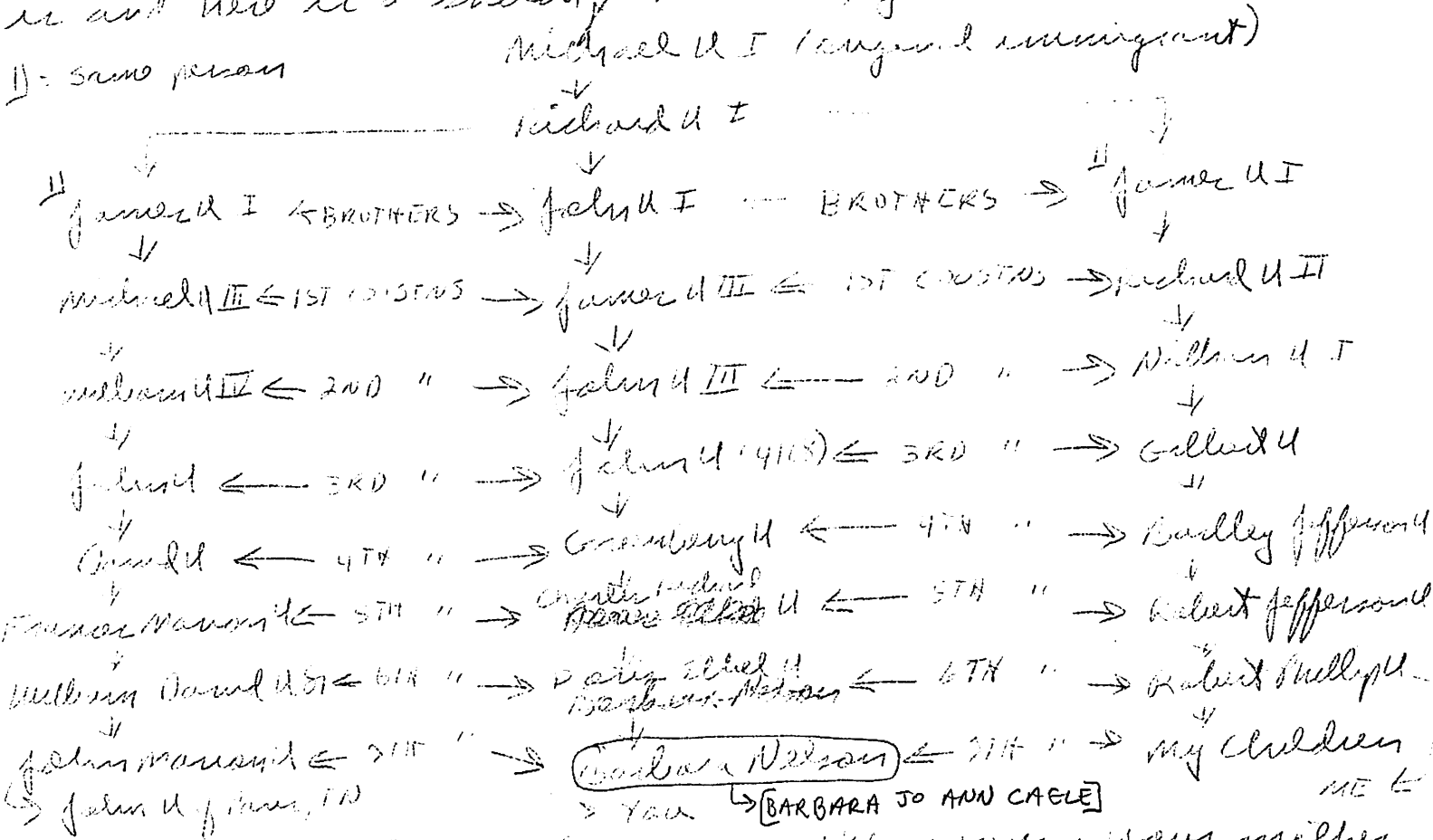

△ ALLRIDGE, CALAWAY, Private

Enlisted in Wake County, September 7, 1864, for the war. Captured at Strasburg, Virginia, October 19, 1864, and confined at Point Lookout, Maryland, until paroled and sent to Aiken's Landing, James River, Virginia, for exchange on March 28, 1865. Admitted to hospital at Richmond, Virginia, March 30, 1865, with "febris cont." and was transferred to Camp Lee, Virginia, April 1, 1865.

△ ASBILL, WILLIAM, Private

Enlisted in Wake County, August 18, 1864, for the war. Wounded and captured at Winchester, Virginia, September 19, 1864, and admitted to U.S.A. Depot Field Hospital, Winchester, September 24, 1864. Transferred to U.S.A. General Hospital, West's Buildings, Baltimore, Maryland, November 15-16, 1864, with "g.s.w. left thigh and right hand" and was transferred to Point Lookout, Maryland, January 8, 1865. Released at Point Lookout after taking the Oath of Allegiance on June 4, 1865.

△ BRANSON, J. M., Private

Enlisted in Wake County, August 18, 1864, for the war. Captured at Winchester, Virginia, September 19, 1864, and confined at Point Lookout, Maryland. Died at Point Lookout, March 17, 1865, of "chronic diarrhoea."

△ CAGLE, D. M., Private

Enlisted in Wake County, September 22, 1864, for the war. Present or accounted for on company muster rolls through February, 1865. Captured in hospital at Richmond, Virginia, April 3, 1865, and "escaped from hospital May 4, 1865."

△ CLARK, D. L., Private

Enlisted in Wake County, August 17, 1864, for the war. Present or accounted for on company muster rolls through February, 1865. Took the Oath of Allegiance at Washington, D.C., on May 29, 1865, and was "furnished transportation to Hamilton, Indiana."

△ COX, GEORGE W., Private

Enlisted in Wake County, August 18, 1864, for the war. Present or accounted for on company muster rolls through February, 1865. Paroled at Appomattox Court House, Virginia, April 9, 1865.

△ HANCOCK, BETHUEL, Private

Enlisted in Wake County, October 12, 1864, for the war. Deserted November 10, 1864.

△ HANCOCK, LEVI, Private

Enlisted in Wake County, October 12, 1864, for the war. Deserted January 15, 1865. Took the Oath of Allegiance and was "furnished transportation to Indianapolis, Indiana."

△ HINSON, HENRY, Private

Enlisted in Wake County, September 22, 1864, for the war. Captured September 29, 1864, at Swift Run Gap, Virginia, and confined at Point Lookout, Maryland. Paroled at Point Lookout and sent to Boulware's and Cox's Wharf, James River, Virginia, for exchange on February 18, 1865. Admitted to hospital at Richmond, Virginia, February 22, 1865, with "pneumonia" and furloughed for 60 days on March 7, 1865. Paroled at Charlotte, May 15, 1865.

△ JARRELL, ANDERSON, Private

Enlisted in Wake County, August 18, 1864, for the war. Wounded and captured at Winchester, Virginia, September 19, 1864. Confined at U.S.A. Depot Field Hospital, Winchester, September 20, 1864, with "v.s. right hip, flesh wound." Transferred to U.S.A. General Hospital, West's Buildings, Baltimore, Maryland, October 13, 1864, and sent to Point Lookout, Maryland, October 26, 1864. Paroled at Point Lookout, October 30, 1864, and sent to Venus Point, Savannah River, Georgia, for exchange. Reported on the company

muster roll for January-February, 1865, as "absent without leave in Randolph County."

△ KINLEY, MADISON, Private

Enlisted in Wake County, September 11, 1864, for the war. Present or accounted for on company muster rolls through February, 1865. Paroled at Appomattox Court House, Virginia, April 9, 1865.

△ MCINTYRE, GEORGE, Private

Enlisted in Wake County, September 22, 1864, for the war. Captured at Swift Run Gap, Virginia, September 29, 1864, and confined at Point Lookout, Maryland, until paroled and transferred to Aiken's Landing, Virginia, for exchange on March 17, 1865. Received at Aiken's Landing on March 19, 1865, for exchange.

△ MACON, GIDEON, Private

Enlisted in Wake County, September 11, 1864, for the war. Reported on company muster rolls as absent in arrest from September-October, 1864, through February, 1865. Paroled at Appomattox Court House, Virginia, April 9, 1865.

△ RICH, JOSEPH, Private

Enlisted in Wake County, September 7, 1864, for the war. Captured at Fisher's Hill, Virginia, September 22, 1864, and confined at Point Lookout, Maryland, October 1, 1864. Released at Point Lookout, May 13, 1865.

△ SLACK, LABAN, Private

Enlisted in Wake County, August 19, 1864, for the war. Wounded and captured at Winchester, Virginia, September 19, 1864. Admitted to U.S.A. General Hospital, West's Buildings, Baltimore, Maryland, October 19, 1864, with "f.w. left thigh above the middle" and was transferred to Point Lookout, Maryland, October 25-26, 1864. Paroled and sent to Venus Point, Savannah River, Georgia, for exchange on October 30, 1864. Reported on company muster rolls as absent prisoner of war until January-February, 1865, when he appears as absent without leave.

△ SMITH, DAVID N., Private

Resided in Mecklenburg County and enlisted in Wake County, September 20, 1864, for the war. Present or accounted for on company muster rolls through February, 1865. Captured at Farmville, Virginia, April 6, 1865, and confined at Point Lookout, Maryland, until released after taking the Oath of Allegiance on June 30, 1865.

△ WARD, JAMES, Private

Enlisted in Wake County, August 8, 1864, for the war. Company muster roll for November-December, 1864, reports that he "deserted November 24, 1864."

△ TROGDEN, H. K., Private
