### CANDIS UPCHURCH XID 8715

**Commentary**: Candis Upchurch (1818 – 1889) was the daughter of Whitney Upchurch and the granddaughter of Moses Upchurch, head of Upchurch Clan No. 1. Her life played out on the border of Wake and Chatham Counties in North Carolina. Her courtship with Britton Mills failed to produce a marriage but did produce a son, Silas Merritt Upchurch who saw service in the Civil War. Candis went on to marry John Mann in 1847 and together they produced an illustrious family. Descendants to this day have a keen interest in their heritage and hold a Mann reunion on an annual basis.

"Dates for <u>Candis U.</u> are difficult to establish. I have set her birth date based on census reports. She was, for some odd reason, according to my two oldest living great aunts buried in the woods near where they lived and not at Christian Chapel. She evidently died after her husband, John, and possibly the illegitimate birth of Merritt U. prevented her from having a church burial. Her name is spelled "<u>Candis</u>" on her marriage bond.

After having written the above I found out that my great aunt Mary Joyce (Mann) Farabow remembers hearing her brother Raymond talk about how he was scared of his grandmother <u>Candis</u> Mann when he was a little boy. However, she added that Raymond said he saw her only a few times – they lived a few miles from each other. This helps to pinpoint her death. Raymond was born Dec 1884 so <u>Candis</u> must have lived at least until 1889 in order for Raymond to remember her."

My great aunt Mary Joyce (Mann) Farabow told me last year at the Mann Reunion that she remembered thinking that John Mann died *after* <u>Candis</u>, that he buried her in Chatham County in the woods somewhat near Christian Chapel Christian Church and also near someone's saw mill. She admitted, though, that her memory of this was a bit foggy. I wonder if she was buried in that Mann\Cotton Cemetery up the road about 300 or 400 yards from Christian Chapel. There are a few legible graves left there, but they are in the woods and hard to find now. I saw them about eight years ago, but I saw no <u>Candis</u> Mann gravestone. Incidentally, I never realized how close Christian Chapel and the dirt road that leads north to Merry Oaks are to the Wake County line until very recently when I was the at the 1991 Mann Reunion. At some points on that short span of road I'm sure that Wake County is within 200 - 300 yards. I mention this because maybe Whitney Upchurch lived in this of Wake County in the Buckhorn District later in his life and was actually very close by to his daughter <u>Candis</u> and son-in-law John Mann.

It is further ordered that the said defendant enter into bond with approved security for the support of said child. That he pay the sum of ten dollars for lying in fee and and ten dollars for five years to the said Candis Upchurch. And thereupon the said defendant enters into bond in the sum of two hundred dollars, with Matthew Mills as his security. [This is the Matthew Mills ↑ born 1789]

Whitney Upchurch was born in 1793 at Franklin County, North Carolina the son of Moses Upchurch and Mary Simms. He died in 1863 at Wake County. He married Elizabeth Goodwin.

Elizabeth Goodwin was born at Wake County, North Carolina in 1794 the daughter of William and Winifred Goodwin. She married Whitney Upchurch on January 3, 1811. They had seven known children born of this marriage. (1) Candis Upchurch was born in 1818 at Chatham County. (2) Richard Dillard Upchurch was born in May 1820 at Chatham County. He married Jane Phelps in 1848. They had a daughter named Kittie Upchurch born 1852 at Nevada City, California. (3) Duncan Lemuel Upchurch (untraced) was born in November 1824 at Wake County, N. C. (4) Hesper Ann Upchurch (untraced) was born in 1828 at Wake County. (5) James M. Upchurch (untraced) was born in 1830 at Wake County. (6) Martha Jane Upchurch (untraced) was born in 1832 at Wake County. She married William Stephens on February 22, 1866. He was born in 1825 and died after 1910. (7) Bennett A.
