

Paragraph 1 refers to SAC, I

John Carpenter (15712) and Elizabeth Upchurch Carpenter (15111) were the parents/adoptive parents of Simeon Upchurch Carpenter as known by the 1803 legislative action regarding the change in surnames of the five Upchurch children and the 25APR1836 Green Co., AL Orphan's Court record [Orphans Ct., Bk D, p205] naming Simeon as a heir of John Carpenter (15712). The age of Simeon Carpenter can be extrapolated by him being a witness to a 24OCT1809 Franklin Co., NC deed from Benjamin Upchurch (163) to John Carpenter (15712) [Deed Bk 15, p73]. Simeon being at least of legal age of 21 in 1809 would have him born circa 1788.

Paragraph 2 refers to SC of Sardis born 22 May 1800 died 5 Aug 1860

Buried in Sardis Cemetery in Greene Co., AL is a Simeon Carpenter [22MAY1800/5AUG1860] and his wife Mary M. Carpenter [20CT1808/20AUG1881]. Recorded in Greene Co., AL is a marriage record between Simeon Carpenter and Polly M. Cherry on 1827. Other court records demonstrate that she was the daughter of Samuel T. Cherry, also buried at the Sardis Cemetery. Based on the dates from the tombstone, it can be shown that the Simeon Carpenter enumerated on the 1830, 1840, 1850, and 1860 censuses is in fact this Simeon Carpenter and not Simeon Upchurch Carpenter. On page 784/394B of the 1830 census he is enumerated on line #5, which is within several lines of other Carpenter associated families, namely Lawrence Williams [line #2] and James B. Tutt [line #6], both husbands of two of John Carpenter's (15712) daughters. Although this would suggest a family association with John Carpenter, I have not found him noted on other records with any known John Carpenter direct family or associated family members. This Simeon Carpenter is also not named as a heir of Simeon Upchurch Carpenter in the 9APR1838 settlement of John Carpenter's (15712) estate [Greene Co., AL Orphan's Ct, Bk.D, p390].

Elizabeth Pierce Carpenter is buried at Pleasant Hill Cumberland Presbyterian Cemetery in Green Co., AL. Her tombstone notes: "In Memory of Elizabeth wife of Simeon Carpenter Sen. who was born Jan 29, 1789 departed this life March 21, 1855 aged about 66 years. She was an affectionate mother leaving six children to mourn her loss." The "Simeon Carpenter Sen. [Senior]" from the tombstone is an interesting reference, but not to the Simeon Carpenter born in 1800, as Elizabeth would have been only 11 years old and Simeon Upchurch Carpenter only 12 years old (assuming the age extrapolation) when this Simeon Carpenter was born. A biological possibility, but highly unlikely from a social and cultural standpoint. This "Senior" reference could have been made only to differentiate the deceased Simeon Upchurch Carpenter from the other Simeon Upchurch still living at the time of Elizabeth Pierce Carpenter's death. It also could mean that one of Simeon Upchurch Carpenter's sons was a Simeon, although no record has been demonstrated to have used this name in association with one of the sons. Furney Lee Carpenter, son of Simeon Upchurch Carpenter, is documented with two proper names, where as the other sons seem to only be documented with one proper name. The possibility exists and will require further research. Trying to sort this out and who this other Simeon Carpenter is and his connection to the John Carpenter (15712) family is not the focus of your Upchurch family research, but I just wanted to point him out.



466 THE CARPENTER FAMILY

The Carpenter family of North Carolina traces its family heritage back to the late 1700's to Nash County. On October 25, 1782, Thomas Carpenter was the first of his family to move to North Carolina. Research indicates that Thomas may have moved from Virginia and served as a Revolutionary soldier for North Carolina. After the war, Thomas purchased 314 acres of property on the waters of Moccasin Creek in Nash County. Thomas married Mary Lee Leigh. Thomas and Mary had a son named John Carpenter. John married Elizabeth Upchurch and had a son named Simeon Carpenter.

John and his family lived on Moccasin Creek in Franklin County, North Carolina. John later moved his family to Green Co., Alabama, where he died sometime around 1836 to 1838. Simeon continued to reside in Nash County and in 1840, Simeon married Martha Bunn (1st wife) and later married Cynthia Gay Brantley. Simeon and Cynthia had a son named Granberry (Berry) Carpenter. Berry married Eliza Ann Moss and they had a son named Granberry Jackson (Jack) Carpenter, who married Ida Pearl Poland. Granberry Jackson (Jack) and Pearl had two sons, which were Otis Lee Carpenter and Winslow Carpenter. They also had four daughters which were, Nina, Ida CIrene and Christine. Otis Lee married Dorothy Bessie Taylor Carpenter and had a son named Harry Lee Carpenter. Otis and Dorothy purchased property in the Sandy Cross area of Nash Co., where Dorothy continued to reside until her death in 2005. Harry Lee Carpenter married Ella Gwendell (Dell) Poland in 1962. Dell was the daughter of the late James Elmer Poland and Lessie Odell Winstead Poland. Harry and Dell purchased property from Dorothy and continued to reside in the Sandy Cross area. They had four children, which were Lynne Carpenter Spencer, Angie Carpenter Page, Harry Lee Carpenter, Jr. and Mark Carpenter. This branch of the Carpenter family continues to reside in Nash Co. At the present, Mr. & Mrs. Harry Lee Carpenter Sr. have a total of 10 grandchildren.

The Carpenter family were primarily farmers up to the point of Otis Lee Carpenter. Otis served in the U.S. Army. He was wounded in the line of duty in Austria on May 16, 1945 and died on May 17, 1945. Members of this family have entered into various fields of work such as business and professional employees, self-employment, healthcare services, teaching and blue collar workers.

John Carpenter Dorn c1760-70, died c1836, resided in Franklin Co. NC and Greene Co. AL. A greatgreat-grandson (#5a2a) stated that "the Carpenters came from England to America about the time of the Revolutionary war, settling in North Carolina" [Shawkey:161]. John Carpenter's heirs were listed in an estate settlement in Greene Co. AL on 25 Apr 1836. He appears to have married twice. His wife named in his will was Elizabeth, who was born probably c1761 in NC. The reason for the legal change of the surname of five of his children from Upchurch to Carpenter is not currently known. Possible reasons for changing the surname include adoption of his wife's children from a previous marriage, acknowledgement of illegitimately-born children, and other possible explanations—the reason in this case may be in the court records, but we have not been able to access them. Elizabeth may have been born or previously married to an Upchurch, which would explain the name change, or the children may have been his natural children.

Churchwell and Belva are buried in the Old Bethany Cemetery, Pickens County, Alabama. The cemetery is just over the Pickens County line from Greene County, highway 14.

Some researchers have indicated Churchwell's first name was William, and if true probably named after his father's brother William. (Additional records under John Carpenter (Churchwell's father will include the mystery --- are we Carpenter's by adoption or by birth)?

Churchwell and Belva were married in Wake County, NC on 9 August, 1824. Peter Hopkins signed the license and B.S. King was a witness. I haven't done any research on the Hopkins, therefore, do not know if Peter was her father or brother (he did move to Greene County, also).

They moved from Franklin County, NC to Greene County, AL about 183 (first land patent granted 14 September 1831). They moved at some point into Pickens County, near Vienna - unfortunately records from Pickens County are scarce due to two courthouse fires, therefore am unable to provide much information on this era in their lives. I can not determine how Churchwell's estate was settled as have been unable to locate anything, other than census records which indicates he did have land and money.

For a general chat and to clarify the reason she created the packet she gave to me on 2 Oct 2006.

She generated these mostly Franklin Co, NC records in an effort to show that one of her Strickland Family females was a wife of Benjamin Upchurch – Head of Clan.

She found no proof but circumstantial data leads her to believe that Benjamin Upchurch had two wives – speculative names given below – with some reasons given.



I. Benjamin Upchurch – Head of Clan married (1st) Mary Ann Strickland 1 married (2^{nd}) Nancy Ledbetter 2 [Ledbetter may have been a married name]

A. Elizabeth Upchurch – oldest child married () John Carpenter. They moved to Pickens Co, AL before Nancy died (Elizabeth would not have left her elderly mother behind) (Elizabeth got 0 from the Benjamin Upchurch estate.) (Carla feels the Upchurches who changed their names to Carpenter were children of Elizabeth and **John** – born before they married).

B. Frances A Upchurch (got the entire estate) married () John Pearce

Carla found no probate records for Benjamin Upchurch and concludes this may have been one of those cases where probate was unnecessary because the estate had funds to pay all debts.
