Valley experts identify the top chocs

Chocolate, early and often

The wraps come off as experts name the best

There may be people in the world who don't like chocolate, but I don't want to know them. They probably kick dogs and run down little old ladies. From all accounts, we have the Aztecs to thank for the food known variously as the elixir of the gods, an aphrodisiac and nature's perfect food. Christopher Columbus brought it back to the Spanish court from the New World in 1502. Spanish explorer Hernando Cortes discovered a cache of cocoa beans among Aztec nobility a few decades later.

Cortes conquered Mexico, and chocolate conquered Europe. After Spanish Princess Anne of Austria gave Louis XIII an engagement present of cocoa beans in the 17th century, Europeans finally had something to look forward to for dessert besides a plate of cheese.



Be honest. If you're stranded on a desert island, do you want to be there with rounds of Gouda or mounds of truffles? And if you're surrounded by chocolate truffles, do you really want to be rescued?

Whether chocolate is an aphrodisiac or whether it lives up to its reputation as a substitute for love is moot. Chocolate is its own reward. The smell, the taste, can bring a moment of contentment as no other food can.

Taste in chocolate varies wildly, depending on your palate and what part of the world you come from. Europeans prefer dark, bittersweet chocolate. Chances are, Americans who have sampled European ambrosia do,

too. Belgians are considered the best chocolatiers in the world. Their candy is the gold standard.

In America, people on both coasts are hooked on dark chocolate. But Phoenix, a local chocolate broker says, "is a milk-chocolate town."



For the heart(s) of your heart, a chocolate-covered marshmallow version of the same from See's ... or perhaps a long-stemmed rose (edible variety) from AJ's.



“Unless you hit your winter visitors, people don’t know any better,” says Billie Williams of Upchurch, a Valley chocolate distributor. Upchurch supplies bulk chocolate wholesale to local candymakers and restaurants.

Milk chocolate has been cut with milk, making it sweeter and, Williams says, less pure than dark chocolate — also known as bittersweet or semisweet.

“It’s like whether you want your coffee straight, or your booze straight,” she says.

But, even in the Valley, “you still have people who appreciate the real thing.”

Upchurch deals in all brands of chocolate from around the world. The best European brands, Williams says, are Perugina from Italy, Lindt and Toblerone from Switzerland, Mackintosh and Rowntree from England and anything from Belgium.

In America, she says, the top brands are Nestlé, Ethel M (a Las Vegas brand from M&M/Mars), Price (out of Kansas City, Mo.), Guittard and Ghirardelli (California).

Surprisingly, Williams calls gold-bound Godiva chocolate “common, common, common.”

“It’s superhard, it has no taste and it’s not as creamy,” she says.

And don’t even mention the chocolates at the bottom of the food chain — Whitman’s, Brach.

How to tell premium chocolate? Williams and her colleagues have the definitive test:

- It should have a rich chocolate fragrance. If it doesn’t smell like good chocolate, don’t put it in your mouth.
 - It should have a strong chocolate taste immediately.
 - It instantly should melt in the mouth — and in the hand.
 - It should be creamy, with no hint of granulation or waxiness.
- And, as every chocolate lover knows, it should make you feel good.

One of the tragedies for Valley chocolate eaters is our weather, says Judy Kubinski, owner of Jus’ Chocolate, a custom-order chocolate business in Fountain Hills.

Kubinski, whose hands are still raw from molding and wrapping 1,500 little chocolate footballs for the Super Bowl Host Committee, says chocolate is seasonal. Business booms around Valentine’s Day, Easter and Christmas, and falls 90 percent in the summer.

MOLE POBLANO DE POLLO (CHILE-CHOCOLATE SAUCE FOR CHICKEN)

(From *The Great American Chocolate Contest Cookbook*)

- 1/4 cup lard or solid vegetable shortening (lard is authentic to the traditional dish)
- 2 tablespoons crushed red-pepper flakes
- 6 boneless, skinless chicken breast halves (about 2 pounds)
- 3 cups homemade or canned chicken broth, divided
- 4 corn tortillas (7 to 8 inches in diameter), cut into small pieces
- 1/4 cup tomato sauce
- 1/4 cup minced onion
- 4 cloves garlic, finely minced
- 1 tablespoon unsweetened cocoa, or more to taste
- 1 tablespoon raisins
- 1 tablespoon chopped almonds or walnuts
- 1 tablespoon sesame seeds
- 1 tablespoon shelled pumpkin seeds
- 1 tablespoon peanut butter or chopped peanuts
- 1-1/2 teaspoons granulated sugar
- 1-1/2 teaspoons dried oregano leaves, crushed
- 1/2 teaspoon aniseed
- 1/4 teaspoon ground cinnamon
- 1/4 teaspoon ground nutmeg
- 1/4 teaspoon ground allspice
- 1/4 teaspoon ground ginger
- 1/4 teaspoon ground cumin

Optional garnishes:

- Fresh cilantro sprigs
- 6 ounces semisweet chocolate, melted

To make the chile-chocolate sauce: Preheat the oven to 325 degrees.

Heat the lard in a large skillet over moderate heat until melted. Stir in the crushed red-pepper flakes and saute for 1 minute.

Add the chicken breasts and lightly

brown each side. Remove from the pan and set aside. Using a strainer, remove any remaining crushed red pepper from the lard in the skillet. Reserve the red pepper for later use.

Add 2 cups of the chicken broth to the skillet. Stir in the remaining ingredients except for the optional garnishes and 1 cup chicken broth and reserved red pepper. Heat the mixture to boiling, then reduce the heat, cover, and simmer, stirring occasionally, for 30 minutes. Remove from the heat and set aside to cool.

Pour a small amount of the cooled sauce into a food processor or blender and puree on high speed until the mixture is fairly smooth. Repeat with the remaining sauce.

To prepare the chicken: Combine the pureed sauce and the remaining 1 cup chicken broth in the prepared baking dish and mix well. Add the browned chicken breasts in a single layer, turning them over to coat each side well with the sauce. Sprinkle the breasts with the reserved crushed red pepper.

Bake for 20 to 25 minutes, or until the chicken is tender and the juices run clear when pierced with a fork.

Serve with a garnish of fresh cilantro sprigs or melted chocolate spooned on the side if desired.

Note: You must try this with spoonfuls of melted semisweet chocolate on the side. Either mix the chocolate into your serving, or dip forkfuls of the dish into the chocolate.

Makes 6 main-dish servings.

Approximate values per serving: 563 calories, 28 g fat, 111 mg cholesterol, 35 g carbohydrates, 235 mg sodium, 44 percent calories from fat.

Pouring it on

At the Coyote Springs Brewing Co., which once commissioned a local candymaker to fashion a beer-flavored chocolate, customers can try another innovative item — beer-flavored cheesecake, which comes in a chocolate version.

If you’re looking for other creative ways to incorporate chocolate into your daily menu, try it in:

- Waffles
- Pancakes
- Dumplings
- Chicken casserole? Chicken in a mole (chocolate) sauce is a classic Mexican favorite.

Jus' Chocolate opened in 1983, after Kubinski decided to turn her cooking skills into an enterprise.

She had just finished an apprenticeship as the candymaker for Oscar Taylor restaurant, turning out 123 varieties of truffles, creams, barks and novelty items. From her own commercial kitchen, she then supplied Oscar Taylor's bakery, the Upper Crust, with chocolate dessert shells.

Kubinski took that knowledge and put it into her shop, where vats of melted chocolate are whirring constantly and tiny red squares of foil swirl around her workstation waiting to wrap chocolate hearts.

Much of her business is in commercial products, like the Super Bowl footballs.

"I'm a custom-order person and a niche filler," she says.

Kubinski can turn out almost any company logo or product in chocolate and will cast any item as long as it has clean, simple lines.

A golf company ordered 1,500 white-chocolate golf balls wrapped in gold foil and packed in shag buckets.

One of Kubinski's strangest requests came from the Coyote Springs Brewing Co. in Phoenix — chocolate with beer inside. When filling a chocolate mold with liquid beer proved impossible, she developed a beer-flavored truffle that pleased her clients.

"I don't drink beer, but I tasted them with people who like beer, and they thought they were pretty good," she says.

Among Kubinski's Valentine's Day novelty items is a chocolate teddy bear dressed in a red satin teddy. In milk chocolate, white chocolate and semisweet, it sells for \$25.

Jus' Chocolate retail items are available at the Desert Kettle in Fountain Hills.

Like the people at Upchurch, Kubinski prefers dark chocolate to milk. That's the preference of the sophisticated palate, she says. What makes one brand different from another is its formula.

The best formulas contain a lot of cocoa butter, melt quickly and are free of tropical oils (such as coconut oil), which gives chocolate a waxy aftertaste.

One of Kubinski's specialties is her assortment of chocolate-dipped buttercreams in distinctive Southwest flavors — prickly pear, citrus and jalapeño. The last is tart but not hot. She also sells such classics as raspberry and vanilla creams.

Something new from Lovebud's: Red-foil-wrapped lips give "chocolate kiss" a whole new meaning. Something old from Walgreens: A classic Whitman's Sampler brings back memories. A Valentine's basket filled with assorted candies comes from Cerreta's, and Godiva offers a Coeur de Lait milk-chocolate heart and chocolate-dipped chocolate-hazelnut biscotti.

CHOCOLATE WAFFLES WITH FRESH BERRY SAUCE

Waffles:

- 1 cup unbleached all-purpose flour
- 1 cup whole-wheat flour
- 1/2 cup unsweetened cocoa powder, sifted
- 1/2 cup sugar
- 1 teaspoon ground cinnamon
- 2 teaspoons baking powder
- 1/2 teaspoon salt
- 1 cup non-fat milk
- 1/4 cup canola or corn oil
- 1 tablespoon vanilla extract
- 3 egg whites, beaten until stiff but not dry

Strawberries, for garnish (optional)

Berry Sauce:

- 3/4 pound fresh or thawed frozen raspberries, pureed
- 3/4 pound fresh or thawed frozen strawberries
- 2 tablespoons sugar

To make the waffles, combine flours, cocoa powder, sugar, cinnamon, baking powder and salt and mix well. Set aside.

In a separate bowl, combine milk,

oil, and vanilla; mix well and add to the dry mixture. Again mix well. Fold in beaten egg whites, just until blended.



Preheat a waffle iron coated with non-stick vegetable spray. Pour 1/2 cup waffle batter into the center of the hot iron and bake about 6 minutes, or until waffle is crisp. Bake the remaining batter, keeping waffles warm in a covered dish in a 250-degree Fahrenheit oven.

Makes 6 waffles.

To make the sauce, strain raspberry puree to remove seeds, then combine with strawberries and sugar and mix well.

Approximate values per waffle: 348 calories, 11 g fat, 1 mg cholesterol, 415 mg sodium, 28 percent calories from fat. Each tablespoon of sauce contains approximately 11 calories; no cholesterol; no fat; trace sodium.

BLACK FOREST BRUNCH PANCAKES

(From The Great American Chocolate Contest Cookbook)

- 1-1/2 cups all-purpose flour
- 1/2 cup instant chocolate milk powder or sweetened cocoa mix
- 2 tablespoons baking powder
- 1/4 teaspoon instant coffee granules
- 2 large eggs or equivalent egg substitute
- 1 cup milk
- 1/4 cup unsalted butter or margarine, melted

Toppings:

- 2 cups cherry pie filling
- Confectioners' sugar to taste

In a large bowl, stir together the flour, chocolate milk powder, baking powder, and instant coffee.

In a separate bowl, beat the eggs until lemon-colored and light in texture (about 2 to 3 minutes). Add the milk to the eggs and beat again.

Pour the milk and egg mixture into

the dry ingredients and blend until smooth. Stir in the melted butter.

Heat the greased griddle or frying pan over medium-high heat. The griddle is hot enough when a few drops of cold water sprinkled on the griddle bounce and sputter. Ladle large spoonfuls of the batter onto the surface and cook for 2 to 3 minutes. Turn over and cook for about 2 minutes more.

Top the cooked pancakes with the cherry pie filling and sprinkle with confectioners' sugar.

Variation: Substitute another type of fruit for the cherries.

Makes 4 servings.

Approximate values per serving: 570 calories, 10 g fat, 146 mg cholesterol, 89 g carbohydrates, 329 mg sodium, 15 percent calories from fat.



Chocolates are best served at room temperature.

"It's like wine," Kubinski says. "The bouquet is better. The mouth feel is better. The whole experience is better."

Magazine spills the beans

In its February issue, *Consumer Reports* rates boxed chocolates. Its rankings, from best to worst:

Burdick — "Most chocolatey chocolate, (the bitter chocolate) may be an acquired taste."

Godiva — "Fast-melting, smooth, but not always deemed fresh."

Teuscher — "Presented beautifully . . . smooth, fast-melting."

Fannie May — "Fresh, natural-tasting fillings."

See's — "Firm, fresh-tasting fillings."

Neuhaus — "The chocolate . . . is only average, and the fillings are not very flavorful."

Perugina — "Thick, hard chocolate that is slightly waxy and slow to melt."

Karl Bissinger — "Chocolate is generally better than the sweet fillings."

Russell Stover — "Chocolate is average, the fillings . . . more sweet than flavorful."

Whitman's — "The least chocolatey chocolate . . . candies are slow to melt, with firm fillings that aren't very flavorful."

Price's — "Less chocolatey than most, with fillings that are much more sweet than flavorful."

CHOCOLATE DOUBLE DUMPLINGS

(From *The Great American Chocolate Contest Cookbook*)

Dumpling Dough:

- 1 cup all-purpose flour
- 1/2 teaspoon salt
- 1/4 cup unsweetened cocoa
- 1/2 cup granulated sugar
- 1-1/4 teaspoons baking powder
- 1/2 cup minus 1 tablespoon half-and-half
- 3 tablespoons margarine, melted
- 1/2 cup semisweet chocolate chips
- 1/2 chopped pecans

Chocolate Sauce:
3/4 cup granulated sugar
1/3 cup unsweetened cocoa
1/8 teaspoon salt
3 cups half-and-half
1/2 cup unsalted butter or margarine, melted

Garnish:
1 teaspoon vanilla extract
Fresh whipped cream

To make the dumpling dough: Preheat the oven to 375 degrees. In a medium bowl, combine the flour, salt, cocoa, sugar and baking powder and mix well.

In a small bowl, combine the

half-and-half and melted margarine and stir all at once into the flour mixture, making a soft dough. Stir in the chocolate chips and pecans. Set aside.

To make the sauce: In a large heavy-bottomed saucepan, combine the sugar, cocoa and salt and mix well. Over moderate heat, gradually stir in the half-and-half until the mixture is smooth. Add the butter and bring to a boil, stirring often. Allow the mixture to boil about 3 minutes, stirring constantly.

Remove it from the heat, stir in the vanilla, and pour into the baking dish.

Drop the dumpling dough by heaping tablespoons into the baking dish on top of the sauce. Bake for 30 minutes. Serve the dumplings and sauce warm with whipped cream.

Makes 8 to 10 servings.

Approximate values per serving: 480 calories, 30 g fat, 56 mg cholesterol, 46 g carbohydrates, 232 mg sodium, 57 percent calories from fat.

Short and sweet

• In a survey conducted by a women's magazine, 70 percent of female respondents said they would rather have chocolate than sex, according to the Chocolate Manufacturers Association.

• Women prefer their chocolate as candy, ice cream and fudge topping. Men like chocolate-cream pie and chocolate cake.

• Chocolate is extremely sensitive to odors and flavors. Take care to keep it away from smoke and other odors. Seal well when storing in the refrigerator to preserve its taste and guard against moisture.

• Bulk chocolate without nuts has a shelf life of about eight months when stored properly. With nuts, it will store about six months.

• Chocolate is a health danger to dogs. Never feed pets chocolate.

Dear Cousin Annie Laurie,

My notes from our 11 MAY 1937 phone conversation indicate that you and Billie and Norman will be making your trip to England in July. I had hoped to develop a paper map for you but other things have claimed my time. In hopes of getting something to you in time I will send this note and hope that it helps.

I understand you were considering visiting the village of Upchurch and/or Little Gidding. If you have to make a choice let me encourage you to select Little Gidding as it has far more known connection with the Upchurch family than the village of Upchurch.

The Upchurch village is located in KENT on the Thames River or just south of same. The village does have a very old church dating from about 1200. There are no Upchurch families living in the area now and I have never seen documentation that they ever lived there - although the fact

That the village ⁽²³⁾ is named Upchurch implies that a family of that name lived in the vicinity at one time or another.

We do know that members of our family were living in the community surrounding Little Gidding starting as early as the late 1500's and probably before they were prominent (ministers, business people, land owners, etc) all during the 1600's and 1700's and so there today. We know that our ancestor Michael II left Little Gidding in 1649 and came to America leaving his father there at Little Gidding. We don't know what role Michael or his father played at Little Gidding. I will have an article in the Upchurch Bulletin in due course speculating on this.

Little Gidding is about 50-70 miles northeast of London proper. When I went there on 24 MAY 1979 I rented a car at Heathrow Airport and drove across North London traveling 104 miles and taking 4 hours and 15 minutes to get there. This took me up M-1 (M-1 = like an interstate highway). Then to A-10 then to A-14 then to A-1 then turn west off of A-1 on B660 towards Gladon and Great Gidding. When you get to Great Gidding turn left to go to Little Gidding. Little Gidding is a mile or so

out of Great Gidding. You have to go down a farm lane to get to Little Gidding as it is about $\frac{1}{4}$ - $\frac{1}{2}$ mile off the road from Great Gidding. In returning to London I took a somewhat more westward route and traveled 98 miles taking 2 hr and 40 minutes. Unfortunately on the way back I did not record the routes or towns. On the way up I went through Raynton, Claxton, and Godmanchester. I know all of this is confusing but you really can get there by car.

Some talking to you I have received a letter from our cousin James Russell Yable who went to Little Gidding last fall. They took the train and taxi. An excerpt from their letter is enclosed in case you want to go by train.

I am anxious to learn about your trip to Little Gidding. If you have a chance to call me before you start your trip or to come down to Tucson please do so. Otherwise I will hope to see you when you get back.


Annie Fawne says her parents did not want



to Nellie and talked to Phyllis by phone. Phyllis
has a copy of the rare autobiography of her
grandfather John Jordan U, a famous Upchurch. She
is bringing it to my office Tuesday and will
loan it to me. It will be extracted for a
future issue of Upchurch Bulletin. It is quite
a coincidence that I spent 1 1/2 hours in
St Louis on 13 JUL 80 looking for the gravesite
of John Jordan U. My son-in-law there has
since found the exact site and my wife and
I will be there in mid-August so I can take
a picture for publication in U B.

your husband and I were related as follows:



Hence your husband and I were 3rd Cousins.

The Natham U Clan has not been well documented and I have been working on it in some special ways. The two lines sketched on the previous page are of special interest to me and are more tightly interwoven than appears on the surface.

William Clinton U I was the first prominent Upchurch merchant in Raleigh, NC. He came to town from the Green Level area in Western Wake Co, NC about 1840 and for 60 years \pm cut a wide swath in Raleigh. My Grandfather, Bartley Jefferson U, left Green Level about 1860 to serve in the Civil War and a few years after his return settled in the Inwood Church area of Southern Wake Co where my father and I were born. Bartley was in the farming business with his brother William George U. William moved to Raleigh about 1855 \pm and first was associated in business with his 1st cousin William Clinton U I, your husband's grandfather. The plot there is that W. G. U and Eleanor Marie U the daughter of W. C. U I (Eleanor was the sister of your father-in-law). W. G. U was an amazingly successful business man in Raleigh. He died of cancer in 1895 at an inopportune business point.

Nathaniel Smith U, a brother of W. G. U + Bartley U, moved to Florida in 1858 and gave

rise to a very prominent family there. In due course Belle Williamson U, sister of your father-in-law, and John Jones U, the son of Nathaniel Smith U. After W. G. U died his wife moved to FL but she was returned to Raleigh for burial when she died in 1927. There are several other interesting cross-connections among these families - some of which I am still sorting out.

On 25 FEB 1980 while in Raleigh on a visit I talked to Marie Hayer (Upchurch) Weaver, a sister of your father-in-law. She gave me many details. John William U Sr decided to raise his boys in the country so he bought a 100 acre farm from my grandfather B. J. U. I know the place well. J. W. U. Sr also ran the local Upchurch store for a time. My mother and father were married in the home of your father-in-law on 14 FEB 1920!

I have dropped by your store in Phoenix once but it was after 4:00 PM. Only recently have I sorted out the right names associated with your husband and you. I visit Phoenix quite a few times each year but at irregular intervals. I would really like to visit sometime when it is convenient - or if you come to Tucson, let me know.
