I assume you have continued your interest in the history of the Upham family. If you have collected more details I would really appreciate having them. Also I will be happy to try to answer any questions you may have. Here are some of mine:

- 1) In your 5 SEP 1980 letter to Mrs E.H. West you mentioned that your Uncle (Jasper Wilson U) took you to an old ^{unmarked} grave site which he had cleaned of weeds a number of times. This site was presumed to have been an earlier Upham ancestor - you thought Charles U at the time. Of course it could be that of Charles U but we know now that your ancestor was Richard U III and not his brother Charles U. Richard U III died in Franklin Co, NC in 1817. Charles U died someplace in GA. Your ancestor Calburn U d 1862 in Clayton Co, GA - could the gravesite be his. Can you tell me exactly where this gravesite is and also that of your gggf Jasper U.?
- 2) Your chart shows that your gggf Jasper U and Lucinda Chapin, that his brother, Button U, and Susan Elizabeth Chapin, and that a 3rd brother, William Calburn U and Lucinda Chapin. I wonder if this third part (underlined) is not in error. I show that William Calburn U b 1822 (Hancock Co, GA) and 17 MAR 1842 Mary Whitaker b 1822.
- 3) your chart shows your gggf Jasper U had two stepdaughters - Ellie Chapin + Tannie Chapin. Does this mean Lucinda Chapin was not earlier - or did the two girls simply go by their mothers name for whatever reason?

Dear Mrs Tebo,

For several years I have been working closely with Mrs G H West of Durham, NC on the Uphurch family. She recently sent me a copy of your 5 SEP 1980 letter to her. Her book is great.

My records show a Jasper U b. 1835 (Henry Co, GA) and 30 DEC 1867 Luanda Chaffin. I have nothing on his descendants but show him as one of 12 children of Calum U who moved from Franklin Co, NC to Hancock Co, GA in 1822 and from Hancock Co, GA to Henry Co, GA in 1832. Calum U was the son of Richard U III (XFD-63). I consider Richard U III to be the Head of an Uphurch Clan. His brother Charles U did some in the Revolutionary War as did his brother Moses U and Nathan U (my greatgreatgrandfather).

Please give me a sketch of your line and I try to give you more detail. Also see flyers enclosed. I hope you will subscribe to U B.

This grave is located on land which was deeded to him as a Revolutionary Veteran. My great-
△ grandfather, Jasper Upchurch, is buried in the vicinity and his grave identifies him as a veteran of the War Between the States.
