### **Nancy Durnal**

Commentary: Nancy Durnal, born about 1791 in Kentucky, married Ambrose Upchurch in 1814 in Warren Co., KY. She survived her husband who died in 1836 in Calloway Co., KY. Ambrose was the son of David Upchurch and the grandson of William Upchurch, IV, the head of Upchurch clan #9. These records help us to trail the family of William Upchurch, IV following the death in Wilkes Co., NC in 1787. A part (all?) of the family were in Greenville Co., SC by 1800, but soon found themselves in KY. A segment of the family moved to Henry Co., TN and another segment to Southern Illinois.
