Commentary: Ann Hamilton was the wife of John III, head of Upchurch Clan 14. John and Ann would marry in Brunswick County, VA and later move to Chatham County, NC.

A. In Brunswick Co, VA Parish of Meherrin Joseph Hambleton (Hamilton) wrote his will 19 May 1780 (recorded Feb 1783) in which he named daughter Ann Upchurch giving her 20 shillings. Searcher writes “Note: Nancy and Nanny are diminutives of Ann as is Nan. Therefore, it seems that Ann Hamilton (Hambleton) married John Upchurch (XID – 157) the son of James Upchurch (XID – 155) who died in Brunswick Co in 1784. Refer to this will and Deed Book 14, Page 240. “John Upchurch and Nanny, his wife, to John Neal...”. John Hambleton also mentions his wife Ann, sons Walter, William, John, Samuel, daughter Elizabeth Ezell, Sarah Sandros. Testors: Benjamin Harrison, Patty Harrison. (5) Samuel Upchurch (the head of the John Upchurch III/ Samuel Upchurch Sub-clan) was born in VA, possibly in Brunswick Co, the son of John Upchurch 2 [John Upchurch, III] and Anne (Hamilton) Upchurch. (2, Page 159)
