**Commentary:** Hinton Hudson was born on 30 Aug 1806 and died on 21 Feb 1871. His first wife was Cynthia Jones, who died in 1850. Later that year he married Armelia Upchurch, the daughter of Hubbard and the granddaughter of Nathan Upchurch, head of Upchurch clan #3.

Deed from William G. Strickland to Samuel W. Atkins 12-16-1858

This Indenture made this the 16<sup>th</sup> day of December in the year of our Lord one Thousand eight hundred and fifty Eight, between William G. Strickland of the first part and Samuel W Atkins of the second part all of the county of Wake and state of North Carolina, Witnesseth that the said WG Strickland for and in consideration of the sum of Six hundred and sixty one dollars and twenty five cents, has bargained and by these doth grant bargain sell and deliver to the said Samuel W Atkins his heirs and assigns forever, a certain (sic) or parcel of land lying on the waters of Swift Creek & bounded as follows to wit, Beginning at a white oak Said Atkins corner, running west 136 pole to a Stake, William Stewarts corner, thence North 154 ½ pole to a Stake PW Dowds Corner thence East 139 pole (sic) to a Stake, Said Dowds corner, thence South 1 ½ degrees West 154 ½ pole to the first station containing one hundred and thirty two and one fourth acres, with all and every the appurtenances thereunto belonging or in any wise appertaining and I do hereby covenant to and with the said Samuel W Atkins that I have before the execution of this deed full right absolute and lawfull authority to sell the said Land and premises, and agree hereby to warrant and forever defend the right and title of the same to him the said SW Atkins his heirs and assigns forever, In witness whereof I have hereunto set my hand and seal the day and year above written

**(no number)** Comments on the family of Hubbard Upchurch 1800-1859, RPU 25 FEB 2011. These comments are derived largely from the will of Hubbard written 31 AUG 1858 and probated MAY 1859 and from a deed made by the heirs of Hubbard on 22 NOV 1859 both preserved in the Biofile of Hubbard, the deed to RPU by Kevin L Hicks on 11 FEB 2011 via email.

The will gives all of his land to son Green Berry Upchurch, on condition that he care for his parents for their lives.

Daughter Lorna given non-real estate items to equal gifts already given to his other children not named.

The NOV 1859 deed is not exactly in sync with the will in that it indicates a dower of land has already been set aside by the widow, nee Esther Byrd (she died in 1864 leaving a will) and the remainder of the property is in the hands of Hubbard's children who sell their undivided shares to their bother Parker Upchurch. The sellers are styled as follows:

1. Armeally (X Her mark) Hudson [Armelia Upchurch] and husband **Hinton Hudson**.

Note that the deed does not mention a daughter of Hubbard named Otela Upchurch [Born 1840 presumed died <1859]. Note that the deed in the first paragraph mistakenly lists Wiley W. Holleman as W. W. Upchurch.

Note that the deed reserves a one-acre cemetery where Hubbard rests. Deed land adjoins Levi Baucom, **Hinton Hudson**, et al, witness George L. Barbee.

Hubbard purchased land in 1823, 1834, 1837- how the three tracts relate to the NOV 1859 deed is unknown. It is presumed to lay just SW of Upchurch Station and is probably what is now Upchurch Farms Subdivision. On 18 JUL 1983 RPU and John Lee Upchurch, Jr. walked the tract looking for the cemetery without success.

Proof that Tabitha Esther Upchurch had the middle name "Esther" is lacking. Hubbard had a sister Tabitha and his wife was Esther.

George Washington Lodge No. 174

George Washington Lodge No. 174, located at Lassiter's Cross-roads, was chartered December 5, 1855. William C Mason was

master; J Broadwell, senior warden; M C Lewter, junior warden; **Hinton Hudson**, secretary; Sims Upchurch, treasurer; William Womble senior deacon; Joseph Bell, junior deacon' and A Barbee, tyler.

Dues for the year 1858 were one dollar per member and 75 members are listed in the lodge minute book.

The cornerstone of the lodge was laid by Columbus Lodge No 102 on September 29, 1859.

In 1882 the lodge moved to Bell's Crossroads and on July 24, 1908, S M Baldwin sold the lodge a lot located behind the present Bell's Baptist Church where the lodge now stands.

With the coming of the New Hope Dam the members of George Washington Lodge will be forced to move from the Bell's Community and the Lodge will probably unite with some nearby lodge.
