# Head of Clan No. 7 and of the 5th Generation

Commentary: James Upchurch V, the head of Upchurch Clan # 7 was born about 1807. In his adult year (1788 – 1807), he is often cited as being active in Dunn Township in Franklin County, NC. His birth in 1768 occurred at about the time his father moved from about ten miles north Dunn Township to Dunn Township itself. Here Richard Upchurch II established an Upchurch enclave that embraces the heritage of about ½ of the present-day American Upchurch family. Some children of James V move to Nash County, NC but there is no evidence that James V moved there. The family of James Upchurch V is ripe for a though study. The tentacles are richly associated with him and local families.

# Deed from Kinchen Strickland to Jon Pace 11-26-1802

This Indenture made the 26<sup>th</sup> day of November in the year of our lord one thousand eight Hundred and two Between Kinchen Strickland of the County County (sic) of Franklin & State of North Carolina of the one part and John Pace of the Said County and State of the other part Witnesseth that for and In consideration of the Sum of Five Hundred pounds to him in hand paid unto the Said Kinchen Strickland the receipt whereof is hereby acknowledged and that I the said Kinchen Strickland Hath given granted Bargained Sold and Possessed & by these presents doth fully & absolutely five grant Bargain Sell and Lien Enfeof (sic) unto the Said John Pace his heirs and assigns forever a Certain Tract or parcell (sic) of Land Situate lying and being on both Sides Mockerson Creek part in Wake and part in Franklin Beginning at the Said Creek at the mouth of Richard Upchurch Branch then the mianders (sic) of Said Branch to **James Upchurch** line along his line to Widowe (sic) Pearce line to Sd Creek thence down the Creek to the sd fork to the fork then up the South Prong to the Mouth of the Grave Rock in Wake County then up Said Branch to a red Oak in Stephen Pearces line then along his line to Corner black oak Nathan Upchurches thence along his to William Ray line thence along his lines to the Said Creek thence up the Said Creek to the first first (sic) Station Containing by Estimation three Hundred acres more it being the land held by Elisha Strickland Deceas'd and given to his son Kinchen Together with the improvements appertaining thereunto belonging Clear of all Manner of Claim Whatsoever To have and to hold the said Land and premises unto the Sd John Pace his heirs and assigns forever and that the Said Kinchen Strickland doth warrant and defend the right and Title of Said Land unto him the Said John Pace his heirs and assigns forever against the Claims of him the Said



Kinchen Strickland his heirs Excrs. Admrs. Or any other person Whatsoever In Witness whereto he the Said Kinchen Strickland hath hereunto set his hand and Seal this day and year above written.

James Upchurch, V age 32\* fills a 45+ slot and is Head of Household Wife unnamed fills a slot 36-45

In 1800 this is a 3-person household with #3 being a male 16 - 26 and would fit Buckner Upchurch age 23 also possibly present in 1790

# RPU Notes 3 Apr 2004

The record for James Upchurch, V is brief and inadequate. His tentative birth date of 1768 may need revision. The allocation of slots and ages for his 1790 household is subject to some uncertainty. As to the birth date of James Upchurch, V:

- \*If born 1768 (as proposed by Clyde Charles Upchurch, Jr) he would have been 22 in 1790 and OK to have had a young wife and 1 or 2 children.
- However the 1800 census shows him as 45+ which exceeds the projected age of 32 in 1800 if born 1768. If 45+ in 1800 he would have been born 1755 or before – possible but not likely.

\*\*The male 0-16 with James Upchurch, V in 1790 has been tentatively designated as a nephew he being tentatively a son of Richard Upchurch, III. However, this male and the  $2^{nd}$  female in the home of James Upchurch, V in 1790 could be children of James Upchurch, V-100 but do not surface in later records. The nephew = Buckner Upchurch.

Alfred A Upchurch born 1805 has tentatively been designated as a son of James Upchurch, V but there is no 1810 household on record and James Upchurch, V is presumed to have died 1807±3 years.

Regarding Birth Date of James Upchurch, V (DOB is generally considered to be born about 1768)



On 1790 census in home of father Richard Upchurch, II as age 16+.

If barely 16 in 1790 would have been born no later than 1774 (but could have been born earlier) [born 1768 = OK]

If 1800 census listing for James Upchurch, V is correct as age 45+.

If barely 45 in 1800 would have been born no late than 1755 (unlikely – RPU) [born 1768 NOT OK]

If 1800 census listing should read 26 – 45 (as was the case with his wife – He would have been born between 1755 and 1774 [born 1768 = OK]

(8) Summary of census records for the children of Janes Upchurch, V born about 1768 (?) Head of Clan

Franklin Co, NC – James Upchurch, V heads a household in 1790 & 1800 in Franklin Co, NC but not thereafter and he is presumed to have died  $1807 \pm 3$  years. A separate summary of census records for James Upchurch, V & his presumed wife shows a record quite inadequate for them. This <u>inadequate</u> situation continues as regards their presumed children:

We have assumed that the young male in the household of James Upchurch, V in 1790 & 1800 is too old to be a son of James Upchurch, V if James Upchurch, V was born 1768. The young male (0-16 in 1790 and 16-26 in 1800 has been tentatively designated as a nephew of James Upchurch, V – possibly Buckner Upchurch born about 1777. If James Upchurch, V was born earlier than 1768 then the young male described above may not be a nephew but could be a son – possibly Peyton Upchurch. This Peyton Upchurch, a presumed son of James Upchurch, V, was a witness in 1813 and thus should have been on the 1790 & 1800 census in his father's home.

One of 2 females in the home of James Upchurch, V in 1790 and the lone female in the home in 1800 is presumed to be the wife of James Upchurch, V.

James Upchurch, V is thought to have had a daughter Penny Upchurch who married in 1813 who could thus have filled one of the female slots in the home of James Upchurch, V in 1790. There is no corresponding slot for such a daughter in the home in 1800.

James Upchurch, V is also thought to have had sons Alfred A Upchurch born 1805, Calvin Upchurch died 1824 & Wilborn Upchurch died 1835. Not slots for them in 1790 & 1800?

In 1839 Alfred A Upchurch lost his wife and made arrangements with William Jackson, brother of his late wife to care for his 7 children until they were grown. The 7 included James Calvin Upchurch. Presumably all 7 are sequestered in the home of William Jackson in 1840. Four of the 7 surface on the 1850 Franklin Co, NC census in the home of William Jackson. James Calvin Upchurch is <u>not</u> among those who surfaced in 1850. "Calvin Upchurch" [James Calving Upchurch] married 3 Oct 1860 Frances W Gupton in Franklin Co, NC.

#### 1860 Franklin Co. NC

Calvin Upchurch [James Calvin Upchurch] age 34 is listed as age 30 and a farmer in the home headed by Littleton Wester – Lewisburg PO.

#### 1870 Franklin Co. NC

James Calvin Upchurch age 44 is listed as 42 and head of household Wife Frances W Gupton 31 is listed as 31.

#### 1880 Franklin Co, NC

James Calvin Upchurch age 54 is listed as 54 and head of household Wife Frances W Gupton 41 is listed as 41.

#### 1900 Franklin Co, NC

James Calvin Upchurch age 71 is listed as 72 and head of clan. Died 1902 Wife Frances W Gupton 61 is listed as 61.

#### 1910 Franklin Co, NC

Frances W (Gupton) widow 71 is listed as 66 and head of household.


Charles provided details on the Riley Family which he happened to notice included nee Penny Upchurch. The document is pages 4, 5 & 6 of <u>Mississippi Genealogical Exchange</u> Vo. 4 1958. This page & the document have been placed in: Bible File for Riley Family & in the Biofile System under Riley Family.

The document shows Michael Riley and Penny Upchurch married on 20 Dec 1813 in the Laurens District of SC. (There is a town Laurens in Laurens Co, SC today – RPU).

It is a strange circumstance that other records show that Reny Upchurch married 20 Dec 1813 (Franklin Co, NC) Michael Riley with Peyton Upchurch as witness at this point the bride is being cross-referenced as Reny Upchurch, Corinna Upchurch and Penny Upchurch.

It is not clear how the bride links to the Upchurch family but our best information is that Peyton Upchurch was the son of James Upchurch – Head of Upchurch Clan No. 7. A further guess is that the bride was a sibling of Peyton Upchurch.

One notes there is a community of Riley in Franklin Co, NC. It had a post office 1873 - 1898. The family name of Riley appears to be rare in Franklin Co, NC in the 1750 - 1850 era – RPU.

Conclude Alfred Upchurch is a grandson of Richard Upchurch, II (XID – 161). The father of Alfred Upchurch by process of elimination, assuming he is legitimate, is most likely Abel Upchurch II (XID – 587) or **James Upchurch**, V. The reason is that the Franklin Co, NC census for 1810 has a **James Upchurch** as head of a household with a male child in it born 1800 – 1810 which is right for Alfred Upchurch born circa 1805. Abel Upchurch II cannot yet be ruled out as he was probably in Wake Co, NC in 1810 and 1820 where the census records for these years are inadequate to help us.
