James W. Upchurch XID – 1123

Commentary: James W. Upchurch was born 1839 in Wake County, NC and died there in 1913. He was the son of Kearney Upchurch, and the grandson of James Upchurch III, who was the son of Richard Upchurch III, head of Upchurch Clan # 4. The details in this Biofile help us to explore further the Upchurch enclave of Wake Crossroads in the St. Matthews Township of Wake County, NC. This enclave was established when Kearney Upchurch moved his family there from Franklin County, NC about 1830. James married a local woman and had eight children. He served in the Civil War in the 1st NC Regiment as did several other Wake County residents including the my grandfather, Bartley Jefferson Upchurch. Both were captured at the Bloody Angle near the Spotsylvania Court House in Virginia on May 12, 1864 and endured imprisonment in Elmira, NY. Barkley and Kearney were 2nd cousins but lived in different parts of Wake County. One wonders if the two soldier cousins figured out their relationship. Most surely they did.

Kearney Upchurch was a pretty wealthy guy, and had a rather large plantation. His house is still standing today, but no one lives in it. A descendent owns it, but I do not know what will happen to it. His plantaion included a cottin gin, and a saw mill. The graves of Kearney and his wife are buried just across the street from the house. He owned slaves, and probably did not treat them well. When I researched the Slave Narratives, a WPA project that Roosevelt had during the depression, where people interviewed still living slaves, I found not so nice things said about his treatment of them. The minute of the Wake Cross Roads Baptist Church, our county's oldest church, are on microfilm at the NC archives. There are quite a few Upchurch's listed in the minutes. Some interesting stories about them, too. James W. Upchurch, Kearney's son, Ivan and Henry's father, was in the Civil War. His record is listed on the attached document. A few years ago, we had a dedication of his Confederate gravestone, which was supplied by the US Veteran's Administration. I am in a Confederate Marine Color Guard, with the Sons of Confederate Veterans, and we performed a service for him.
