

Jamison Upchurch XID – 990

Commentary: Jamison Upchurch was born about 1810 in Franklin County, NC and died after 1870 in Benton County, TN. He was the son of James Upchurch VII and the grandson of Richard Upchurch III, head of Upchurch Clan # 4. We are missing a good analysis of the proper spelling of his name and of the travels that he and his family undertook beyond 1860 and 1870 in Benton County, TN. However, his NC tracks are of much interest. The 400 acres of Franklin County land in which he had an interest appears to the 400 acres Moses Upchurch sold to his nephew James Upchurch VII when, in 1803, Moses moved to Chatham County. The will of James Upchurch VII grants the 400 acres to his daughter Elizabeth Thaney (Upchurch) Phillips for life and then to Jamison Upchurch. Jamison is found in Franklin County in 1810, but by 1850 he had moved to the Cross Roads district in Wake County, NC where his brother Kearney had moved earlier. From there Jamison moved to Tennessee. This move appears to have been financed by the sale of the 400 acre tract into which he had come into possession when his mother died. This sale was to John Phillips, the husband his sister Elizabeth Thaney Upchurch.

Subsequently, the 400 acres fell into the hands of Simeon Rogers who was a fantastic cooperator and is buried on the site. There stands the abandoned 1800s “Mansion” which holds an amazing Phillips history.

Jimmison Upchurch apparently is to get the 400 acres where his father lives but only at the death
of James’s wife Elizabeth Thaney [Butler] Upchurch + he gets ½ slaves at her dead +
participates in proceeds of sale at her death.

To my son KEARNEY – 278 acres on Mocason Creek [joining – CJM 27 Jun 2017] Burkley Upchurch, Larkin Upchurch, John Pearce & others, where he now lives; at my wife's death, I also give him half the negroes I have lent her. To my son JIMMISON – 400 acres where I now live; the other half of my negroes that I have loaned my wife. At my wife's death, the residue of my estate to be sold & the money to be divided among my children & granddaughters as follows: GILLY RAY the wife of James Ray, ELIZABETH PHILLIPS the wife of John Phillips, CLOA COOLEY the wife of John Cooley Jr, THOMAS UPCHURCH, **JIMMISON UPCHURCH** & my granddaughter LECY UPCHURCH.
