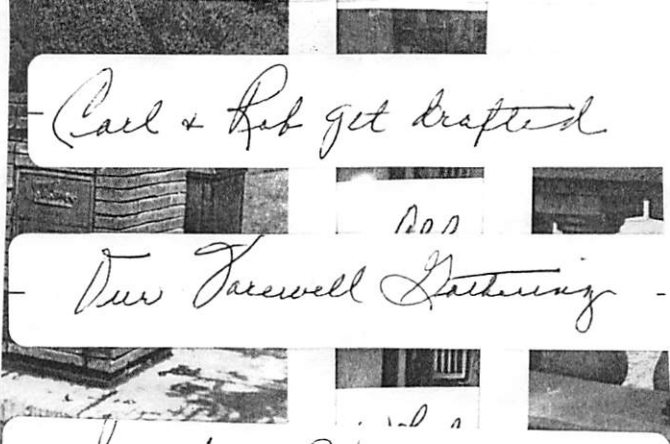

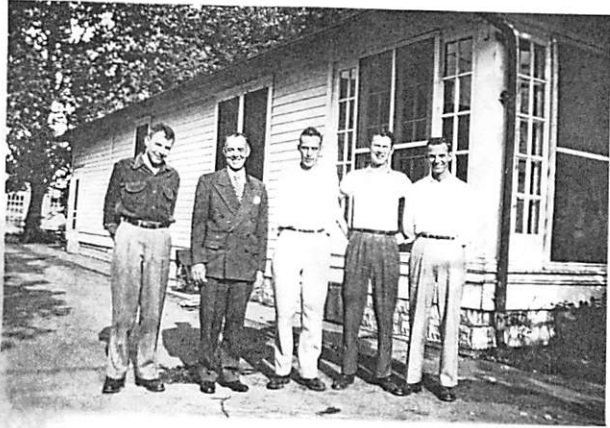

together.

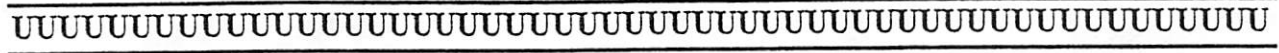
