Dear Cousin Gary,

I want to thank you for your excellent letter of 6 FEB 1989 and for the very fine outline that was attached. I have assigned XID numbers to all the entries and they appeared in the U B Vol 10 No 1. All the names have been entered on the Master outline. There are just a few more Biofile sheets to make and I will do that later today or I will let Angora and Clemson play basket ball over the TV.

A large amount of material has been published on the John U, III case in the U B and we continue to find and publish more all the time John U, III and his family lived about four miles from where I was born and raised in Cent. of North Carolina.

I am glad to get the story straight on which Bramlet was murdered and west. It would be good to have more on that story but I guess we have all that is available.

Can you tell me any more about the family squabble that separated the Warner Ewing Bramblet Family and the circumstances that reunited my, Naomi, and Wilbur in the early 1960's. It sounds interesting. It is nice to deal with more than dates, names and place.

Morgan on page 250 of her Upchurch Book lists only three children of Warner Ewing Bramblet. They are Hesterah, Raymond and Newton. Your list of children of Warner Ewing Bramblet is longer and more complete. However, you do not list a Raymond Bramblet (whom Morgan says died in childhood). Do you have information to confirm or eliminate Raymond as a child of Warner?

The memoirs of Robert Franklin Upchurch which you requested are provided herewith. There is no charge for this. Perhaps you will wish to contribute to the Upchurch Research Fund at some point.

I hope you will be willing to work on adding more details to the Warner Ewing Bramblet outline. What you have done already is just tremendous but there are always changes as time goes by and there are certain details that were not available on the first pass. You know what is needed (missing)

and if you want me to I'll be glad to prepare
a list of questions about what is needed
you asked about children end of week.

There is a common problem as the long term
average is about 1 out of 10 are so born.
From a genealogical standpoint we are not
judgmental on such matters we just want
the facts. However, we do have to be sensitive
about people's feelings. The longer ago the event
happened the easier it is to deal with. There
again some people are not sensitive. You have
to treat each case on its own merits. You
will note that the outline I published in the
U.S. just go through the 4th generation. In
many cases this avoids displaying outline
for people presently living and it avoids
highlighting illegitimacy. However, two registers
of American Ancestors include a complete listing.
In that case you have to put the pieces
together. The registers show the blood relationships
of individuals but give no indication of whether
the parents were married or not. unless you
start searching throughout the registers and even
then the details may not be there. Look up
VED-22125 (Karl & the O'Glen) and XED-²²¹²⁵ (Mary Kathleen Knapp)
for example. All of that helps me handle the
situation in the U.S. Have you handled a

relation in a given case or another matter. I usually try to creep up on the issue by establishing a working relationship through a series of contacts (letter / phone calls). Often the person will reveal what is needed on their own. On rare occasions I am requested not to publish a given fact. I can almost always honor such a request. Sometimes the details are already out in the open somewhere.

I am really pleased to have your interest in the Upchurch family and your active involvement in collecting details. Perhaps you will find someone who wants to subscribe to the U/B or buy some back copies. Some extra order forms are enclosed.

If you so desire I'll be glad to send you a sketch of your line and mine showing how we are related. Please let me know if you have any questions.

— Enclosed you will find a family outline for my
□ + □ great-great-grandfather, Bluford Bramlet, of the John
— Upchurch III Clan (No. 14). An outline of this clan
— was in the Upchurch Bulletin, Vol. 8, No. 2, April 1987.

□ I have updated slightly the information on Bluford
— Bramlet and his children. The rest of the outline is to
— the best of my knowledge correct. I have tried to follow
— the format you use in the bulletin to the best of my ability.
— I hope you can follow it.

△ The one notable error was that Warner Ewing Bramlet
△ was the one murdered. My grandmother, Talitha Ann Bramlet
△ Downey, always told us that her grandfather, Bluford Bramlet,
— went to California to increase his fortune and was never
△ heard from any more. According to Talitha Elder Aaron,
△ writer of the Elder Family History, and neice of Bluford
△ Bramlet by marriage; Bluford had started home from California
— with his accumulated wealth and was murdered on the train.
— The guilty party was never apprehended but the officers got
— so close to him that he committed suicide, so the tale goes.

△ + □ Warner Ewing Bramlet, son of Bluford Bramlet, lived
△ with his grandparents family in the 1870 census, the John
△ Elder family. He and his family went to Oklahoma by
△ covered wagon between 1900 and 1903. W. E. Bramlet died
△ there. His widow and children returned to Saline County,
△ Illinois. About 1915/1916 Jennie Bramlet and her children
— moved to Alton, Illinois. There was plenty of work in the
△ factories of the Alton area. Eliza A. Bramlet, wife of
△ + △ Jamie Allen, lived for many years near Paris, Tenn. Jamie
— Allen farmed a cotton/tobacco plantation there. After the
△ + △ death of Jamie Allen, Eliza moved to the Alton, Ill. area.

Viva Inez Bramlet Owen and her family moved to Texas shortly after the family had moved to Alton, Ill. There apparently was some sort of family squabble. There was no contact with this family for about forty years. Through a series of coincidences the daughters of W.E. Bramlet, Inez, Naomi, and Talitha were reunited in the early 1960's.

I have a question to pose to you. How do you handle situations where the two parents have never been legally married and have children? You may notice two particular instances of this happening. Virginia Mae Duley Murray and Mabel Irene Duley Rodgers both had children by men they were not married to. Irene Rodgers is deceased and her son has lost contact with out family. Virginia Murray lives in Oregon, loves her daughter but does not acknowledge marriage to her father. Please help if you can.

I also noticed in a recent issue of the Upchurch Bulletin you would make available copies of "Memoirs" by Robert Franklin Upchurch. I would appreciate this document and please advise of the cost for such.

Enclosed please find a check for the 1988 subscription to the Upchurch Bulletin. I think your bulletins are very informative and excently researched. I am looking forward to future issues.


