The 1860 and 1870 censuses, however, suggest that these are probably the same person, the correct year of birth being 1845. G.T. Little 1984, *Those Mississippi Upchurch's*, p. 77, however, considers the 1855 date of birth as correct. Their marriage is recorded in the Oktibbeha County, Mississippi, Marriage Book 6, p. 316. N.R. Murray, *Oktibbeha County, Mississippi, 1863-1900 Computerized Index of Marriage Records*, gives the marriage date as 21 January 1870.]
