

Larkins Upchurch Sr.**XID-66**

Commentary: Larkins Upchurch, SR, is the son of Richard Upchurch III, head of Upchurch Clan # 4. Larkins was born about 1791 in Franklin County, NC. There are many good records to show his presence, as an adult, in Franklin County. After 1850, records are not to be found, and we presume he had passed away by that time. More research is needed to determine if his name was Larkin or Larkins.

Since the 1833 will of James Upchurch, VII does not mention a son Williford Upchurch, it is presumed that Williford Upchurch died before 1833 but a best guess is that granddaughter Lecy Upchurch is the daughter of Williford Upchurch. The son Thomas Upchurch, alive in 1833 is yet to be identified otherwise in the records – RPU]

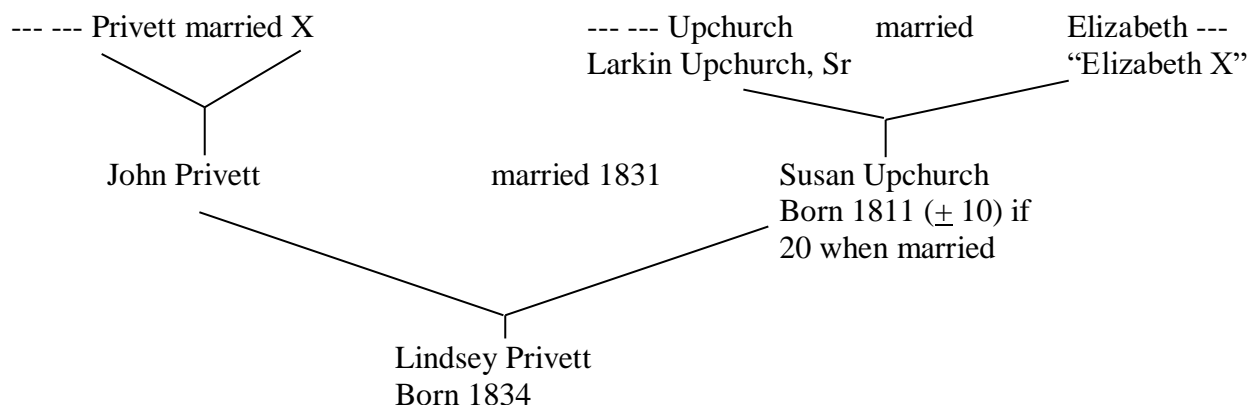

Elizabeth () Upchurch is in home of a married couple in Franklin Co, NC in 1850 & 1860. In 1850 she is shown as age 50 (born 1800). In 1860 she is shown as age 70 (born 1790).

Questions: who was her Upchurch husband?

The couple is Lindsey Privette born 1834 and Fetney Ann E. Denton. Both of whom may have had Upchurch ancestors.

At one point Lindsey Privette born 1834 is said to be the grandson of Elizabeth () Upchurch. This relationship would have to be:



Consider that Elizabeth X born 1795 ± 5 could be wife of Larkin Upchurch [Richard Upchurch, III/ Larkin Upchurch Sub-clan] or wife of Little Berry Upchurch [Jubal Upchurch, I/ Little Berry Upchurch Sub-clan]

Larkin Upchurch:

1830 – His wife 30 – 40 (born 1790 – 1800) but wife’s name thought to be “Ann”. There is room for a daughter 10 – 15 (born 1815 – 1820) [Could be Susan Upchurch who married in 1831 – if born 1815 would have married at 16 = OK]

1840 – His wife 40 – 50 (born 1790 – 1800) [“Ann”?]

Little Berry Upchurch:

1830 – His wife 20 – 30 (born 1800 – 1810) – Elizabeth Barberry Williams – } not a good fit

1840 – His wife 30 – 40 (born 1800 – 1810) – Elizabeth Barberry Williams

However note that Larkin Upchurch ha a grandson born in 1849 in Walker Co, GA. It is possible that Larkin Upchurch moved with his son to GA in the 1840s but he has not yet been found on the GA records 1840 – 1870 - RPU
