Since 2011 we have been including a fifteen-year Law Family Christmas letter Flashback that seems to be popular among our family and friends. So here is a look back to our 2003 Christmas letter. It was written as a letter to Santa. Here is a brief summary of that letter.

All we wanted for Christmas 2003 was 'peace and tranquility'. It was an extraordinarily busy year. Jerry spent the better part of the year dealing with suppliers and customers after his company filed for Chapter 11. He was actually very successful retaining, even growing, all customers and suppliers at improved contractual terms in the relatively short time period...filing the reorganization plan in less than four months from the bankruptcy date.

Jean's responsibilities as VP administration expanded to more mergers, acquisitions, and accreditations in expanding geographies around the U.S. Her industry was receiving some bad press and she was actively working to maintain the company's position as one of the top non-profit services in the money management industry. At the time of the letter writing she had applied to several colleges, received acceptances to some while others remained pending. Her preference seemed to change with the weather. She missed having her big sister around and consulted her often regarding school, friends and colleges.

So slowing down for the holidays was on everyone's wish list. A Christmas celebration at the Colorado LawG Cabin was Santa's most appreciated gift.



FLASHBACK 2001

Since 2011 we have been including a fifteen-year Law Family Christmas letter Flash that seems to be popular among our family and friends. So here is a look back to our 2001 Christmas letter. It was the second year in a row the letter was written by Jillian (then a Freshman at Baylor University) and written totally from her perspective.

Jillian and Lindsey spent that summer attending the American School in Leysin, Switzerland WITHOUT PARENTS (she emphasized). After listing their multiple adventures, classes, performances and travels there, she summarized by saying it was the best vacation ever.

She extolled the very positive experiences of her transition from high school to college student and her good fortune to have a great first roommate (with whom she remains good friends).

Lindsey was doing exemplary work as a sophomore in high school while participating in school plays...and after four years in the band drum line she switched to choir to develop her voice. The Lindsey highlight was receiving her first driver's license.

Jean and I had spent a couple of weeks at our Colorado cabin while the girls were in Switzerland (first time without the girls). Jean was busy with her quilting as an escape from work and I was getting in some golf as part of my work.

She closed the letter very nicely:

"While we can't always visit with one another, we think of our friends often. Even more so after the September events that remind us how precious and unpredictable life is. We wish you peace and joy in this holiday season and throughout the year."

Later, Lindsey wrote about here time at the American School in Leysin, Switzerland. The following is the beginning of that essay.

"As I walked into orientation for the Summer in Switzerland program in Leysin, I gazed over a sea of faces that looked like a patchwork quilt, all different colors and textures. A concert of voices speaking a multitude of languages bombarded me as I threaded my way to a seat. The Swiss Alps attracted me to this program where I planned to study French and explore different cultures, but I never imagined the world I would discover. I met people from over fifty different countries, representing countless languages and religions. This might overwhelm the typical teenage American girl from upper-middle class suburbia. I, however, finally felt liberated.

I was in my element, in a place where I could take advantage of people's differences by learning from them. I jumped at every opportunity to learn about these fascinating people. Everyone opened up. Nobody judged. One of my roommates was Turkish, the other Japanese. The language barriers just made communicating more exciting. I took leadership courses where we worked together, played together, and learned to trust each other. I took a world cultures and religions course in which the diversity of the students brought reality and led to lively discussions. I grew, and I made lifelong friends."

Delighted to hear from you and to have a report on your parents. Starting in 1982 your mother and I had a 20+ year period of intensive sharing of our interests in our shared family heritage. She was exceptionally supportive. Upon receiving your email I enjoyed having a look at her Biofile which contains copies of our many exchanges. Now to your questions. The short answer is that, regrettably, none of the materials to which you refer are available electronically. I started manually in the 1970's and have continued that way. I only got into the electronic world in 2005 after finally deciding I could not outlive it.

On a longer term basis there is some reason for hope. I have established and endowed the Upchurch Collection at N. C. State University in Special Collections. It will eventually hold all of my professional, business, personal, and family history records (forty four drawer file cabinets of the latter). Some of them are already there and I am working on another batch to send this summer. The family history records will not be sent for several more years as I continue to work with them.

The plan is for N. C. State to get key parts of the Collection into electronic format and to make it available on the Internet. The Endowment will eventually provide funds to do this. On my periodic visits from home in MO to NC I continue to press Special Collections to move ahead with pilot projects. In a separate thrust a Cousin In GA has been talking with me for a year or so about coming up with the money to digitize the Upchurch Bulletins (which Special Collections already have) but he is slow to act. He already has a quote from Special Collections as to cost. So, eventually we will get to where you want to be.

On another note, I am somewhat disappointed at the number of members of the extended Upchurch Family who express and interest in their heritage which is so rich and varied. Over the last four decades I had many Cooperators like your mother who were interested takers and givers of information and seemed to take great joy and pride in the collaboration. As these older Cooperators have faded from the scene replacements have not been forthcoming. Even those who find my website seem to have only the most casual interests. I, on the other hand, have found Ancestry .com a fountain of new information which I use daily to enhance my extensive records on the family.

Perhaps you can see why I am so pleased to learn that you find value in the Upchurch publications your mother acquired. My apologies for unloading my frustration on you.




