

Commentary: Lindermond Upchurch, (b 1832 – d 1866), was the son of Hubbard Upchurch and the grandson of Nathan Upchurch I, head of Upchurch clan # 3. He served in the Civil War with two of his Upchurch cousins, but other than that, Lindermond lived his entire life in western Wake County, NC. He married prior to the war, and left behind a widow and one child. His early death at age 34 is likely due to the ill treatment he suffered in a prison at Elmira, NY.

“Upchurch, Lineman, Private resided in Wake County where he enlisted at age 28, July 1862 for the war. Present on account for until captured at Spotsylvania Court House, Virginia May 12, 1864 confined at Point Lookout, Maryland, until transferred to Elmira, NY Aug 6, 1864. Paroled at Elmira on March 14, 1865 and sent to James River, Virginia for exchange, Received at Boulware’s wharf, James River March 18-21, 1865 Admitted to hospital at Richmond Virginia March 21, 1865 with “debilitas” and furloughed for 30 days on March 28, 1865 [Note These are same dates as for his first cousin Bartley Jefferson Upchurch. Another relative of A. Burtess Upchurch (son of Bartley’s and Linderman’s first cousin Golden Almon Upchurch, Sr.) enrolled on same date but was captured later-RPU.

Otela died before May Term 1859- on 1850 census, not named as a survivor of Hubbard.

LINDAMOND UPCHURCH [1862 civil war service] not found after 1862 (RPU has death 1866)

Parker Upchurch-[1863 civil war service] not found after 1863 not named in mother's will written July 21, 1864. This suggests that Parker was deceased by July 21, 1864.

Amelia [RPU styles her as Armelia] died between 1863-1870-on 1860 census has a 7 year old daughter on 1870 census not named in mother's will written July 21, 1864. This suggests that Amelia was deceased by July 21, 1864.

Tabitha died about 1864-on 1860 census, last known child born July 06, 1859 not named in mother's will written July 21, 1864, husband posts marriage bond 30 MAR 1866 W.W. Holleman, Bride: Martha A. Collins assuming 1 year for courting and 1 year for mourning. This suggest that Tabitha was deceased by July 21, 1864.

Lorena, on 1860 census as a 36 year-old spinster not found 1870, not named in mother's will written July, 21 1864. This suggests that Lorena was deceased by July 21, 1864.

Esther Byrd Upchurch dies about August 1, 1864. Will written July 21, 1864 probated August 1864, [possibly 3rd Monday in August].

Names Tabitha and Armelia's children, but not Tabitha or Armelia, This suggests that Tabitha and Armelia were both deceased by July 21, 1864.

Names Theodocias, eldest daughter of Lindamond, but not Lindamond.

Lindamond and Parker have military service 1862(L) and 1863(P) but not in 1864. This suggests that Lindamond and Parker were both deceased by July 21, 1864.

Lorena and Green Berry both named in Hubbard's will, only Green Berry is named in Esther's will. This suggests that Lorena was deceased by July 21, 1864. Green Berry Upchurch died after 1870.

COMPANY G

This company, known as "Washington Volunteers," was raised in Washington County and enlisted at Plymouth on June 24, 1861. On July 3, 1861, the company was ordered to New Bern and from there to Raleigh and then to Warrenton, Warren County. Arriving at Warrenton about July 20, the company was assigned to this regiment as Company G. After joining the regiment the company functioned as a part of the regiment, and its history for the war period is recorded as a part of the regimental history.

The information contained in the following roster of the company was compiled principally from company muster rolls which covered from July through August, 1861; November through December, 1861; March through April, 1862; and June 30, 1862, through December, 1864. No company muster rolls were found for the period prior to July, 1861; for September through October, 1861; January through February, 1862; May through June 29, 1862; or for the period after December, 1864. In addition to the company muster rolls, Roll of Honor records, receipt rolls, hospital records, prisoner of war records, and other primary records, supplemented by state pension applications, United Daughters of the Confederacy records, and postwar rosters and histories, all provided useful information.

LATHAM, LOUIS CHARLES

Resided in Washington County and appointed Captain at age 20 to rank from May 16, 1861. Wounded in action at Sharpsburg, Maryland, September 17, 1862. Present or accounted for until transferred to the Field and Staff of this regiment upon appointment as Major to rank from December 14, 1863.

WHITEHURST, NEHEMIAH J.

Resided in Washington County and appointed 1st Lieutenant at age 35 to rank from May 16, 1861. Promoted to Captain to rank from December 14, 1863. Captured at Spotsylvania Court House, Virginia, May 10-12, 1864. Confined at Fort Delaware, Delaware, until released after taking the Oath of Allegiance on June 16, 1865.

LIEUTENANTS

COKE, LUCIUS C., 3rd Lieutenant

Resided in Washington County where he enlisted

at age 24, July 23, 1861, for the war. Mustered in as 1st Sergeant and appointed 3rd Lieutenant to rank from September 19, 1861. Present or accounted for until transferred to the Field and Staff of this regiment upon appointment as Assistant Surgeon on June 12, 1862.

HARGETT, JOHN M., 2nd Lieutenant

Resided in Craven County and appointed 2nd Lieutenant at age 20 to rank from December 27, 1862. Present or accounted for until captured at Spotsylvania Court House, Virginia, May 10, 1864. Confined at Fort Delaware, Delaware, until transferred to Hilton Head, South Carolina, August 20, 1864. Transferred to Fort Pulaski, Georgia; back to Hilton Head; and then back to Fort Delaware on March 12, 1865. Released at Fort Delaware after taking the Oath of Allegiance on June 19, 1865.

HOLLIDAY, SAMUEL S., 3rd Lieutenant

Resided in Washington County and appointed 3rd Lieutenant at age 26 to rank from May 16, 1861. Resigned on July 31, 1861.

LATHAM, JULIAN A., 1st Lieutenant

Resided in Washington County and appointed 2nd Lieutenant at age 18 to rank from May 16, 1861. Wounded in action at Chancellorsville, Virginia, May 3, 1863. Promoted to 1st Lieutenant to rank from December 14, 1863. Present or accounted for until captured at Spotsylvania Court House, Virginia, May 10, 1864. Confined at Fort Delaware, Delaware, until transferred to Hilton Head, South Carolina, August 24, 1864. Transferred to Fort Pulaski, Georgia, around October 20, 1864, and then back to Hilton Head on December 26, 1864. Transferred back to Fort Delaware on March 12, 1865. Released at Fort Delaware after taking the Oath of Allegiance on June 16, 1865.

MILLER, JOHN S. R., 3rd Lieutenant

Appointed 3rd Lieutenant to rank from August 23, 1861, but transferred to the Field and Staff of this regiment upon appointment as Adjutant, 1st Lieutenant, to rank from May 16, 1861.

Bartley Jefferson Upchurch served in Company G. 1st Regiment NC State Troops organized 3 JUN 1861 at Warrenton, Warren County, NC. 1st and, 2nd, 3rd Regiments NC Troops served together.

Captured at Farmville, Virginia, April 2, 1865, and confined at Point Lookout, Maryland, until released after taking the Oath of Allegiance on June 21, 1865.

UPCHURCH, B. J., Private

Resided in Wake County where he enlisted at age 21, July 15, 1862, for the war. Admitted to hospital at Richmond, Virginia, October 2, 1862, with "shock of arm from explosion of shell." Transferred to hospital at Danville, Virginia, January 8, 1863. Wound described on transfer as "contusion shoulder." Returned to duty February 27, 1863. Present or accounted for until wounded in the hand at Payne's Farm, Virginia, November 27, 1863. Reported as absent wounded through December, 1863. Captured at Spotsylvania Court House, Virginia, May 12, 1864, and confined at Point Lookout, Maryland. Transferred to Elmira, New York, August 6, 1864. Paroled at Elmira on March 14, 1865, and sent to James River, Virginia, for exchange. Received at Boulware's Wharf, James River, March 18-21, 1865, in exchange. Admitted to hospital at Richmond, Virginia, March 21, 1865, and furloughed for 30 days on March 28, 1865.

Resided in Wake County where he enlisted at age 28, July 15, 1862, for the war. Present or accounted for until captured at Spotsylvania Court House, Virginia, May 12, 1864. RPU Note: In 1850 Allen Maynard was in a household with Group "A" Franklins and in 1860 with Group "B" Franklins. The connections between "A" and "B" not yet established nor is the relationship of Allen Maynard to either "A" or "B" established. I will hypothesize that Elizabeth Franklin born 1813 was nee Elizabeth Maynard born 1813, sister of Allen Maynard. It is known that Adeline Franklin married **LINDERMOND UPCHURCH** son of Hubbard Upchurch and grandson of Nathan Upchurch I, Head of Clan-13 JUN 2008.

(21) Comments on the family of Hubbard Upchurch 1800-1859, RPU 25 FEB 2011. These comments are derived largely from the will of Hubbard written 31 AUG 1858 and probated MAY 1859 and from a deed made by the heirs of Hubbard on 22 NOV 1859 both preserved in the Biofile of Hubbard, the deed to RPU by Kenn L Hicks on 11 FEB 2011 via email.

The will gives all of his land to son Green Berry Upchurch, on condition that he care for his parents for their lives.

Daughter Lorna given non-real estate items to equal gifts already given to his other children not named.

The NOV 1859 deed is not exactly in sync with the will in that it indicates a dower of land has already been set aside by the widow, nee Esther Byrd (she died in 1864 leaving a will) and the remainder of the property is in the hands of Hubbard's children who sell their undivided shares to their bother Parker Upchurch. The sellers are styled as follows:

1. Armeally (X Her mark) Hudson [Armelia Upchurch] and husband Hinton Hudson.
2. Tabbitha (X Her mark) Holleman [Tabitha Esther Upchurch] and husband shown as Willie Holleman but signed as [Wiley W. Upchurch]
3. G.B.U. [Green Berry Upchurch]
4. Lindermon (X His mark) Upchurch
5. Lorena (X Her mark) Upchurch [Note: Born 1824, still single 1859 Age 35]

Note that the deed does not mention a daughter of Hubbard named Otela Upchurch [Born 1840 presumed died <1859]. Note that the deed in the first paragraph mistakenly lists Wiley W. Holleman as W. W. Upchurch. Note that the deed reserves a one-acre cemetery where Hubbard rests. Deed land adjoins Levi Baucom, Hinton Hudson, et al, witness George L. Barbee. Hubbard purchased land in 1823, 1834, 1837- how the three tracts relate to the NOV 1859 deed is unknown. It is presumed to lay just SW of Upchurch Station and is probably what is now Upchurch Farms Subdivision. On 18 JUL 1983 RPU and John Lee Upchurch, Jr. walked the tract looking for the cemetery without success. Proof that Tabitha Esther Upchurch had the middle name "Esther" is lacking. Hubbard had a sister Tabitha and his wife was Esther.

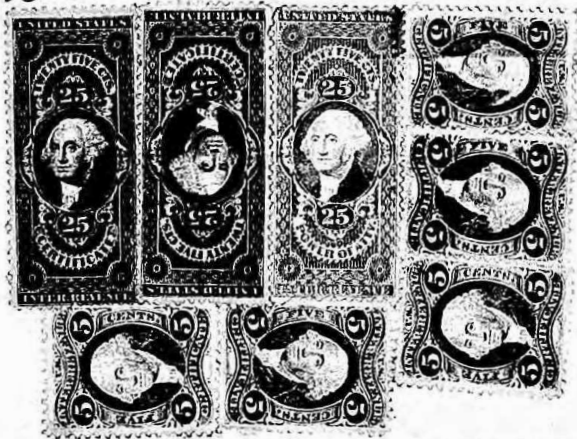
