MARIAH ELIZABETH UPCHURCH

Commentary: Mariah Elizabeth Upchurch was born in 1820 and died in 1900. She lived her entire life in Wake County, NC. She was blind from birth and never married. She lived her entire adult life with her half-brother Bartley Jefferson Upchurch, my grandfather. I grew up hearing my aunts and uncles talking about their Aunt Mariah. Through family lore I have more to relate about my great-Aunt Mariah.

There is a marriage record in Wake County, NC of one Gilbert Upchurch to an Elizabeth Upchurch. Circumstances essentially dictate that this couple were the parents of Mariah. Her mother disappeared from the record and Gilbert subsequently took on a new wife, Lucretia Mills and they produced nine children.

So how does the 1818 bride, Elizabeth fit into the family? Theoretically she could have been a member of the Moses Upchurch or the Nathan Upchurch I clan, being as both families having settle on the Wake/Chatham border about 1805. However our knowledge of these two clans suggests that the 1818 bride could not have come from these two clans. It is my strong conviction that Elizabeth Upchurch was of the John Upchurch III clan that had settled earlier on Shaddocks Creek in Chatham County just a few miles south of the spot where Moses and Nathan later settled. John Upchurch III had three sons whom we know very well. He also had five daughters, one of whom was most likely the Elizabeth who married Gilbert in 1818. This union thus linked the John Upchurch III and the Nathan Upchurch I clans. More research to support my claims would be most helpful.

Lucretia Mills, daughter of Naaman Mills and ______, was born 3 May 1802 in Edgecombe County, NC and died 26 Sep 1877. She married after May 1823 Gilbert Upchurch (born ca 1792, died ca 1845), son of Nathan Upchurch and Mackey Johnson. For more information see ch. COURT DATES ETCHED IN TIME (May 1823 – page 51).

Lucretia is buried at Inwood Baptist Church Cemetery, Wake County, NC. Gravesite marked with tombstone. A memorial tombstone is also placed there for Gilbert – his *actual* burial site is not currently known.

On Federal Census /1830, Lucretia and her children fit the description of Naaman Mills' household in Wake County NC. On Federal Census /1840, Gilbert is listed as head of a household in Wake County NC.

After Gilbert's death, Lucretia and her family resided in Wake County, NC (White Oak Township) on Federal Census 1850-1860. In 1860, Lucretia owned real estate valued at \$72 and a personal estate valued at \$200. Lucretia

resided in Wake County, NC (Barton's Creek Township) with her son, Bartley and family on Federal Census 1870. Lucretia lived to age 75.

Allegedly, Naaman Mills' Bible was passed down to Gilbert and Lucretia's descendants. According to various writings: "Lucretia's family started to move to Tennessee in 1812, but they stopped in Green Level, NC and bought a farm and settled there. She had five brothers and was the only girl. Her brothers were all farmers – very honorable people, but never rich. Her father was Naaman Mills. We have his Bible, which was printed in 1769."

The balance of this chapter will list the children and descendants of Lucretia Mills and Gilbert Upchurch. NOTE: The first child, Mariah may not have been Lucretia's child. The ten children:

Page 92 – 1. MARIAH ELIZABETH UPCHURCH, daughter of Gilbert Upchurch and ___, was born 19 Jul 1820 in NC, and died 30 Dec 1900. She is buried at Inwood Baptist Church Cemetery, Wake County NC. Mariah was blind, according to Federal Census 1850. She resided in Wake County NC (White Oak Township) with Lucretia Upchurch and family on Federal Census 1850-1860; (Barton's Creek Township) with Bartley Upchurch and family on Federal Census 1870 and (Swift Creek Township) on Federal Census 1880. Mariah was one of the founding members of Inwood Baptist Church, Wake County NC. She lived to age 80.

RPU comments regarding above. All known information fits the above proposal that <u>Mariah Elizabeth Upchurch</u> was a child of Gilbert Upchurch and his first wife Elizabeth Upchurch whom he married in 1819. However, I know of no rationale for the proposal that <u>Mariah Elizabeth Upchurch</u> and Marie Upchurch were the same. Uncle Gettys told me Gilbert Upchurch had five daughters. Sister Perry (Lena Perry) told me one of the five was named Marie. Sister Perry knew enough not to confuse Marie and <u>Mariah</u>. – RPU - 11 Apr 2001

14) UPCHURCH INSANITY RECORDS – on 8 Sep 2011 Kay Lind Slappey sent RPU 6 emails regarding insanity of four members of the Nathan Upchurch I clan which I have coded to show pages = A10, B6, C15, D13, E55, F34. The pages are filed in the biofiles of the four as shown in the boxed names below. All four were declared legally insane an INDIGENT and committed to the Florida Asylum for the insane (Florida State Hospital) at Chattahoochee, Gadsden, Florida. The documents were shared with Margaret Louise Harris on 10 Sep 2011. RPU – Extract 29 Nov 2013

More research would be required to conclude that an "insanity" genetic trait existed in the Nathan Upchurch I clan. In any family + and – traits are distributed unevenly. With today's medicines some or all of the four might have led more or less normal lives outside of an institution. At this remove we cannot know what environmental conditions may have contributed to their ill health. It is a surprise that all four were declared indigent in view of the wealth of the family – but we judge from afar. The available records fail to show much family concern for those incarcerated (except for Rebecca) but more evidence is needed.

15.) Was blindness among the descendants of Nathan Upchurch, I related to the cases to the cases of insanity in the family. (See RPU Extract 29 Nov 2011) – RPU 30 Nov 2011.

By reference to the 29 Nov 2011 Extract Sheet it will be seen that the insanity / blindness cases all involved descendants of Nathan's son Gilbert Upchurch. Gilbert's son Nathaniel Smith Upchurch had two sons and one granddaughter declared insane (Susie).

Susie was also a granddaughter of Gilbert's son William George Upchurch (due to intermarriages in the family.)

[In the Extract I explain how these cases of insanity could have been the "luck of the draw" and how modern medicine might have made unnecessary the pejorative term "insanity". However, in the case of Susie, one cannot overlook the two close marriages of four of her ancestors (two couples). Susie and her full siblings did not show robust health records.]

The blindness involved the other sons of Gilbert – Bartley, Lamberth, and Mariah. The latter two were blind (completely or partially?) (from birth?). My unsubstantiated guess has always been that the blindness of these two <u>could</u> have traced to venereal disease introduced by Gilbert as he had some known weakness of character. These two children had different mothers.

Bartley had a great-granddaughter, Frances Holt Tilly who developed complete blindness as an adult. Her years of explaining her condition led her to believe that her blindness was hereditary and thus connected to that of Lamberth and Mariah.

In conclusion, I have developed no connection that the insanity or blindness cases are genetic in nature or that they are related. Others with more expertise may show genetic causes.
