I noticed a few errors in the family tree of George Upchurch line.

#1 Sarah Jane Matthews Bunch married to Joseph Upchurch is in fact Sarah Jane Matthis daughter of Andrew Matthis (Mathis). It clearly states this on her death certificate. She was born 15 Sept. 1925 and died 26 March 1915. They are my 2x great grandparents.

#2 Martha Bunch is not the child of Joseph Upchurch. Sarah "Sallie" was previously married to Robert Bunch who died in 1853.

#3 Lucinda C Upchurch (the daughter of Sarah and Joseph) did not die in 1966. She died approx. 1901. According to the obituary of her husband James C. Baker he married Lucetta Burchett-Whitehead on March 1, 1902 after the death of his first wife Lucinda. She is on the 1900 Census records and that's the last I can find her.
