① 15 APR 1996 - The name of John Ray Maxwell came up while visiting Grimes Co, TX in the context of him having been responsible for a cemetery book on Grimes Co, TX. His phone no (409) 394 8273. He was visited the next day (16 APR 1996) and a copy of his book obtained. Notes of that visit with him are as follows:

16 APR 1996 (TUE)

Breakfast HI - College Station - called John R. Maxwell in Lela, Grimes Co, TX and arranged to meet him at 8:30. I purchased a copy of the cemetery book for North Grimes Co, TX. Met him at the Masonic Lodge in Lela and got the book and had a nice chat. His ancestors have lived in the area since the mid 1850's.

He did not know any of his extended family who had anyone in the extended family. However, he knew of the A family and especially talked about RELU, I passed down by his father and others. It was well understood in the community that RELU, I had a track for making money. It was generally believed in the community (according to the father of John R. Maxwell and others) that RELU, I paid serious attention to females in the community and it was believed he had children by some of them. None of this has ever been verified and no specific child of RELU, I by any of these persons has ever been identified. John's father passed to him as true a story that RELU, I

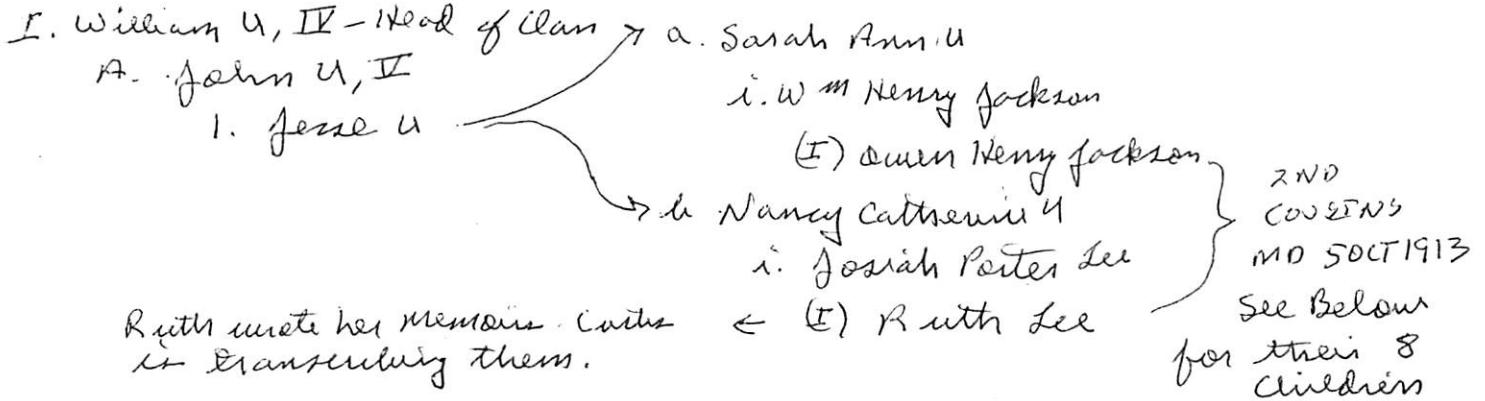

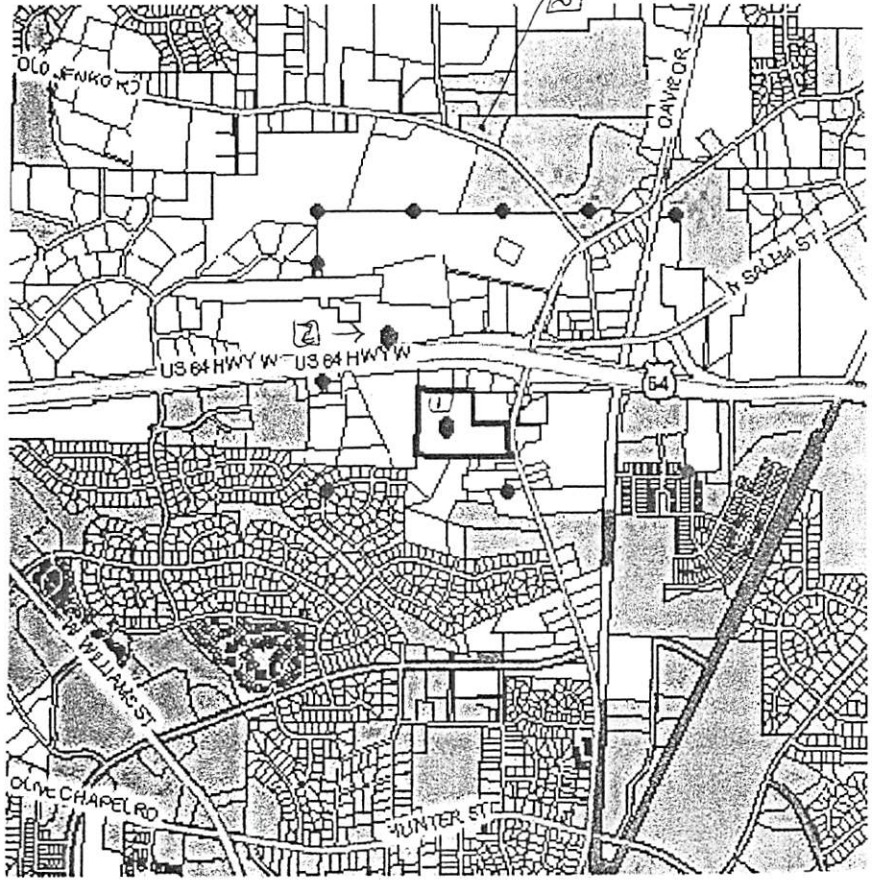
