This claim was for \$270 for fodder, oats and a mule taken by the Yankees. Claim 17026 was submitted by William W Holden, Attorney in Raleigh and by his firm Cutts & Holden in Washington, DC. The claimant and witnesses all claimed they were strong Union people (not convincing to me – RPU). In spite of this pandering, the claim was rejected with the note: "All circumstances show him disloyal" – 32. Testimony taken in Raleigh, NC on 11 Oct 1872 – W W Holden present.

Deposition of Claimant William Jinks – He is 51 (born 1821), Page 1: lives at Green Level, Wake Co, NC – Is blacksmith and farmer. On 16 Apr 1865 Yankees came to his farm with 9 wagons and 18 – 27 men and took oats and fodder to take to camp at Holly Springs for the USA 14th corps. He and **Britton Mills** (4) had been to camp at Holly Springs and met the wagons on the way back. He and **Britton** live 1/2 mile apart. Earlier the Yankees had taken a mule he loaned to wife's uncle – Mr Whitehead.

Deposition of Witness John X Upchurch age 51 (born 1821). Pages 18-21 [John R Upchurch XID -3418 – son of Ruffin Upchurch] lives $1\ 1/4$ miles from William inks. John went into salt works rather than go into CSA service. He was a Union man and a CSA deserter and went into the bushes to hide as did the claimant.

G E Olds was also a witness, Page 11

Deposition of Witness William Steadman Jinks, age 21 (born 1847) Pages 22 -2 6. Is a son of claimant. He was with his father when he met the wagons. The Holl Springs Camp lasted 15 days. The mule loaned to the very old Lazarus Whitehead 5 miles away in Morrisville.

Loyalty Test – Page 12 – owned 250 acres, 100 tilled – was constable – elected 1864 – Page 12, 32. Was drafted but never served – hired a substitute. All Jinks were opposed the war – but 2 brothers served CSA – Page 15.

Matthew Mills, son of Naaman Mills and ______, was born 1789 in Edgecombe Co., NC, and died 1854. He had a twin brother, Britain Mills. Matthew married 3 Jan 1822 Piety Wade (b ca 1800, d ca 1854). They were married in Wake Co., NC - bondsman was John Mills. They are buried at Mills Fam. Cem., Apex, NC - gravesites marked with fieldstones.

The full will appears on Page 40 in the Book and a copy is in the Biofile of Nathan Mills. It was written 14 Mar 1872. It recognizes 11 of the 12 children excluding daughter Sarah Mills who died at 18 in 1855 presumably single and without issue. The 11 are treated differently – perhaps he had given to some already or perhaps they were less needy of less worthy. Sons Joseph and Nathan – executors.

Of the 4 children of his first wife the heirs of James Mills who died in 1856 were left \$2 each – not much. Green Clemmons Mills and <u>Britton T Mills</u> were left \$10 and \$20 respectively. The 4th child Martha L (Mills) Babb was left \$10 and shared in te non-real estate residue.

The seven living children of the 2nd marriage all were to share in the non-real estate residue. They were Julia Ann Mils, \$10, Joseph Hinton Mills, \$10, Ann Eliza Mills \$2, Nathan Manly Mills, John Haywood Mills, William Henry Mills, and Isley Jane Mills \$60. Julia and Jane, being single, had claim on the house until marriage or death. Sons Nathan John and William Henry got 54, 54, and 60 acres designated. Remainder of real estate [120 acres] to be equally divided between 4 sons of 2nd marriage – Joseph, Nathan, John and William Henry. Nathan promised Nathan a horse/mule or \$50 and William Henry a horse/mule or \$100.

Nathan left all property not devised to wife nee Candis Wilson for her life or widowhood [so when was what disbursed??]

In this case it is ordered and adjudged by the Court, that the defendant, Britton Mills is the father of an illegitimate child begotten on the body of Candis Upchurch, single woman. It is further ordered that the said defendant enter into bond with approved security for the support of said child. That he pay the sum of ten dollars for lying in fee and ten dollars for five years to the said Candis Upchurch. And thereupon the said defendant enters into bond in the sum of two hundred dollars, with Matthew Mills as his security."

28. Feb 1845 – Page 420: "State of North Carolina to use of Candis Upchurch vs. **Britton Mills**, Jr, Matthew Mills} Shadrack Mills & Elijah Wilson, witnesses summoned to attend this court



and testify on behalf of the defendants, being solemnly called out, and failing to appear, as they were bound to do. On motion, judgment vise is granted against them for the sum of \$40 each."

29. Feb 1845 – Page 536: "The State of North Carolina to Use of C. Upchurch vs **Britton Mills** and Matthew Mills} Same jury as in No 5, duly sworn & empowered to try. Finds that the penalty of the bond declared on, is two hundred dollars, and that the same is the act & deed of the defendants, and assess the plaintiff's damages to find costs. Judgment of the Court accordingly and for costs."
