

858 ACREL N. PEARCE

Acrel was a prominent farmer and merchant in Southeastern Franklin County. He owned and lived on the lands now known as the Pearces Community. He controlled lands his Great Grandfather Nathan and Grandfather Phillip received in land grants in 1779 on both sides of Moccasin Creek, some of which was in what was then Wake County. He lived and is buried near the intersection of Pearces Road and Johnsontown Road. The house was moved and the cemetery plowed over, ironically by a Great grandson.

Acrel was born June 21, 1814 to Nathan Pearce (son of Phillip and Susan Upchurch, daughter of Richard Upchurch, Jr.). <u>He had</u> eight brothers: Burrell, Seth Thomas, Franklin, Peter, Paul, Silas, Soloman, Siemon, and sisters Frances, Susan and Nancy. Acrel married Obedience "Bedie" Denton, daughter of James Denton on August 22, 1834 in Franklin County.

There children were: Harvie, circa 1835; Sarah, July, 1836 (m. Kearney W. Perry); John Calvin, October 26, 1838 (m. Lenora Jane Pearce, daughter of Benjamin Pearce and Elizabeth Upchurch); Abraham "Abel", circa 1841; (m. Delilah Mitchell, daughter of Pemberton Mitchell); James, circa 1845 (m.

Mary Jane Pearce, daughter of Seth Thomas Pearce and Charlotte Pearce); Kearney, September 14, 1846 (m. Candis Phillips, daughter of Presley J. Phillips and Mary A. John, Lee, James, and Kearney served with the North Carolina Troops during the War Between the States and survived the war. Lee and James died young from effects of imprisonment at Point Lookout POW Camp. John and Kearney remained in the Pearces Community and lived near where the church and school are located. Some of their descendants still live there. John and wife Jane donated the land where the Pearce Amny Baptist Church now stands. They also donated the trees that were cut for lumber for the first building.

John Calvin and Lenora Jane had three children: Joshua Jefferson, Winnie, and Jonah Robert Lee.

Joshua married Minnie Stallings, daughter of Atlas J. Stallings and Agnes C. Baker. To them

In 1863 the heirs of the late John Pearce petitioned to have her 1125 acres in Franklin Co, NC divided among his 9 children (heirs). In 1866 the commissioners awarded his daughter Lucinda (Pearce) Mitchell and her husband <u>Pemberton Mitchell</u> 187 acres which they in turn sold to Benjamin Pearce in 1870.

Lucinda Pearce, b 1810, d 24 May 1875 and Pemberton Mitchell, born circa 1804 in Wake County, died 1872 in Wake County. I can only guess that they were buried in the Mitchell Family Cemetery on the border of Wake and Franklin cos. These two people were my great great grandparents. It could be that John Mitchell and Winnie Alford is Pemberton's parents, but I cannot prove it. It seems that I have come to a dead end. Do you have information that identifies the parents or siblings of <u>Pemberton Mitchell</u>?
