**BELL, Essie Ira vs Joris Richmond BELL**

Divorce was granted during March term of Superior Court 1920, and child custody given to Pl. Pl alleged that she had been a resident of Wake Co. for more than 2 years, and Def was a Wake Co. resident also. They were married on 18 July 1916 and lived together until about 1 Mar 1917. Pl further alleged that about 1 Mar 1917 "and at various other times thereafter and prior thereto," the Def committed adultery with Eva MULLIN and with other women unknown to Pl. Essie Ira and Joris BELL had one child, Joris R. BELL.
