Commentary: William and John Robinson Newbold b 1815 – 1820 were sons of William Newbold who was born about 1787 in Onslow County, NC. The Newbolds moved to Johnson County, Illinois where both sons married Upchurch girls who were daughters of David Upchurch of the William IV Clan.

1. John R.⁶ NEWBOLD (William⁵, Levi/Levy⁴, John³, Thomas², Thomas¹) was born Bet. 1815 - 1820 in Onslow County North Carolina, and died Bef. 1860 in Illinois'. He married Mary Upchurch 13 Aug 1842 in Johnson County Illinios². She was born Abt. 1825 in Tennessee³, and died Aft. Jul 1860⁴.

Notes for John R. NEWBOLD:

A researcher of James Oliver NEWBOLD born in 1853 reported that she has a death certificate for James that noted his parents were "Jack" NEWBOLD and "Polly Upchurch". Jack is a common alternate name for John, and Polly is also a common alternate name for Mary. Mary Upchurch married John R. Newbold in 1842. John R. Newbold and Mary Upchurch were almost certainly "Jack" and "Polly" Newbold parents of James Oliver Newbold.

Other than the record of John getting married to Mary Upchurch in 1842, there was virtually no other mention of this individual found in the record. He was not found on the 1850 Federal Census nor on the 1855 Illinois State Census.

He was probably the male listed in the age 20 to 30 column in his father William Newbold's household on the 1840 Census in Johnson County Illinois, and the male in the 10 to 15 column in William Newbold's household on the 1830 Census in Onslow County Illinois. It was from these assumptions that his birth year estimate of between 1815 and 1820 was derived.

The 1990 "History of Johnson County and Families" [page 289] noted only that:

"John R. NEWBOLD (dead by 1860) married Mary Upchurch".

And:

"John R. NEWBOLD's widow and children stayed in the county near Ozark and Reynoldsburg."

Ozark and Reynoldsburg are small communities in Johnson County Illinois.

The 1860 Federal Census for Johnson County listed Mary NEWBOLD as a head of household. She was listed as being 35 years of age and born in Tennessee. Listed with her were 4 children: Elizabeth age 17; Mary age 10: John O. age 7 [James]; and Kate age 3. Living in households listed 2 before her and 2 after her were households headed by Upchurches, her maiden name. This proximity, plus her name, of course, indicated that this was Mary Upchurch Newbold, and probable widow of John R. NEWBOLD as of the 1860 Census.

No further evidence of Mary Upchurch Newbold was found.

On the 1850 Federal Census, a Timothy NEWBOLDS, age 9 (1841) and born in Illinois, was listed in Williamson County Illinois (county that bordered Johnson to the north) living with the "Seaborn Prichard" family [several Prichard familes living in close proximity].

He was almost certainly not a child of William and Alice NEWBOLD, since Alice was over age 50 at the time.

There were two sons of William and Alice Newbold whose marriage date was not found: John R. Newbold and Thomas Newbold. All of William's other sons were known married in 1842 or later.

The eldest known child of John and Mary Upchurch Newbold was Elizabeth Newbold, who was age 17 (1843) on the 1860 Federal Census in Johnson County in her mother's household.





The eldest known child of Thomas Newbold may have been Margaret, who was age 20 on the 1860 Census in Union County in her father's household. Or it may have been George, who was age 14 (1846) on that same Census. Margaret could have been a second wife.

On the assumption that any Newbold/Newboles/Newbolds individual in the Johnson/Union/Williamson County Illinois area circa 1850 was most likely related to William and Alice Newbold or their descendants, then Timothy was probably the son of one of these two individuals, neither of whom could be found on either the 1850 Federal Census or the 1855 State Census in any of the counties in southern Illinois.

The 1860 Federal Census for Union County Illinois listed Thomas Newbold and his family. Among those listed were 4 children born to Thomas and his unknown wife between 1846 and 1858 in the state of Missouri. This makes it less likely that Timothy was a son of Thomas than a son of John. However, why Timothy was in the Richards household, and where were his parents living, are questions without answers.

In addition, no further record for Timothy Newbolds was found.

As to the four "known" children of John R. and Mary Upchurch Newbold, the following was found:

Elizabeth Newbold. The 1870 and 1880 Federal Cenuses showed additional evidence of Elizabeth NEWBOLD. On the Ancestry.com Web site, a record showed for a "Giles Taylor" born about 1880 in Johnson County Illinois. His parents were listed as Samuel Taylor and Mary Elizabeth NEWBOLDs. Using this information, the 1870 Federal Census for Johnson County for the area covered by the Reynoldsburg Post Office found one Samuel Taylor and wife Elizabeth, both age 23. Living with them was Ann NEWBOLES, age 15. These ages would equate to birth years of about 1847 and 1855, respectively.

To further support them being the children of John R. NEWBOLD, Samuel Taylor and wife "Lizzie" appeared on the 1880 Federal Census in Johnson County Illinois. She was listed as age 33, with parents both born in Kentucky. And yes, Giles Taylor, age 3 months, was also listed as their youngest child. This information does track fairly well with the sparse information from the 1990 Johnson County History, and the record about Giles Taylor listed in the on-line database.

Finally, James Oliver NEWBOLD, who was a son of John R. NEWBOLD, is found living in the household of one William Harper on the 1870 Federal Census in Johnson County in the Reynoldsburg Post Office area. Thus, one finds the one certain child of John R. NEWBOLD in the Reynoldsburg P.O. area as per the 1990 Johnson County History, and one also finds the probable two daughters of John R. NEWBOLD on the 1870 Census in the Reynoldsburg area.

The Ann NEWBOLES listed on the 1870 Federal Census might be "Kate" listed as 3 years old with mother Mary Upchurch NEWBOLD on the 1860 Census. Or it could be another child of John and Mary Newbold not otherwise known. But certainly a relative, to be living with Elizabeth Newbold Taylor in 1870.

Notes for Mary Upchurch:

A Mary NEWBOLD was found listed on the 1860 Federal Census in Johnson County Illinois as a head of household. She was listed 35 years of age and born in Tennessee. Listed with her were 4 children: Elizabeth age 17; Mary age 10; John O. age 7; and Kate age 3. Living in households listed 2 before her and 2 after her were households headed by Upchurches, her maiden name. This proximity, plus her name, of course, would indicate that this was Mary Upchurch who married John R. NEWBOLD in 1842. An assumption was that her husband is deceased for her to be listed as head of the household.

Descendants of John R. NEWBOLD

Generation No. 1

1. John R.⁶ NEWBOLD (William⁵, Levi/Levy⁴, John³, Thomas², Thomas¹) was born Bet. 1815 - 1820 in Onslow County North Carolina, and died Bef. 1860 in Illinois¹. He married Mary Upchurch 13 Aug 1842 in Johnson County Illinios². She was born Abt. 1825 in Tennessee³, and died Aft. Jul 1860⁴.

Notes for John R. NEWBOLD:

A researcher of James Oliver NEWBOLD born in 1853 reported that she has a death certificate for James that noted his parents were "Jack" NEWBOLD and "Polly Upchurch". Jack is a common alternate name for John, and Polly is also a common alternate name for Mary. Mary Upchurch married John R. Newbold in 1842. John R. Newbold and Mary Upchurch were almost certainly "Jack" and "Polly" Newbold parents of James Oliver Newbold.

Other than the record of John getting married to Mary Upchurch in 1842, there was virtually no other mention of this individual found in the record. He was not found on the 1850 Federal Census nor on the 1855 Illinois State Census.

He was probably the male listed in the age 20 to 30 column in his father William Newbold's household on the 1840 Census in Johnson County Illinois, and the male in the 10 to 15 column in William Newbold's household on the 1830 Census in Onslow County Illinois. It was from these assumptions that his birth year estimate of between 1815 and 1820 was derived.

The 1990 "History of Johnson County and Families" [page 289] noted only that:

"John R. NEWBOLD (dead by 1860) married Mary Upchurch".

And:

"John R. NEWBOLD's widow and children stayed in the county near Ozark and Reynoldsburg."

Ozark and Reynoldsburg are small communities in Johnson County Illinois.

The 1860 Federal Census for Johnson County listed Mary NEWBOLD as a head of household. She was listed as being 35 years of age and born in Tennessee. Listed with her were 4 children: Elizabeth age 17; Mary age 10: John O. age 7 [James]; and Kate age 3. Living in households listed 2 before her and 2 after her were households headed by Upchurches, her maiden name. This proximity, plus her name, of course, indicated that this was Mary Upchurch Newbold, and probable widow of John R. NEWBOLD as of the 1860 Census.

No further evidence of Mary Upchurch Newbold was found.

On the 1850 Federal Census, a Timothy NEWBOLDS, age 9 (1841) and born in Illinois, was listed in Williamson County Illinois (county that bordered Johnson to the north) living with the "Seaborn Prichard" family [several Prichard familes living in close proximity].

He was almost certainly not a child of William and Alice NEWBOLD, since Alice was over age 50 at the time.

There were two sons of William and Alice Newbold whose marriage date was not found: John R. Newbold and Thomas Newbold. All of William's other sons were known married in 1842 or later.

The eldest known child of John and Mary Upchurch Newbold was Elizabeth Newbold, who was age 17 (1843) on the 1860 Federal Census in Johnson County in her mother's household.



The eldest known child of Thomas Newbold may have been Margaret, who was age 20 on the 1860 Census in Union County in her father's household. Or it may have been George, who was age 14 (1846) on that same Census. Margaret could have been a second wife.

On the assumption that any Newbold/Newboles/Newbolds individual in the Johnson/Union/Williamson County Illinois area circa 1850 was most likely related to William and Alice Newbold or their descendants, then Timothy was probably the son of one of these two individuals. neither of whom could be found on either the 1850 Federal Census or the 1855 State Census in any of the counties in southern Illinois.

The 1860 Federal Census for Union County Illinois listed Thomas Newbold and his family. Among those listed were 4 children born to Thomas and his unknown wife between 1846 and 1858 in the state of Missouri. This makes it less likely that Timothy was a son of Thomas than a son of John. However, why Timothy was in the Richards household, and where were his parents living, are questions without answers.

In addition, no further record for Timothy Newbolds was found.

As to the four "known" children of John R. and Mary Upchurch Newbold, the following was found:

Elizabeth Newbold. The 1870 and 1880 Federal Cenuses showed additional evidence of Elizabeth NEWBOLD. On the Ancestry.com Web site, a record showed for a "Giles Taylor" born about 1880 in Johnson County Illinois. His parents were listed as Samuel Taylor and Mary Elizabeth NEWBOLDs. Using this information, the 1870 Federal Census for Johnson County for the area covered by the Reynoldsburg Post Office found one Samuel Taylor and wife Elizabeth, both age 23. Living with them was Ann NEWBOLES, age 15. These ages would equate to birth years of about 1847 and 1855, respectively.

To further support them being the children of John R. NEWBOLD, Samuel Taylor and wife "Lizzie" appeared on the 1880 Federal Census in Johnson County Illinois. She was listed as age 33, with parents both born in Kentucky. And yes, Giles Taylor, age 3 months, was also listed as their youngest child. This information does track fairly well with the sparse information from the 1990 Johnson County History, and the record about Giles Taylor listed in the on-line database.

Finally, James Oliver NEWBOLD, who was a son of John R. NEWBOLD, is found living in the household of one William Harper on the 1870 Federal Census in Johnson County in the Reynoldsburg Post Office area. Thus, one finds the one certain child of John R. NEWBOLD in the Reynoldsburg P.O. area as per the 1990 Johnson County History, and one also finds the probable two daughters of John R. NEWBOLD on the 1870 Census in the Reynoldsburg area.

The Ann NEWBOLES listed on the 1870 Federal Census might be "Kate" listed as 3 years old with mother Mary Upchurch NEWBOLD on the 1860 Census. Or it could be another child of John and Mary Newbold not otherwise known. But certainly a relative, to be living with Elizabeth Newbold Taylor in 1870.

Notes for Mary Upchurch:

A Mary NEWBOLD was found listed on the 1860 Federal Census in Johnson County Illinois as a head of household. She was listed 35 years of age and born in Tennessee. Listed with her were 4 children: Elizabeth age 17; Mary age 10; John O. age 7; and Kate age 3. Living in households listed 2 before her and 2 after her were households headed by Upchurches, her maiden name. This proximity, plus her name, of course, would indicate that this was Mary Upchurch who married John R. NEWBOLD in 1842. An assumption was that her husband is deceased for her to be listed as head of the household.

Notes for Elizabeth NEWBOLD:

The 1860 Federal Census for Johnson County [page 41] listed Mary NEWBOLD as a head of household. She is listed as being 35 years of age and born in Tennessee. Listed with her are 4 children: Elizabeth age 17; Mary age 10; John O. age 7; and Kate age 3. Living in households listed 2 before her and 2 after her are households headed by Upchurches, her maiden name. This proximity, plus her name. of course. would indicate that this is Mary Upchurch who married John R. NEWBOLD.

Also supporting this supposition is the listing for a 7 year old "John" O. NEWBOLD. This is almost certainly James Oliver NEWBOLD, who is known to have been born in January 1853 per the 1900 Federal Census.

The 1870 and 1880 Federal Cenuses show additional evidence of Elizabeth NEWBOLD. On the Ancestry.com Web site, a record appears for a "Giles Taylor" born about 1880 in Johnson County Illinois. His parents were listed as Samuel Taylor and Mary Elizabeth NEWBOLDs. And so it happens that on the 1870 Federal Census for Johnson County for the area covered by the Reynoldsburg Post Office is found one Samuel Taylor and wife Elizabeth, both age 23, and living with them one Ann NEWBOLES, age 15. These ages would equate to birth years of about 1847 and 1855, respectively. To help support this being the children of John R. NEWBOLD, Samuel Taylor and wife "Lizzie" appear on the 1880 Federal Census in Johnson County Illinois. She is listed as age 33, with parents both born in Kentucky. And yes, Giles Taylor, age 3 months, is also listed as their youngest child. This information does track fairly well with the sparse information from the 1990 Johnson County History, and the record about Giles Taylor listed in the on-line database.

Notes for Mary J. NEWBOLD:

The Illinois online Statewide Marriage Index listed Mary J. Newboles getting married to William H. Barnwell in Johnson County Illinois on June 3, 1872. She was found with her husband on the 1880 Federal Census in Johnson County Illinois, where she was listed as age 28 with parents born in North Carolina and Tennessee. They had 3 children listed ages 4, 2, and 5 months.

On the 1900 Federal Census in Johnson County Illinois, Mary J Barnwell was found listed with her husband and 3 children: Lula age 17, Nancy J age 15, and Christian age 12. She was listed born in May of 1853, married for 27 years and with a total of 6 children, all alive as of the Census.

On the 1910 Census in Johnson County, Mary J Barnwell and her husband were listed again. She was recorded as age 56. She said her parents were born in "Germany" and "Illinois"!

She repeated the story about her father being from Germany on the 1920 Census! Both she and her husband, "Henry" Barnwell [what the "H" must have stood for] were listed. His occupation was a teamster for a coal hauler. Her age was given as 66.

Mary J. Barnwell was found on the 1930 Census in Johnson County Illinois with her husband in the household of her daughter Lula married to C. F. McCuan. She was listed age 77, and listed her parents born in Germany and Tennessee. Where she got the idea her dad came from Tennessee would be an interesting story to learn.

Found on the Illinois Trails genealogy web site: Census of the Gilead Cemetery had numerous Barnwells, and one of the entries was for "May J Barnwell, wife of W. H. Barnwell. Born 1952 Died 1936". The same listing recorded "W. H. Barnwell, husband of Mary J., Born 1851 Died 1935".

There is a record for a "Louiza A" NEWBOLES getting married to one Lewis Brumley in 1872 in the Illinois Statewide Marriage Index. No further information has been found for them.

4. James Oliver⁷ NEWBOLD (John R.⁶, William⁵, Levi/Levy⁴, John³, Thomas², Thomas¹) was born Jan 1853 in Johnson County Illinois¹⁷, and died 14 Aug 1932 in Johnson County Illinois^{12,13,14}. He married Lucinda Mounce 27 Jan 1874 in Johnson County Illinois^{15,16}. She was born Jun 1856 in Illinois¹⁷, and died 22 Jan 1942 in Johnson County Illinois^{18,19}.

Notes for James Oliver NEWBOLD:

James NEWBOLES, age 16, is found on the 1870 Census living in the household of William Harper.

"O. NEWBOLS" appears on the 1880 Census in Johnson County Illinois. He is a farmer. Listed with him are his wife and two children, a daughter age 5 "L. A.", and a son age 2 "L.".

The 1900 Census records James O NEWBOLD and wife Lucinda living in Johnson County Illinois with their 6 surviving [of 7] children. He is listed as a farmer who owns his land.

On the 1910 Census, "J. O. NEWBOLD", age 57 is listed with his wife "L. M. A.", age 53, and a 20 year old son named "Tyler", a 16 year old daughter named Fanny H., and a 6 year old granddaughter named "Thurma(?)".

On the 1920 Census, there is a "J. B. NEWBOLD", age 66 listed with his wife, "Angelina", age 63. This is almost certainly James Oliver NEWBOLD and wife Lucinda -- Angelina must have been what the "A." stood for on the 1910 Census.

On the 1930 Census for Johnson County Illinois, James O. NEWBOLD appears as a 77 year old, again with wife Angelina. His occupation is listed as "general farmer--operator". A researcher of James Oliver NEWBOLD reports that she has a death certificate for James that notes that his parents were "Jack" NEWBOLD and "Polly Upchurch". Jack is a common alternate name for John, and Polly is also a common alternate name for Mary. The fact that it was Polly "Upchurch" helps to make this connection.

According to Death Register "A" of Johnson County [library] he is buried in Reynoldsburg, and died of "acute diareha".

Notes for Lucinda Mounce:

On the 1900 Federal Census for Johnson County Illinois, it is indicated that Lucinda NEWBOLD had a total of 7 children with James Oliver Newbold, although only 6 were living. It is not known who the deceased child was.

For marriage license for daughter Tina May in 1904, her name was given as "Angalina".

Children of James NEWBOLD and Lucinda Mounce are:

 Joanna[®] NEWBOLD, born Feb 1875 in Johnson County Illinois³⁹; died Aft, Jun 1900. She married George Blunk 15 Sep 1897 in Johnson County Illinios27.

Notes for Joanna NEWBOLL.

Joanna NEWBOLD is listed as the 25 year old daughter of James O. NEWBOLD and wife Lucinda on the 1900 Federal Census in Johnson County Illinois. It listed her as single. However: the Illinois Marriage Index records a marriage of one Joanna NEWBOLD to George Blunk in September of 1897. Are both records correct? Is it possible at all for there to be 2 Joanna NEWBOLDs?

On the 1900 Federal Census for Johnson County Illinois, one of the children of James O NEWBOLD looks to be named "Hosa T.". He is indicated born in November of 1888 in Illinois.

On the 1910 Federal Census for Johnson County, living with J. O NEWBOLD is 20 year old "Tyler" NEWBOLD. This would appear to be the same individual as "Hosa T." from the 1900 Census. He did not have an occupation indicated [his father is a farmer].

No further evidence of this individual has been found.

> Notes for Fanny H. NEWBOLD: Mable M. Dalton TUNNEL HILL -- Mable M. Dalton, 89, died at 1:50 p.m. Monday, Dec. 10, 2001, at the home of her daughter near Vienna. Mable was born on Aug. 5, 1912, in the Reynoldsburg Community in Johnson County. She was the daughter of Walter Sr. and Fannie (Newbold) Cook.

> Above shows that Fannie Newbold was married to one Walter Cook. And that they were married prior to 1912.

Found on 1920 Census with 3 kids.

Found on 1930 Census with 7 kids. Age at marriage 19, which would translate to about 1911.

 William Alonzo⁸ NEWBOLDS (James Oliver⁷ NEWBOLD, John R.⁶, William⁵, Levi/Levy⁴, John⁵, Thomas², Thomas¹) was born 04 May 1882 in Johnson County Illinois^{23,24}, and died Aft. Dec 1931²⁵. He married Lola Jane Johns 25 Feb 1906 in Johnson County Illinois^{26,27}. She was born 18 Feb 1888 in Williamson County Illinois^{26,29}, and died 20 Dec 1931 in Union County Illinois^{30,37}.

Notes for William Alonzo NEWBOLDS:

Willie L. NEWBOLD is found living with his parents, James Oliver and Lucinda NEWBOLD, on the 1900 Federal Census in Johnson County Illinois. He is listed born in May of 1884, with an occupation of "day laborer".

A note in a local Johnson County newspaper [Vienna Times] had this item on Thursday Mar 8 1909:

"We overlooked a wedding last week that occured in our town Feb 25, (1909) at the residence and by Esq. J. R. Deaton, Mr. Willis Newbold and Miss Lola Johns. The Groom is the son of J. O. Newbolds, east of town, the bride, the dau of Isaac Johns of Williamson County."

The 1910 Federal Census for Johnson County Illinois listed William NEWBOLD's occupation as an "odd jobs laborer". Listed with him are his wife Lola and 1 year old son, Howard.

A September 1918 WW I draft registration card for one "Will Alonzo NEWBOLDS" shows him born on May 4 1882. His next of kin is wife "Lola Jane NEWBOLDS". His occupation is "miner". Where his signature is required, the words "his mark" is listed, along with a signature. Perhaps he could not write? The card described him as being of "medium" height and build, with blue eyes and black hair.

William "NEWBOLT" and wife "Lola" are found on the 1920 Federal Census in nearby Williamson County Illinois. He is listed as age 38. Living with them are 4 children: Howard, age 11; Hershey, age 8; "Tina?", age 6; and "Margie?", age 1. His occupation is listed as "farm laborer".

William "NEWBOLT" is next listed on the 1930 Federal Census for Johnson County again. Listed this time are his wife Lola, and William O, a 22 year old son; Arthur L., age 16; Joyce A., 11 year old daughter; Herbert E., an 8 year old son; Issac R., a 6 year old son; and finally Robie L., a 3 year 1 month aged son. He and his two older sons are listed as "farm laborers".

It is difficult to reconcile the children listed on the Censuses of 1910, 1920 and 1930. In particular, who are William O. NEWBOLD and Arthur L. NEWBOLD? William O. is older than Howard, and in fact, is old enough to have been born before William L. NEWBOLD married Lola Johns in 1909 [his age would make him born in about 1908]. As well, Arthur L. NEWBOLD did not appear listed on the 1920 Census, although he would have been born about 1914. Just an oversight at the time of Census taking? Possible.

Andrea Newbolds, who has studied this particular NEWBOLD line, stated that "Will disappeared after her [wife Lola] death in 1931 and the children remained with James Oliver until after his death in 1932."

She also stated that William L. NEWBOLD and wife Lola had "6 or 7 children".

 John R.⁶ NEWBOLD (William⁵, Levi/Levy⁴, John³, Thomas², Thomas¹) was born Bet. 1815 - 1820 in Onslow County North Carolina, and died Bef. 1860 in Illinois¹. He married Mary Upchurch 13 Aug 1842 in Johnson County Illinios². She was born Abt. 1825 in Tennessee³, and died Aft. Jul 1860⁴.

Notes for John R. NEWBOLD:

A researcher of James Oliver NEWBOLD born in 1853 reported that she has a death certificate for James that noted his parents were "Jack" NEWBOLD and "Polly Upchurch". Jack is a common alternate name for John, and Polly is also a common alternate name for Mary. Mary Upchurch married John R. Newbold in 1842. John R. Newbold and Mary Upchurch were almost certainly "Jack" and "Polly" Newbold parents of James Oliver Newbold.

Other than the record of John getting married to Mary Upchurch in 1842, there was virtually no other mention of this individual found in the record. He was not found on the 1850 Federal Census nor on the 1855 Illinois State Census.

He was probably the male listed in the age 20 to 30 column in his father William Newbold's household on the 1840 Census in Johnson County Illinois, and the male in the 10 to 15 column in William Newbold's household on the 1830 Census in Onslow County Illinois. It was from these assumptions that his birth year estimate of between 1815 and 1820 was derived.

The 1990 "History of Johnson County and Families" [page 289] noted only that:

"John R. NEWBOLD (dead by 1860) married Mary Upchurch".

And:

"John R. NEWBOLD's widow and children stayed in the county near Ozark and Reynoldsburg."

Ozark and Reynoldsburg are small communities in Johnson County Illinois.

The 1860 Federal Census for Johnson County listed Mary NEWBOLD as a head of household. She was listed as being 35 years of age and born in Tennessee. Listed with her were 4 children: Elizabeth age 17; Mary age 10: John O. age 7 [James]; and Kate age 3. Living in households listed 2 before her and 2 after her were households headed by Upchurches, her maiden name. This proximity, plus her name, of course, indicated that this was Mary Upchurch Newbold, and probable widow of John R. NEWBOLD as of the 1860 Census.

No further evidence of Mary Upchurch Newbold was found.

On the 1850 Federal Census, a Timothy NEWBOLDS, age 9 (1841) and born in Illinois, was listed in Williamson County Illinois (county that bordered Johnson to the north) living with the "Seaborn Prichard" family [several Prichard familes living in close proximity].

He was almost certainly not a child of William and Alice NEWBOLD, since Alice was over age 50 at the time.

There were two sons of William and Alice Newbold whose marriage date was not found: John R. Newbold and Thomas Newbold. All of William's other sons were known married in 1842 or later.

The eldest known child of John and Mary Upchurch Newbold was Elizabeth Newbold, who was age 17 (1843) on the 1860 Federal Census in Johnson County in her mother's household.



The eldest known child of Thomas Newbold may have been Margaret, who was age 20 on the 1860 Census in Union County in her father's household. Or it may have been George, who was age 14 (1846) on that same Census. Margaret could have been a second wife.

On the assumption that any Newbold/Newboles/Newbolds individual in the Johnson/Union/Williamson County Illinois area circa 1850 was most likely related to William and Alice Newbold or their descendants, then Timothy was probably the son of one of these two individuals. neither of whom could be found on either the 1850 Federal Census or the 1855 State Census in any of the counties in southern Illinois.

The 1860 Federal Census for Union County Illinois listed Thomas Newbold and his family. Among those listed were 4 children born to Thomas and his unknown wife between 1846 and 1858 in the state of Missouri. This makes it less likely that Timothy was a son of Thomas than a son of John. However, why Timothy was in the Richards household, and where were his parents living, are questions without answers.

In addition, no further record for Timothy Newbolds was found.

As to the four "known" children of John R. and Mary Upchurch Newbold, the following was found:

Elizabeth Newbold. The 1870 and 1880 Federal Cenuses showed additional evidence of Elizabeth NEWBOLD. On the Ancestry.com Web site, a record showed for a "Giles Taylor" born about 1880 in Johnson County Illinois. His parents were listed as Samuel Taylor and Mary Elizabeth NEWBOLDs. Using this information, the 1870 Federal Census for Johnson County for the area covered by the Reynoldsburg Post Office found one Samuel Taylor and wife Elizabeth, both age 23. Living with them was Ann NEWBOLES, age 15. These ages would equate to birth years of about 1847 and 1855, respectively.

To further support them being the children of John R. NEWBOLD, Samuel Taylor and wife "Lizzie" appeared on the 1880 Federal Census in Johnson County Illinois. This information does track fairly well with the sparse information from the 1990 Johnson County History, and the record about Giles Taylor listed in the on-line database.

Finally, James Oliver NEWBOLD, who was a son of John R. NEWBOLD, is found living in the household of one William Harper on the 1870 Federal Census in Johnson County in the Reynoldsburg Post Office area. Thus, one finds the one certain child of John R. NEWBOLD in the Reynoldsburg P.O. area as per the 1990 Johnson County History, and one also finds the probable two daughters of John R. NEWBOLD on the 1870 Census in the Reynoldsburg area.

The Ann NEWBOLES listed on the 1870 Federal Census might be "Kate" listed as 3 years old with mother Mary Upchurch NEWBOLD on the 1860 Census. Or it could be another child of John and Mary Newbold not otherwise known. But certainly a relative, to be living with Elizabeth Newbold Taylor in 1870.

She was found with her husband on the 1880 Federal Census in Johnson County Illinois, where she was listed as age 28 with parents born in North Carolina and Tennessee. They had 3 children listed ages 4, 2, and 5 months.

On the 1900 Federal Census in Johnson County Illinois, Mary J Barnwell was found listed with her husband and 3 children: Lula age 17, Nancy J age 15, and Christian age 12. She was listed born in May of 1853, married for 27 years and with a total of 6 children, all alive as of the Census.

On the 1910 Census in Johnson County, Mary J Barnwell and her husband were listed again. She was recorded as age 56. She said her parents were born in "Germany" and "Illinois"!

She repeated the story about her father being from Germany on the 1920 Census! Both she and her husband, "Henry" Barnwell [what the "H" must have stood for] were listed. His occupation was a teamster for a coal hauler. Her age was given as 66.

Mary J. Barnwell was found on the 1930 Census in Johnson County Illinois with her husband in the household of her daughter Lula married to C. F. McCuan. She was listed age 77, and listed her parents born in Germany and Tennessee. Where she got the idea her dad came from Tennessee would be an interesting story to learn.

Found on the Illinois Trails genealogy web site: Census of the Gilead Cemetery had numerous Barnwells, and one of the entries was for "May J Barnwell, wife of W. H. Barnwell. Born 1952 Died 1936". The same listing recorded "W. H. Barnwell, husband of Mary J., Born 1851 Died 1935".

Notes for John R. NEWBOLD:

A researcher of James Oliver NEWBOLD born in 1853 reported that she has a death certificate for James that noted his parents were "Jack" NEWBOLD and "Polly Upchurch". Jack is a common alternate name for John, and Polly is also a common alternate name for Mary. Mary Upchurch married John R. Newbold in 1842. John R. Newbold and Mary Upchurch were almost certainly "Jack" and "Polly" Newbold parents of James Oliver Newbold.

Other than the record of John getting married to Mary Upchurch in 1842, there was virtually no other mention of this individual found in the record. He was not found on the 1850 Federal Census nor on the 1855 Illinois State Census.

He was probably the male listed in the age 20 to 30 column in his father William Newbold's household on the 1840 Census in Johnson County Illinois, and the male in the 10 to 15 column in William Newbold's household on the 1830 Census in Onslow County Illinois. It was from these assumptions that his birth year estimate of between 1815 and 1820 was derived.

The 1990 "History of Johnson County and Families" [page 289] noted only that:

"John R. NEWBOLD (dead by 1860) married Mary Upchurch".

And:

"John R. NEWBOLD's widow and children stayed in the county near Ozark and Reynoldsburg."

Ozark and Reynoldsburg are small communities in Johnson County Illinois.

The 1860 Federal Census for Johnson County listed Mary NEWBOLD as a head of household. She was listed as being 35 years of age and born in Tennessee. Listed with her were 4 children: Elizabeth age 17; Mary age 10: John O. age 7 [James]; and Kate age 3. Living in households listed 2 before her and 2 after her were households headed by Upchurches, her maiden name. This proximity, plus her name, of course, indicated that this was Mary Upchurch Newbold, and probable widow of John R. NEWBOLD as of the 1860 Census.

No further evidence of Mary Upchurch Newbold was found.

On the 1850 Federal Census, a Timothy NEWBOLDS, age 9 (1841) and born in Illinois, was listed in Williamson County Illinois (county that bordered Johnson to the north) living with the "Seaborn Prichard" family [several Prichard familes living in close proximity].

He was almost certainly not a child of William and Alice NEWBOLD, since Alice was over age 50 at the time.

There were two sons of William and Alice Newbold whose marriage date was not found: John R. Newbold and Thomas Newbold. All of William's other sons were known married in 1842 or later.

The eldest known child of John and Mary Upchurch Newbold was Elizabeth Newbold, who was age 17 (1843) on the 1860 Federal Census in Johnson County in her mother's household.



The eldest known child of Thomas Newbold may have been Margaret, who was age 20 on the 1860 Census in Union County in her father's household. Or it may have been George, who was age 14 (1846) on that same Census. Margaret could have been a second wife.

On the assumption that any Newbold/Newboles/Newbolds individual in the Johnson/Union/Williamson County Illinois area circa 1850 was most likely related to William and Alice Newbold or their descendants, then Timothy was probably the son of one of these two individuals. neither of whom could be found on either the 1850 Federal Census or the 1855 State Census in any of the counties in southern Illinois.

The 1860 Federal Census for Union County Illinois listed Thomas Newbold and his family. Among those listed were 4 children born to Thomas and his unknown wife between 1846 and 1858 in the state of Missouri. This makes it less likely that Timothy was a son of Thomas than a son of John. However, why Timothy was in the Richards household, and where were his parents living, are questions without answers.

In addition, no further record for Timothy Newbolds was found.

As to the four "known" children of John R. and Mary Upchurch Newbold, the following was found:

Elizabeth Newbold. The 1870 and 1880 Federal Cenuses showed additional evidence of Elizabeth NEWBOLD. Notes for James Oliver NEWBOLD:

James NEWBOLES, age 16, is found on the 1870 Census living in the household of William Harper.

"O. NEWBOLS" appears on the 1880 Census in Johnson County Illinois. He is a farmer. Listed with him are his wife and two children, a daughter age 5 "L. A.", and a son age 2 "L.".

The 1900 Census records James O NEWBOLD and wife Lucinda living in Johnson County Illinois with their 6 surviving [of 7] children. He is listed as a farmer who owns his land.

On the 1910 Census, "J. O. NEWBOLD", age 57 is listed with his wife "L. M. A.", age 53, and a 20 year old son named "Tyler", a 16 year old daughter named Fanny H., and a 6 year old granddaughter named "Thurma(?)".

On the 1920 Census, there is a "J. B. NEWBOLD", age 66 listed with his wife, "Angelina", age 63. This is almost certainly James Oliver NEWBOLD and wife Lucinda -- Angelina must have been what the "A." stood for on the 1910 Census.

On the 1930 Census for Johnson County Illinois, James O. NEWBOLD appears as a 77 year old, again with wife Angelina. His occupation is listed as "general farmer--operator".

A researcher of James Oliver NEWBOLD reports that she has a death certificate for James that notes that his parents were "Jack" NEWBOLD and "Polly Upchurch". Jack is a common alternate name for John, and Polly is also a common alternate name for Mary. The fact that it was Polly "Upchurch" helps to make this connection.

According to Death Register "A" of Johnson County [library] he is buried in Reynoldsburg, and died of "acute diareha".

Notes for Lucinda Mounce:

On the 1900 Federal Census for Johnson County Illinois, it is indicated that Lucinda NEWBOLD had a total of 7 children with James Oliver Newbold, although only 6 were living. It is not known who the deceased child was.

For marriage license for daughter Tina May in 1904, her name was given as "Angalina".

Notes for William Alonzo NEWBOLDS:

Willie L. NEWBOLD is found living with his parents, James Oliver and Lucinda NEWBOLD, on the 1900 Federal Census in Johnson County Illinois. He is listed born in May of 1884, with an occupation of "day laborer".

A note in a local Johnson County newspaper [Vienna Times] had this item on Thursday Mar 8 1909:

"We overlooked a wedding last week that occured in our town Feb 25, (1909) at the residence and by Esq. J. R. Deaton, Mr. Willis Newbold and Miss Lola Johns. The Groom is the son of J. O. Newbolds, east of town, the bride, the dau of Isaac Johns of Williamson County."

The 1910 Federal Census for Johnson County Illinois listed William NEWBOLD's occupation as an "odd jobs laborer". Listed with him are his wife Lola and 1 year old son, Howard.

A September 1918 WW I draft registration card for one "Will Alonzo NEWBOLDS" shows him born on May 4 1882. His next of kin is wife "Lola Jane NEWBOLDS". His occupation is "miner". Where his signature is required, the words "his mark" is listed, along with a signature. Perhaps he could not write? The card described him as being of "medium" height and build, with blue eyes and black hair.

William "NEWBOLT" and wife "Lola" are found on the 1920 Federal Census in nearby Williamson County Illinois. He is listed as age 38. Living with them are 4 children: Howard, age 11; Hershey, age 8; "Tina?", age 6; and "Margie?", age 1. His occupation is listed as "farm laborer".

William "NEWBOLT" is next listed on the 1930 Federal Census for Johnson County again. Listed this time are his wife Lola, and William O, a 22 year old son; Arthur L., age 16; Joyce A., 11 year old daughter; Herbert E., an 8 year old son; Issac R., a 6 year old son; and finally Robie L., a 3 year 1 month aged son. He and his two older sons are listed as "farm laborers".

It is difficult to reconcile the children listed on the Censuses of 1910, 1920 and 1930. In particular, who are William O. NEWBOLD and Arthur L. NEWBOLD? William O. is older than Howard, and in fact, is old enough to have been born before William L. NEWBOLD married Lola Johns in 1909 [his age would make him born in about 1908]. As well, Arthur L. NEWBOLD did not appear listed on the 1920 Census, although he would have been born about 1914. Just an oversight at the time of Census taking? Possible.

Andrea Newbolds, who has studied this particular NEWBOLD line, stated that "Will disappeared after her [wife Lola] death in 1931 and the children remained with James Oliver until after his death in 1932."

She also stated that William L. NEWBOLD and wife Lola had "6 or 7 children".

In the 1830 census the young male shown could be Harrison, who is mentioned in William's will, and the two females could have been Mary (Polly) and Elizabeth, also shown in William's will. Since both Mary and Elizabeth were married in 1842, Whichever female was the youngest, would have been between 17 to 22 when she married. The other daughter would have married at an age between 27 and 32.

If one wished to speculate, Mary could have married John Newbold who was older than his brother William. Therefore she might have been the older daughter. I'm hopeful John Newbold and Mary can be tracked down. I already have been told by a descendent of John and Mary's that one of John and Mary Newbold's daughters (Mary Elizabeth) married a Samuel Taylor. It is stated she (Mary Elizabeth Newbold) was born in 1841, which is most unlikely since Mary Upchurch and John Newbold didn't marry until 1842.

If the younger sister was Elizabeth (born about 1820 - 1825) she would have been between 17 and 22 years old when she married William Newbold. Elizabeth Upchurch Newbold and William Newbold's oldest son, Elisha, is shown on the 1860 census as 16. This means he was born @1844. On the 1860 census it states Elizabeth's age to be 20, which is obviously incorrect. She may have been married at age 20, but that wasn't her age at the time of the census. If she were between 5 and 10 on the 1830 census, she would have been 35-40 years of age at the time of the 1860 census, and 19 - 24 years old when Elisha was born. And William Newbold's age! Did he marry an older woman who fudged her age so it would not be an embarrassment to her younger husband?
